Statement of Work

Department of Veterans Affairs

Furniture for Michael E. DeBakey VA Medical Center

I. Introduction

The Michael E. DeBakey VA Medical Center in Houston is seeking desk furniture for administrative offices for the CardioThoracic Surgery Section in Bldg. 100, Rm. 5B-170D. All furniture must be safe in design for staff use, constructed of high quality and environmentally friendly materials.

II. Information:

The new furniture will be used in the CardioThoracic office, 5B-170D, that functions as staff work space, teaching space, conference space and patient interview space. The design and finish of the furniture shall meet infectious control measures and The Joint Commission (TJC) standards. Furniture requested shall meet ergonomic standards and guidelines for the Americans with Disabilities Act (ADA).

III. Product Specifications and Quantities:

VENDOR: Herman Miller (Herman Miller product is needed in order to re-use existing electric connection whips in the project room. These are manufacturer specific. In addition, Herman Miller parts and pieces are in use throughout the facility and can be repaired, modified and reconfigured more efficiently with interchangeable parts and pieces.)

PRODUCT: Straight work surfaces to create “L” work stations and straight work surfaces, wall mounted for staff work areas.

Storage units: Storage Cabinets with double doors, 64”H, 36” Wide,

FINISH: Sand with sand laminate

Desk units will also include tack board, BBF and/or FF mobile storage pedestals with pencil drawer, and lockable overheads.

SEATING: Aeron, ergonomic work chairs

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans or eligible surviving spouses (see VAAR 802.201 Surviving Spouse definition);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB as appropriate.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

- (1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and
