B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes FAR 52.219-6 Notice of Total Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor's compliance with the limitations on subcontracting or percentage of work performance requirement.

B.3 PERFORMANCE WORK STATEMENT

STATEMENT OF WORK

Security Officer

GENERAL REQUIREMENTS & SPECIFICATIONS

The Contractor shall furnish all supervision, labor, equipment, transportation, insurance, supplies and materials necessary and incident to the provision of Uniformed/Unarmed Mobile Security Guard Services to Cumberland County Health Care Center, 7300 S. Raeford Rd, Fayetteville, NC. One security personnel shall be utilized from 2000-0600 (8pm to 6am) Monday thru Friday, and 24 hours a day on weekends and holidays by personnel that have had 2 years of Civilian or Military law enforcement or security experience from working in industrial or commercial guard/ security field.

CONTRACT MANAGEMENT

The Contractor shall manage the total work effort associated with the guard services required herein to assure fully adequate and timely completion of these services. Included in this function will be a full range of management duties including, but not limited to, planning, scheduling, report preparation, establishing and maintaining records, and quality control. The Contractor shall provide an adequate, qualified staff of guard personnel with the necessary management expertise to assure the performance of the work in accordance with sound and efficient management practices.

UNIFORMED / UNARMED MOBILE SECURITY GUARD SERVICES

The Contractor shall provide 1 unarmed uniformed security guard. All security guard personnel assigned to this contract shall be fully uniformed including photo identification tags. Contract Security Services include, but are not limited to the following:

- Entrance Control – Operate and enforce a system of personal.
- Traffic Control – Direct traffic (vehicle and pedestrian), control parking and notify the Fayetteville PD and VA Leadership of any infractions.
- Roving Patrol – Conducts patrols in accordance with established routes and schedules when directed to do so by authorized persons.
- Rules/Regulations – Observe building occupants and visitors for compliance with posted regulations.
- Unauthorized Access – identify anyone attempting to gain unauthorized access to the grounds or buildings of the HCC, notify Local PD, Clinic Leadership and then the VA Police.

- Hazardous Conditions – Report daily, or more often if required, in accordance with procedures found in the standard operating procedures, potential or real hazardous conditions and items in poor repair to include inoperative lighting, uneven or broken or slippery surfaces, vehicle accidents, persons needing assistance in the parking lot, etc.
- Reports/Records – Prepare all required reports in a timely manner and provide the reports to the HCC Leadership.
- Civil Disturbances – Maintain vigilance and immediately contact the Fayetteville PD for instances of civil disorder, attempts of sabotage, espionage, or other criminal acts adversely affecting the security and or safety of the Government, its employees, property and general public lawfully in buildings or on the grounds under control of the Department of Veterans Affairs. After contact with Local PD an attempt should be made to contact the VA Police to report the incident (910) 822-7922.
- Personnel shall physically inspect the exterior of all buildings to ensure no forced entry or vandalism has occurred and reports any security violations discovered to the appropriate authorities.
- Perform routine checks of properties utilizing the following schedule:

During all shifts the Officer is required to conduct at least three physical checks of the ground floor interior of the building. Two checks of the parking lot and all entrance/exit access points. Officer may be responsible to unlock entrances to the facility and working areas. Keep daily journal of all activity.

Position Description: Security guard shall have a sufficient history with the Contractor to have demonstrated the ability to meet and deal successfully with the public; the ability and capability to read, understand, and properly apply printed rules, detailed orders, instructions, and training materials; the ability to maintain poise and self-control in stressful situations; the ability to conduct and write clear, concise, accurate and detailed reports. Sufficient history with Contractor is considered as not less than six (6) months progressive responsibility, or three (3) months with a history of military service and documented security guard/dispatching training. Coverage must be maintained every day, including Federal Holidays. Duty hours must be 2000-0600 Monday thru Friday, and 24 hours a day on weekends and holidays.

Requirements: Security personnel furnished under this contract shall pass a background check to include criminal history, past employment and drug screening. As a minimum, all contract personnel providing services at the HCC shall meet the following employment requirements:

- Complete background investigation documentation, including a 10 year employment history.
- Be 21 years of age or older.
- Police record check – Verify that the Contractor employee has no record of a felony, or a misdemeanor involving the moral turpitude.

- Personal reference (minimum of three persons not related to subject).
- Complete and submit a physical examination report performed by a board qualified physician without cost to the Government or employee. Contractor employee must be in good health and physically able to perform all general patrol duties, functions and activities as needed or required by the contract; shall possess binocular vision correctable to 20/30; shall not be color blind; be capable of hearing ordinary conversation at a distance of approximately fifteen (15) feet with either ear and without benefit of a hearing aid.
- Complete and submit an acceptable psychological assessment without cost to the Government or the employee. This psychological assessment must be carried out in accordance with accepted professional standards by a physician or licensed practitioner authorized to conduct such examinations. For detailed policy see the Federal Personnel Manual, Chapter 339 Medical Qualification Determinations. security guard duties include personal encounters with patients, visitors and other employees. Encounters are often with mentally ill, irrational or disturbed persons who although assaultive or destructive, must be handled with understanding, full control of force and unimpeded judgment. Any emotional or mental condition which could cause the applicant to be a hazard to others or self during stressful situations and physical altercations will disqualify him/her from performance from work on this contract.
- Complete and resubmit annual physicals and psychological assessments and provide results to the Contracting Officer or COR.
- Communicate effectively both verbally and written to the extent of reading and fully understanding printed regulations, detailed written orders, training instructions and materials, and shall be capable of composing reports. In addition, they must be able to verbally communicate in such a manner as to be easily understood and be physically able to perform duties associated with verbal communications and customer service; ability to enter data utilizing a computer keyboard; and to utilize a telephone.
- Complete an initial drug testing procedure. Screening shall be current within thirty (30) days preceding work start date under the contract. The Contracting Officer may request the Contractor to perform an interim screening of his/her personnel during the contract period

WORK HOURS

Security Services covered by this contract shall be furnished by the Contractor as specified herein. Services are required Monday thru Friday five (5) days per week from 8:00PM – 6:00AM, and 24 hours on weekends and National Holidays. The Fayetteville VA Medical Center reserves the right to change this requirement to fit the need of clinic operations.

The following terms have the following meanings:

National Holiday: All work required under this contract shall be performed as provided in the Security & Patrol Services Schedule. Deviations from the work schedule shall

require prior written permission from the COTR. The following is a list of the *Federal holidays:

- New Year's Day
- Washington's Birthday
- Martin Luther King's Birthday
- Memorial Day
- Independence Day
- Labor Day
- Columbus Day
- Veterans Day
- Thanksgiving Day
- Christmas

*Or any other day specifically declared by the President of the United States to be a national holiday.

Contractor will facilitate the majority of the meal and rest breaks. VA Police will provide additional breaks as they arise.

Meals will not be consumed on post.

Once the individual is on duty, the individual may not be permitted to leave their post until properly relieved by another contractor or VA Police Officer.

PERSONNEL POLICY

The Contractor shall be responsible for protecting the personnel furnishing services under this contract. To carry out this responsibility, the Contractor shall provide the following for these personnel:

- Workers Compensation
- Liability Insurance
- Health Examinations
- Income Tax Withholding, and
- Social Security Payments

It is agreed and understood that the Contractor, its employees, agents and sub-contractors shall not be considered VA employees for any purpose. The Contractor is responsible for payment of any leave, including sick leave, holiday or vacation time, for itself, employees, agents and sub-contractors.

CONTRACTOR FURNISHED PROPERTY AND SUPPLIES

The Contractor shall furnish and maintain in acceptable condition, all items of uniform and equipment necessary to perform work required by this contact, as discussed in this paragraph.

Uniforms:

Appropriately lettered breast badges, indicating the employee is a security guard, shall be worn as part of the uniform. Shoulder patches lettered to indicate the identity of the contractor shall be worn on the left shoulder of the uniform blazer, jacket and shirt. Identification nametags and PIV identification shall be worn over the right breast jacket, blazer and shirt pocket. No other identification of the contractor or employee shall be worn or displayed on the uniform.

Approved uniforms and related accessories, listed below, do not have to be new but must be in good condition:

A. Shirt, long sleeve

B. Shirt, short sleeve

C. Trouser, all season weight

D. Necktie (to be worn with long sleeve shirt or short sleeve shirt, when worn with blazer)

E. Jacket, winter, heavyweight artic field coat

F. Jacket, lightweight

G. Blazer

H. Gloves, (pair), (color to match accessories)

I. Flashlight, 2 "Lithium photocell", size 123, "Surefire"

J. Flashlight holder, secured to trouser belt.

K. Radio case

L. Insignia, shoulder patch (each shirt and jacket)

M. Nameplate, 3 1/2" x 3/4", black 1/2" lettering on silver metal (brushed or stainless)

The long and short sleeve shirts will be required at the contractor's discretion.

The uniform shall only be worn when the officer is on official duty or when the officer is in transit

between his/her place of residence and duty station.

Shoes shall be low quarter or high topped lace type with police or plain toe and standard heel. The color of the shoe shall match the color of leather equipment accessories. Any deviation from the above requirements must be approved by the Point of Contact and the Chief of Police Services.

The color of uniform accessories and equipment shall be standard black and brown, as may be appropriate to match the uniform.

Inclement weather clothing shall be required for all guards required to perform duties while exposed to cold, rain, and other inclement weather conditions. All inclement weather clothing must be identical in style and color for each guard.

****NOTE:** No guard may enter on duty without wearing the proper uniform (including PIV card/badge).

Contractor's guards shall NOT be permitted to provide themselves with any unauthorized supplemental or personals, such as either concealed firearms, knives, or such other non-standard items, considered as illegal or unauthorized on Department of Veterans Affairs property.

All security contractors will be required to attend a facility orientation program on safety and emergency procedures. This training will be scheduled at the kick off meeting at a mutually agreeable date. VA specific training and orientation must be completed by each employee after award and prior to commencement of any work. All post furniture will be provided by the Department of Veterans Affairs. All communication equipment will be provided to each post.

CONTRACTOR RESPONSIBILITIES:

The CONTRACTOR shall ensure that continuous coverage is maintained during shift changes. Under no circumstances, will there be a total absence of service personnel during the hours covered by this CONTRACT.

Reserve Personnel (Back-up Staff): Prior to commencement of work on this Contract, the Contractor is required to submit to the Point of Contact, the names and all necessary documentation of at least (four) fully trained and qualified personnel who will be used in a reserve capacity (e.g. to replace guards on scheduled or non-scheduled sick leave or vacation, to respond to emergency service, or similar situations), for approval via email or fax to the Point of Contact.

Recall System: The Contractor shall provide an employee recall system with the capability of contracting and recalling off duty personnel up to two per shift. Personnel shall be on-site within (1) hour of the Contractor's receipt of the Point of Contact recall authorization. Situations which may

result in recalls include riots, civil disturbances, or other large gatherings of people where, in the opinion of the Government, a threat exists to life and property, and active shooter. The Point of Contact will notify the contractor for additional personnel as required.

POST ORDERS:

Within fifteen (15) Days of the Effective Date, Contractor shall deliver to the Point of Contact drafted comprehensive Post Orders for **all designated Sites** for review and approval. The Point of Contact shall review and return same to Contractor with instructions for revisions.

Post Orders shall include, but are not limited to:

- A. General Safety Procedures
- B. Emergency Procedures (including contact lists)
- C. Incident and Emergency Report Procedures and Forms
- D. Shift Patrol Procedures
- E. Communication Procedures
- F. Dress and Grooming Standards
- G. Training Procedures including harassment training
- H. Photographs and diagrams of each Site.
- I. Human Resources Policies and Hiring and Disciplinary Procedures

REPRESENTATIVES OF THE CONTRACTING OFFICER

The Contracting Officer reserves the right to designate representatives to act for him/her in furnishing technical guidance and advice or generally supervises the work to be performed under this contract. Such designation will be in writing and will define the scope and limitations of the designee's authority. A copy of the designation(s) shall be furnished to the Contractor at time of award.

The VA Contracting Officer will delegate one (or more) representatives to serve as the COTR. The COTR may direct and arrange the Contractor's work schedule in specific areas of the cemetery to

coordinate with daily cemetery activities and operations. Duties and responsibilities of the COTR include, but are not limited to, the following:

- Provides contract oversight and technical guidance to the Contractor.
- Acts as technical liaison between the HCC and the Contractor.
- Placing orders for services.
- Determining whether contract deliverables meet functional, technical and performance specifications.
- Verification / certification of payments to the Contractor for services rendered.
- Assuring that any changes effecting work involved, price, terms and/or conditions under the contract are not implemented before written authorization is issued by the Contracting Officer.

(End of Work Statement)

B.3 PRICE/COST SCHEDULE

The Contractor shall furnish all personnel, equipment, supervision, and supplies necessary to provide unarmed security guard services for Fayetteville Health Care Center (HCC) for the Base Year with four (4) twelve (12) month options to extend the term of the contract. The total contract will not exceed five (5) years in accordance with the terms and conditions herein.
