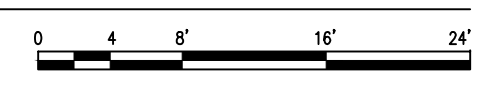

1. EXISTING FLOOR DRAINS.

4. EXISTING STORM (ST) RISE DOWN TO LEVEL B AND UP TO LEVEL D.
5. EXISTING DOMESTIC WATER PIPING AND FROST PROOF HOSE BIBBS TO REMAIN.
6. FLOOR DRAIN LOCATIONS.
7. FLOOR DRAINS AT PARKING LEVEL DD ABOVE. REFER TO DRAWING P-103.
8. SANITARY (SS) AND STORM (ST) PIPING SYSTEM CLEAN OUTS WILL BE LOCATED EITHER AT HORIZONTAL LENGTHS OR VERTICAL STACKS. REFER TO DRAWING P-201 FOR PIPING ISOMETRICS.
