This solicitation includes . Accordingly, any contract resulting from this solicitation will include this clause. Performance Work Statement

1. The Urology Endoscopy System is needed to support our procedure case load volume. This system will be processed in SPS through the V-Pro Max processor to ensure daily volume goals for these procedures.
2. Requirements: Model TH 111 camera heads being requested require the purchase of the Image1S X-link camera processor system. Resolution 1920 x 1080 pixels with Scanning method progressive scan and Lens fixed focus pendulum system, fixed focus. This camera processing system needs to be compatible with the OR's ureteroscopes and the new ones requested, as well as the flexible cystoscopes that are presently in inventory and the rigid cystoscopy sets currently in inventory.
3. Define requirements: The Video System processor requested must be compatible and adaptable with the current camera processor currently being used in both Urology Clinic and OR Suites.

Easy to use: The angle of deflection, reverse deflection capability and the position of the working lumen relationship to the lens that provides the visual field. The lumen needs to be offset at the 1 to 2 o'clock position for optimal viewing for procedures requiring cannulation of the ureteral orifice.

Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as

those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—
