APPENDIX 1: Purpose and Objectives

The DVA plans to request complete construction services to perform work for Project No. 459-305 "Expansion of Building 32 Parking Structure" at VA Pacific Islands Health Care System (VAPIHCS), 459 Patterson Road, Honolulu, HI 96819-1522.

CONSTRUCTION SCOPE OF WORK:

(This is a *planned* set-a-side for Service-Disabled Veteran-Owned Small-Businesses (SDVOSB) or Veteran-Owned-Small-Businesses (VOSB))

The Contractor shall provide complete construction services to include labor, materials, equipment and supervision to correct the deficiencies as outlined in the J. Uno & Associates plans and specifications for Project Number 459-305 "Expansion of Building 32 Parking Structure". The drawings and specification should be the basis of bid-ability and construction, along with the other provisions listed herein. Magnitude (*including options*) is \$5M-\$10M.

- A. Contractor shall completely prepare site for building operations, including demolition/removal/upgrade of existing structures, construct additional fifth floor level parking and furnish labor and materials and perform work for extending and modifying the existing Parking Structure and surrounding areas. This work includes, but is not limited to site work, grading, landscaping, new bumpers and electrical power receptacles, asphalt and concrete repairs and additions, retrofit existing elevator, and painting as required by drawings and specifications.
- B. Contractor will complete all work in accordance with design drawings titled TAMC EXPANDING BUILDING 32 PARKING STRUCTURE dated MAR 07, 2016 and specifications titled VA EXPAND PARKING STRUCTURE dated MAR 07, 2016.
- C. Work areas. This project site shall be located at the building 32 parking structure per contract plans at Tripler Army Medical Center.
- D. The work includes, but is not limited to, general construction, alterations, grading, drainage, electrical work, utility systems, and necessary removal of existing structures, pavement and landscaping and new construction.
- E. Contractor shall survey areas prior to contract task order award and start of work.
- F. A separate bid option will include painting of the exterior of the entire building that was not included in the drawings. Specification and color will match the specification documents identified in the ae to match existing exterior finish.
- G. A separate bid option will include a temporary gravel parking Lot.
