SECTION B - CONTINUATION OF SF 1449 BLOCKS

B.1 STATEMENT OF WORK - Bariatric Hi-Low Beds

This is a Brand Name or Equal requirement. The brand name items referenced are the Sizewise Evolution EXP and Sizewise accessories. For offerors supplying an equivalent product, please supply all product specifications on the equivalent to allow for Government evaluation of acceptability.

A. Background:

The Department of Veterans Affairs Erie Pennsylvania has a brand name or equal requirement for 22 Sizewise Evolution EXP expandable bariatric hi-low beds and mattresses for the new CLC scheduled to open in the fall of 2018. These beds will allow flexibility in providing comfortable, safe beds for our patients and assist in the prevention and reduction of patient injury as a result of patient falls out of bed.

B. Salient Characteristics:

NOTE: In addition to the following salient characteristics the contractor will provide any and all necessary components to ensure communication with the Nurse Call System.

- Height of Mattress Deck to Floor (Low Position) maximum of 10"
- Height of Mattress Deck to Floor (High Position) maximum of 35¼"
- Easily expandable bed frame from 36" to 42" to 48"
- Weight capacity of 850 up to 1000 lbs.
- Battery Back-up and charger
- Patient Lock Outs
- Low CPR Release w/Actuator Assembly
- Central Lock-and- Steer System with swivel casters
- Footboard Staff Control Panel
- Auto contour function, one button chair position
- Trendelenburg/Reverse Trendelenburg functions
- Tuckable or folding handrails
- Meets all FDA Entrapment Guidelines
- Manual emergency CPR release
- Integrated Nurse Call
- Integrated scale system
- Integrated 3-zone Bed Exit Alarm
- Trapeze adapter to allow compatibility with Hill-Rom trapeze or single post trapeze
- Traction and IV receptacles; drainage hooks, restraint loops
- Must have capability to interface with the Hillrom Navicare Nurse Call Communication System
- Mattress length minimum of 80"
- Mattress width shall be expandable from 36" to 42" to 48"

- Mattress shall have the option to convert from non-powered to powered alternating air control unit to allow for 10, 15, 20, 25 minute cycle times to maintain low interface pressures throughout the mattress reducing pressure areas for the patient (feature of a support surface that provides rotation about a longitudinal axis as characterized by degree of patient turn, duration and frequency)
- Mattress will be comprised of a combination of vented/foam filled air chambers that are encased in a foam cavity. Chambers shall run laterally for head to heel pressure redistribution.
- Mattress will have gel-infused viscoelastic thermal neutral foam topper that provides the ability to quickly dissipate or absorb heat in order to maintain an optimal microclimate environment.
- Heel zone of mattress must be tapered to further reduce pressure for the sensitive heel area.

C. General Requirements:

1. Project Management

- a. The contractor shall provide implementation services as part of the bed purchase.
- b. Implementation Services shall include, but are not limited to, a project manager, a detailed project timeline with defined roles and responsibilities (including contractor provided and VAMC Erie resources such as technical staff, and COR), on-site installation coordination of all equipment and accessories, a training plan, and schedule for Go-Live.

2. Delivery and Installation Services

- a. Materials provided shall be new equipment, parts, and accessories as specified in the SOW.
- b. The contractor shall deliver materials to the job site in OEM's original unopened containers, clearly labeled with the OEM's name, equipment model and serial identification numbers, and Purchase Order (PO) number.
- c. The contractor is responsible for inventorying materials prior to delivery to VAMC ERIE to check for accuracy in quantity and part number.
- d. The VAMC ERIE shall identify and provide limited storage of contractor parts/supplies at the time of delivery and reject items that do not conform to this requirement.
- e. All on-site installation services shall be contractor-provided by technical staff (not sales reps) fully trained to service and install bed products, parts, and accessories as specified in the SOW.

- f. The contractor shall ensure that each bed is fully operational. This includes testing the scales and verifying functionality of each bed to the satisfaction of the Government

3. Disposal of Waste

- a. The contractor shall provide, maintain, and dispose all material waste and packaging associated with the beds/products and/or waste generated during the installation services.
- b. Contractor will be responsible for moving waste materials from job site(s) to a contractor-provided waste container, and then off site.

4. Technical Support

- a. Contractor will supply 24/7/365 hour warranty call (on-site) assistance for the duration of the manufacturer's commercial and or extended warranty as awarded.
- b. Response time for parts and labor associated with warranty repairs is 24hours (1 calendar day – excluding Federal Holidays) from the time of the repair call.
- c. Contractor will supply 24/7/365 hour over the phone technical assistance without charge for the life of the Bed Systems.
- d. During warranty period replacement parts for covered items delivered 24 hours of notice of warranty repair call.
- e. Response time for parts and labor will be no more than 24 hours available 24/7
- f. If a bed cannot be repaired in a reasonable amount of time, a loaner be provided at no cost.

5. Service and Operator Manuals The contractor shall provide the following documentation for the proposed bed system:

- a. Two copies of the operator's manual for each 4 beds purchased.
- b. Two copies of complete technical service manuals including troubleshooting guides, necessary diagnostic software and equipment, schematic diagrams, and parts lists for every 4 beds purchased.
- c. Electronic versions of both operators manual and technical service manuals
- d. Abbreviated operating instructions, with non-technical trouble shooting (target audience end users) should be included on all beds.
- e. DVD or web based training for both operator's manual and service if available.

- f. The bed operator's manual must specify the mattress size to reduce risk of patient entrapment between bed and side rail.
- g. The Contractor shall provide VA mandated and local permitted/safety requirements User and Service Manuals.
- h. The contractor shall provide the following documentation for the mattress motors (if applicable):
 - i. One copy of the operator's manual for each motor purchased.
 - ii. Two copies of complete technical service manuals including troubleshooting guides, necessary diagnostic software and equipment, schematic diagrams, and parts lists.
 - iii. Electronic versions of both operators manual and technical service manuals
 - iv. If the operation of the motor is not self-explanatory, abbreviated operating instructions must be included and attached to all motors.

6. On-Site User Training This training shall be provided as listed below. This service call should occur no later than one (1) week after receipt and installation of the beds, but actual schedule will made by mutual agreement of the parties. Prior to the on-site service, the vendor will ensure that the employees providing the service under this contract complete the Privacy Awareness training and submit the completion certificate(s) to the Contracting Officer Representative (COR), William Taylor. The COR will provide all details regarding access to and completion of the required training.

- a. Upon delivery/set up of the beds, the contractor must provide qualified instructors to conduct end user training for staff. Training shall be conducted for end users working assigned tours of duty on the day, evening, and night shifts.
- b. Training will be coordinated with the COR, at reasonable times to be determined by the facility.
- c. All end users must receive training to that end: Training must be must be offered 7 days a week for the first week and 3 days a week in the following week
- d. Ongoing training, annually as requested. Note: This would be a chargeable as a separate contract action – but is a requirement established under this award.

7. Facility Engineering Technical & EMS Training

- a. The contractor shall provide technical training for overall maintenance and service to the VAMC ERIE Biomedical/Technical staff to include factory service training courses (if Applicable). A minimum of six (6) VAMC ERIE Facility Engineering staff shall receive the training.
- b. On-Site Training (is preferred) Coordinated with the COR to be performed by qualified technical personnel.

- c. Any Off-Site (factory based) Training shall include tuition, hotel, meals, and travel expenses for factory based training.
- d. Contractor shall provide any special service tools and/or test equipment comparable with that provided to the OEM's service personnel
- e. The contractor shall provide (on site) technical training for overall cleaning and EMS related maintenance and service to the VAMC ERIE EMS staff

D. Commencement and Prosecution of Work

1. The Contractor shall be required to (a) commence all work under this contract immediately upon award (Notice of Award and Notice to Proceed), (b) prosecute the work diligently, and (c) complete the work ready for use no earlier than 15 August 2018 and no later than 15 September 2018.
2. The times stated for completion shall include procurement, installation, training, and final acceptance final cleanup of the areas.
3. Schedules of work, access to the VAMC facility/spaces, and delivery of material shall be coordinated at least 7 days prior to the required action with designated Contracting Officer's Representative (COR).
4. The contractor will schedule a post-award/pre-work meeting with the COR within 3 days, to occur within 7 days, of award to review work activities and schedules.

C.1 52.211-6 BRAND NAME OR EQUAL (AUG 1999)

(a) If an item in this solicitation is identified as "brand name or equal," the purchase description reflects the characteristics and level of quality that will satisfy the Government's needs. The salient physical, functional, or performance characteristics that "equal" products must meet are specified in the solicitation.

(b) To be considered for award, offers of "equal" products, including "equal" products of the brand name manufacturer, must—

(1) Meet the salient physical, functional, or performance characteristic specified in this solicitation;

(2) Clearly identify the item by—

(i) Brand name, if any; and

(ii) Make or model number;

(3) Include descriptive literature such as illustrations, drawings, or a clear reference to previously furnished descriptive data or information available to the Contracting Officer; and

(4) Clearly describe any modifications the offeror plans to make in a product to make it conform to the solicitation requirements. Mark any descriptive material to clearly show the modifications.

(c) The Contracting Officer will evaluate "equal" products on the basis of information furnished by the offeror or identified in the offer and reasonably available to the Contracting Officer. The Contracting Officer is not responsible for locating or obtaining any information not identified in the offer.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

(End of Provision)

C.2 52.212-4 CONTRACT TERMS AND CONDITIONS—COMMERCIAL ITEMS (JAN 2017)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

(1) Within a reasonable time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) *Invoice.*

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

(i) Name and address of the Contractor;

(ii) Invoice date and number;

(iii) Contract number, line item number and, if applicable, the order number;

(iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;

(v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;

(vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;

(viii) Name, title, and phone number of person to notify in event of defective invoice; and

(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability.* Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances.* The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts.* The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety

Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) *Order of precedence.* Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

(1) The schedule of supplies/services.

(2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;

(3) The clause at 52.212-5.

(4) Addenda to this solicitation or contract, including any license agreements for computer software.

(5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments

(9) The specification.

(t) *System for Award Management (SAM).*

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within

the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see Subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor's SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the "Suspension of payment" paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

(u) Unauthorized Obligations.

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an "I agree" click box or other comparable mechanism (e.g., "click-wrap" or "browse-wrap" agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) *Incorporation by reference.* The Contractor's representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub.
