3. Description of Supplies or Services:

The estimated value of the proposed action is Over 150K

Automated Drug Dispensing Cabinets (ADC) which will allow controlled storage and dispensing of medications within our medical center. We currently utilize Omnicell's products throughout our facility. It supports controlled drug distribution and safe storage in compliance with Joint Commission and OIG standards. The purchase of additional cabinets will support medication management in the Joplin, MO and Springfield, MO CBOCs.

An urgent and compelling need exists, and following the ordering procedures would result in unacceptable delays.

Only one source is capable of providing the supplies or services required at the level of quality required because the supplies or services are unique or highly specialized;

Omnicell is currently used within the VHSO for all other automated drug dispensing cabinets. We currently utilize this manufacturer’s product throughout our facility. It supports controlled drug distribution and safe storage in compliance with Joint Commission and OIG standards. The purchase of an additional cabinets will support medication management in the Joplin, MO and Springfield, MO CBOCs. The purchased cabinets must seamlessly fully integrate and interface with existing Omnicell equipment which includes the main Omnicell server that controls all existing medication cabinets.

In the interest of economy and efficiency, the new work is a logical follow-on to an original Federal Supply Schedule order provided that the original order was placed in accordance with the applicable Federal Supply Schedule ordering procedures. The original order must not have been previously issued under sole source or limited source procedures.

Items peculiar to one manufacturer:

(5) DESCRIBE WHY YOU BELIEVE THE ORDER REPRESENTS THE BEST VALUE CONSISTENT WITH FAR 8.404(d) TO AID THE CONTRACTING OFFICER IN MAKING THIS BEST VALUE DETERMINATION:

The Omnicell units are on VA Contract which offers the best pricing available. Switching to another unit would require a significant uneconomical duplicate investment in computer hardware, software, and technician training. The VHSO has invested over \$2M in Omnicell equipment over the past 10 years and it is the logical choice for CBOCs supported by the main Pharmacy at Fayetteville.


(6) DESCRIBE THE MARKET RESEARCH CONDUCTED AMONG SCHEDULE HOLDERS AND THE RESULTS OR A STATEMENT OF THE REASON MARKET RESEARCH WAS NOT CONDUCTED:

Market Research revealed that only Omnicell has software that will seamlessly interface with VistA patient data. This research was conducted by contacting Omnicell Support and making inquiry. At this time there are no other vendors that can supply a different branded product that will interface and connect as required.

(7) ANY OTHER FACTS SUPPORTING THE JUSTIFICATION: Currently there are other supplies of other proprietary products for medication dispensing (e.g. Pyxis), however the cost to replace all existing equipment and server would far exceed the cost of this upgrade. Average cost of cabinet is \$50,000. VHSO supports 45 cabinets currently with a server replacement cost of \$50,000. The interface cost would be unknown with procurement of all replacement equipment from another supplier. Estimated cost to the government to replace existing systems would be over 2 million dollars not including cost difference between existing cabinets and new supplier cabinets.
