NOTICE: This is a Combined Synopsis/Solicitation notification. The National Cemetery Administration (NCA) 's Intend to Sole Source to a Services Disabled Veteran Owned Small Business (SDVOSB) concern (John Condon Realty) for a NCA requirement of Turf Application Services (North America Industry Classification System (NAICS) code **561730** Landscaping – Services. This is a commercial service contract for **Massachusetts National Cemetery**.

Massachusetts National Cemetery has immediate need for complete turf application services (Broadleaf Weed & Crabgrass Control Services). The need also requires the awardee to provide all turf application as outline in the specification and statement of work (SOW) regarding cemetery turf maintenance.
