The purpose of this amendment is to answer the questions submitted via e-mail in response to the above referenced Solicitation, and make changes to the Solicitation as follows:

A. Answers to Questions:

1. Question: The current solicitation reads that contractor must provide a CPO during *operational hours at all times*. The schedule has the CPO on site 8 hrs. a week and the Lifeguard 5-7 hrs. a day. As it stands, the CPO will not be onsite during all operational hours. Is this accurate?

Answer: CPO shall be on site only during their schedule hours. See attached revised "APPENDIX A WEEKLY SCHEDULE"

Special Material Requirements –

RESPONSIBILITIES DURING POOL OPERATING HOURS: a. CONTRACTOR shall schedule the hours and the days of work of said employees. The Contractor will schedule a CPO to be on duty during operational hours of the pool at all times.

Answer: Amended to remove "at all times" at the end of the last sentence.

2. Question: The current incumbent, are there any performance issues? Are there any special circumstances or "hot buttons" of which we should be aware?

Answer: RFI's are limited to questions regarding the terms and provisions of the solicitation/ RFQ.

3. Question: Will this firm re-compete for the open solicitation?

Answer: RFI's are limited to questions regarding the terms and provisions of the solicitation/ RFQ.
