2. Brief Description of Supplies/ Services required and the intended use/Estimated Amount: \$12,795.00

The Prosthetics Service team has a requirement for 1 Create 5400 System and Starter Package CP5400SP Package which includes the DIGITAL 3D SCANNER WITH IPAD MINI ONLINE EDUCATION FOR (2) STAFF ON HOW TO USE YOUR CREATE 3D PRINTING SYSTEM, and, THREE (3) MONTHS ACCESS TO RAPID PLASTER.

The requirement also includes O&P Specific Modification Software for Diagnostic Sockets:

- THREE (3) MONTHS OF TECHNICAL SUPPORT;
- THREE (3) MONTHS ACCESS TO THE CREATE ONLINE DASHBOARD;
- ONE (1) ROLL OF PCTG FILAMENT- 750G;
- ONE (1) ROLL OF FLEXYFIT FILAMENT -500G;
- ONE (1) FILAMENT STORAGE CONTAINER;
- ONE (1) TOOL KIT;
- ONE (1) ADDITIONAL HOT END;
- ONE (1) CREATE DISTAL END ATTACHMENT;
- ONE (1) CUSTOM DESIGNED LEG COVER, FLEXIBLE INNER SOCKET;
- ONE (1) DIAGNOSTIC SOCKET OR LAMINATION MOLD; and,
- ONE (1) GCODE FILE. SIMPLIFY3D SLICER SOFTWARE

The CREATE 5400 3D Printer will enable the Prosthetics Service to make socket molds in-house, reducing costs incurred when Veterans are sent to outside vendors for these items, and allowing more control over patient care.

The Create 5400 Printing System is a sole source product, manufactured, sold and distributed exclusively by Peak Performance Design LLC d/b/a Create Orthotics and Prosthetics. No division of Create O&P, nor any other company, makes a similar or competing product. There are no agents or dealers authorized to represent this product. Additionally, competition is precluded by the existence of an agreement with the manufacturer, who has given Create an exclusive right to market this product. There is no other like item(s) or product(s) available for purchase that would serve the same purpose or function.

4. Description of market research conducted and results or statement why it was not conducted:

VIP was checked to see if Peak Performance Design was listed as a SDVOSB or Small Business. Many SDVOSB's were found under NAICS code 339112; however, the specific 3D 5400 Create Printer for Orthotics and Prosthetics which is manufactured by Peak Performance Designs is not found under VIP. A Sources Sought Notice was posted to FBO and an RFI was sent via e-mail to potential SDVOSB vendors on 3/2/218 under RFI 36C248-18-Q-9106. Responses were due 3/12/2018; however, no responses were received. Peak Performance Design is not registered as a small business entity.

The Create 5400 3D Printing System is a specific type of 3D Printer used solely for Orthotics and Prosthetics. No division of Create O&P, not any other company make a similar or competing product that would serve the same purpose of function. Furthermore, no other market research was conducted because is a sole source product, manufactured, sold and distributed exclusively by Peak Performance Design LLC d/b/a Create Orthotics and Prosthetics.
