

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued. Solicitation 36C10X18Q0099 is issued as a Request for Quotes (RFQ). This solicitation is being conducted under FAR Part 13.5 Simplified Acquisition Procedures (SAP). This solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular 2005-96 effective November 6, 2017. The NAICS Code is 541330 – Engineering Services is most appropriate for this requirement. The small business size standard is \$15.0 Million.

This solicitation includes VAAR 852.219-10 VA Notice of Total Service- Disabled Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. ## **B.5 PERFORMANCE WORK STATEMENT (PWS)**

Department of Veterans Affairs  
Philadelphia Information Technology Center (PITC)  
EMERGENCY DIESEL GENERATOR RELIABILITY STUDY

### **1.0 BACKGROUND INFORMATION:**

The Philadelphia Information Technology Center (PITC) has a requirement for a reliability study to be performed on the existing VA owned Emergency Power Generation/Distribution System. PITC has had two (2) computer room outages, less than six months apart (i.e. March 2017 & Sept 2017), due to the Emergency Power Generation/Distribution System failing to provide power during commercial power outages.

PITC initially thought the first generation system failure was due to the control settings on the automatic transfer switches and the second outage was due to starved fuel issues to the generators. A reliability study is required to determine all underlying problems that may impair the Emergency Power Generation/Distribution System from providing electricity to the facility during a loss of commercial power.

### **2.0 CONTRACT TYPE:**

This is a firm-fixed price contract.

### **3.0 PERFORMANCE DETAILS:**

#### **3.1 PERFORMANCE PERIOD**

The period of performance of this contract shall be twelve (12) months from the date of award. All tasks will be performed within the timeline outlined in Section 8.0 of this Performance Work Statement (PWS).

Any work at the Government site shall not take place on Federal holidays or weekends unless directed by the Contracting Officer's Representative (COR).

With the exception of testing events that require electrical shutdowns, all the work associated with this Performance Work Statement shall be accomplished under the supervision of a government employee, during normal business hours (i.e. Monday through Friday 8:00am through 4:00pm). The contractor shall provide PITC at least 48 hours' notice of any scheduled work to ensure resources and PITC's primary mission does not conflict.

Testing event(s) that will require the shutdown of electrical power to one or more of the facility automatic transfer switches shall be submitted in writing to the PITC at least 5 business days prior to the scheduled performance of this work. This shutdown work must be performed during non-business hours (i.e. Monday through Friday 6:00pm



through 6:00am or selected weekends) and cannot be performed without written approval by the PITC.

There are ten (10) Federal holidays set by law (USC Title 5 Section 6103) that VA follows:

Under current definitions, four are set by date:

### **3.2 PLACE OF PERFORMANCE**

Tasks under this Performance Work Statement shall be performed at the VA facility located at 5000 Wissahickon Ave., Philadelphia, PA 19144.

### **4.0 SCOPE OF WORK:**

The Contractor shall provide all labor, tools, equipment, and supervision necessary to perform a complete system reliability study of the VA owned Emergency Power Generation/Distribution System. This study shall include cleaning, inspecting, and servicing the underground fuel tank. Upon completion of the study the contractor shall provide the VA with a comprehensive report of findings identifying any vulnerability discovered within the Emergency Power Generation/Distribution System. The comprehensive report shall include a corrective action plan with a cost estimate to repair/resolve all deficiencies. Once the VA makes all recommended repairs, the contractor shall return to the site to perform re-commissioning of the power generation system.

## 6.0 SPECIFIC TASKS AND DELIVERABLES:

The Contractor shall ensure all documentation is written in a skilled business style, is grammatically correct and error free, and is in an electronic format that can be read on Adobe PDF or any Microsoft Windows Office product (e.g. MS Word format, MS Excel, MS Visio, etc.).

### 6.1 CONTRACTOR PROJECT MANAGEMENT PLAN

**6.1.1** The contractor shall develop and maintain a Contractor Project Management Plan (CPMP) that lays out the Contractor's approach, timeline, personnel, and tools to be used in the execution of this effort. The CPMP should take the form of both narrative and graphic format that displays the schedule, personnel and milestones associated with each task.

**6.1.2** The contractor shall provide revised CPMP 5 days after the Post Award Orientation Conference and update the CPMP weekly thereafter.

### 6.2 POST AWARD ORIENTATION CONFERENCE

**6.2.1** A post-award conference aids both government and contractor personnel to (1) achieve a clear and mutual understanding of all contract requirements and (2) identify and resolve potential problems. A post-award conference is a substantive review and analysis of the contract terms and conditions.

**6.2.2** The Contractor shall schedule and attend a technical kickoff meeting within seven (7) days after award. The contractor shall present, for review and approval by the COR, the details of the CPMP.

**6.2.3** The contractor shall be prepared to hear the Government's description of the

two (2) Emergency Power Generation/ Distribution System failures and the actions taken by the Government to prevent further failures.

### **6.3 RELIABILITY STUDY**

The study shall include an engineering evaluation of all system components, as well as complete electrical and mechanical system review.

The study shall include the following:

**6.3.1** The contractor shall evaluate the generator control and protection systems and determine if components are sized and operating properly and if the system settings are set appropriately.

**6.3.2** The contractor shall evaluate the generator diesel fuel distribution system and determine if this system is sized and operating properly, as well as the overall condition of the components.

**6.3.3** The contractor shall evaluate the existing individual and total generator capacity and determine if it is adequate to support the current and projected critical load. If it is deemed to be inadequate to support that load, the contractor shall determine the appropriate size and rating of the generator units required.

**6.3.4** The contractor shall evaluate the environmental support systems (i.e. building space heaters and ceiling/roof fan assemblies) located in the Diesel Generator Building to determine proper sizing and operation during hot and cold weather conditions.

### **6.4 UNDERGROUND DIESEL TANK INSPECTION**

Diesel tank inspection shall include the following:

**6.4.1** Remove the existing diesel fuel from the VA Owned underground storage tank and properly store for reuse;

**6.4.2** Clean and inspect the inside of the underground tank and verify fuel system piping is free from obstruction up to the entrance point into the Diesel Building;

**6.4.3** Perform Hydrostatic Testing of the system for leaks;

**6.4.4** Evaluate the surrounding area grading and drainage to determine possible water penetration capability at the underground diesel storage tank container; and

**6.4.5** Certify the fuel storage tank for use. Contractor will verify the tank meets State Codes for Underground Storage Tanks and register the tanks with the State. The State will then send the VA a Certificate.

## 6.5 COMPREHENSIVE REPORT OF FINDINGS

The contractor shall provide a comprehensive report of findings in narrative and graphic format that includes the following sections:

**6.5.1** A Single Line Diagram (SLD) of the entire Emergency Power Generation/Distribution System;

**6.5.2** Results from fuel tank inspection;

**6.5.3** Detailed analysis outlining vulnerabilities within the current system design and deficiencies found per the current Building and Life Safety Codes;

**6.5.4** A corrective action plan detailing the recommended solutions to resolve system deficiencies;

**6.5.5** Baseline costing figures which shall include equipment cost as well as installation cost for any recommended replacement solution; and

**6.5.6** On-site meeting scheduled with the PITC Electrical Engineer to discuss the report of findings.

## 6.6 RE-COMMISSIONING OF POWER GENERATION/ DISTRIBUTION SYSTEM

The contractor shall return to the VA facility to perform commissioning of the Emergency Power Generation/ Distribution System. Commissioning shall meet all standards outlined in National Fire Protection Association (NFPA) 110 Standard for Emergency and Standby Power Systems standards.

## 7.0 CONTRATOR QUALIFICATIONS

**7.1** The Emergency Generator Logic Controller (GE FANUC VersaMax) operates using GE proprietary software. The Contractor shall provide personnel that are certified to perform GE FANUC VersaMax Programmable Logic Control (PLC) code download and analysis.

**7.2** Contractor shall provide certified underground diesel tank cleaner and inspector.

- (b) Your quote must stipulate that it is predicated upon all the terms and conditions of this RFQ and signed by an official authorized to bind your organization. In addition, it must contain a statement to the effect that it is firm for a period of at least 60 days from the date of receipt by the Government.
- (c) Quotes not submitted directly to [Anthony.Zibolski@va.gov](mailto:Anthony.Zibolski@va.gov), or received after the due date/time may not be considered. The email system will not accept file sizes that exceed 5MB. It is the contractor's responsibility to submit all parts of their quote no later than the date and time specified in the RFQ.
- (d) Quote Files: The submission shall be clearly indexed and logically assembled. Each volume shall be clearly identified and shall begin at the top of a page. All pages of each volume shall be appropriately numbered and identified by the complete company name, date and solicitation number in the header and/or footer.
- (e) All files will be submitted as a Microsoft Excel (.xls/.xlsx), Microsoft Word (.doc/.docx), or Acrobat (.pdf) file or compatible as indicated in the table. Page size shall be no greater than 8 1/2" x 11". The top, bottom, left and right margins shall be a minimum of one inch each. Font size shall be no smaller than 12-point. Times New Roman fonts are required. Characters shall be set at no less than normal spacing and 100% scale. Tables and illustrations may use a reduced font size not less than 8-point and may be landscape. Line spacing shall be set at no less than single space. Each paragraph shall be separated by at least one blank line. Page numbers, company logos, and headers and footers may be within the page margins ONLY, and are not bound by the 12-point font requirement. Footnotes to text shall not be used.

Quoters are responsible for including sufficient details, in a concise manner, to permit a complete and accurate evaluation of each quote.

### **E.6.1 VOLUME I –TECHNICAL CAPABILITY**

The technical volume shall demonstrate the ability to meet the requirements in the solicitation, to include the following:

1. A narrative/graphic presentation that displays the quoter's understanding of the work, ability to meet the objectives of the Performance Work Statement (PWS), and accomplish specific tasks, along with a Contractor Project Management Plan (CPMP).
2. Allocation the contractor identified key personnel, and resources. The currency, quality, depth, and relevancy of experience of proposed individuals in working on similar projects, especially generators and power generation/distribution equipment of similar size and complexity as those identified in the PWS.

3. Submission of licenses/certifications/resumes and contractor identified key personnel and a narrative indicating their ability to design and troubleshoot Emergency Diesel Power Generation/Distribution Systems of similar size and complexity described in the PWS.

#### **E.6.2 Volume II –PAST PERFORMANCE**

1. Past Performance Record: Vendors shall provide information on Past Performance Record. This information is used in determining the level of confidence the Government has for a successful performance based upon the vendor's actions under previously awarded and/or relevant contracts, both for the Government and in the Open Market. The information provided in Volume II will be utilized to evaluate the Vendor's Past Performance.

To be considered part of the Past Performance record, a vendor must demonstrate execution of three (3) or more relevant contracts in the last five (5) years.   - Customer points of contact (provide name, telephone number, and e-mail addresses)
  - Period of Performance (dates)
  - Description of product/service provided (include sufficient detail to demonstrate similarities/dissimilarities to the requirements of this solicitation). This section shall state how the quoter's performance relates to generators and power generation/distribution equipment of similar size and complexity as those identified in the PWS.
- b. A list of Previous Contract Data for all major subcontractors containing the information listed in (1) above as it relates to relevant Prime and Subcontracts that the major subcontractor is currently performing or has completed during the last five (5) years.

2. The Government may utilize the Federal Past Performance Information Retrieval System (PPIRS), the Contractor Performance Assessment

Reporting System (CPARS), responses from the Performance Risk Assessment Questionnaire, data submitted by the vendor, and any other information available to determine the quality and relevance of the vendor's past performance.

### **E.6.3 VOLUME III –PRICE**

1. Quoters shall submit a completed Price Schedule (Section B.4 Price/Cost Schedule). Quoters may also, within the one page narrative, detail any discounts or other relevant pricing information.
2. Quoters shall include signed amendment(s) (SF 30s), if any, in the Price volume. An authorized official of the prime contractor shall sign the amendment(s) and all certifications requiring signature. Additionally, any proposed terms and conditions and/or assumptions upon which the Quote is predicated shall be included in the Price volume.
3. Quoters are hereby advised that any quote- imposed terms and conditions and/or assumptions which deviate from the Government's material terms and conditions established by the solicitation, may render the quoter's quote unacceptable, and thus ineligible for award.

Offerors or quoters are urged and expected to inspect the site where services are to be performed and to satisfy themselves regarding all general and local conditions that may affect the cost of contract performance, to the extent that the information is reasonably obtainable. Offerors must be determined responsible according to the standards of FAR Part 9 to be eligible for award.

The Government is not limited to the Past Performance Record information provided above, but reserves the right to independently seek past performance information through open market contracts, government systems, and other government agencies.

The Contracting Officer does anticipate adequate price competition for this RFQ. Should that not happen, the Contracting Officer may need to ask for Data Other than Certified Cost and Price Data to assist with the determination of price reasonableness.

Vendors are advised that submitting an unrealistically low price may be grounds for eliminating a quote from competition. This could be on the basis that the vendor does not understand the requirement or has made an incautious quote.

*Economically disadvantaged women-owned small business (EDWOSB) concern* means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States and who are economically disadvantaged in accordance with 13 CFR part 127. It automatically qualifies as a women-owned small business eligible under the WOSB Program.

*Forced or indentured child labor* means all work or service—

(1) Exacted from any person under the age of 18 under the menace of any penalty for its nonperformance and for which the worker does not offer himself voluntarily; or

(2) Performed by any person under the age of 18 pursuant to a contract the enforcement of which can be accomplished by process or penalties.

*Highest-level owner* means the entity that owns or controls an immediate owner of the offeror, or that owns or controls one or more entities that control an immediate owner of the offeror. No entity owns or exercises control of the highest level owner.

*Immediate owner* means an entity, other than the offeror, that has direct control of the offeror. Indicators of control include, but are not limited to, one or more of the following: Ownership or interlocking management, identity of interests among family members, shared facilities and equipment, and the common use of employees.

*Inverted domestic corporation* means a foreign incorporated entity that meets the definition of an inverted domestic corporation under 6 U.S.C. 395(b), applied in accordance with the rules and definitions of 6 U.S.C. 395(c).

*Manufactured end product* means any end product in product and service codes (PSCs) 1000-9999, except—

- (1) PSC 5510, Lumber and Related Basic Wood Materials;
- (2) Product or Service Group (PSG) 87, Agricultural Supplies;

- (3) PSG 88, Live Animals;
- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

- (1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—
  - (i) To restrict the free flow of unbiased information in Iran; or
  - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and
- (2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern*—

- (1) Means a small business concern—
  - (i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and
  - (ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.



(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

*Small business concern* means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

*Small disadvantaged business concern*, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

(1) Is at least 51 percent unconditionally and directly owned (as defined at 13 CFR 124.105) by—

(i) One or more socially disadvantaged (as defined at 13 CFR 124.103) and economically disadvantaged (as defined at 13 CFR 124.104) individuals who are citizens of the United States; and

(ii) Each individual claiming economic disadvantage has a net worth not exceeding \$750,000 after taking into account the applicable exclusions set forth at 13 CFR 124.104(c)(2); and

(2) The management and daily business operations of which are controlled (as defined at 13.CFR 124.106) by individuals, who meet the criteria in paragraphs (1)(i) and (ii) of this definition.

*Subsidiary* means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

*Successor* means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

*Veteran-owned small business concern* means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

*Women-owned business concern* means a concern which is at least 51 percent owned by one or more women; or in the case of any publicly owned business, at least 51 percent of its stock is owned by one or more women; and whose management and daily business operations are controlled by one or more women.

*Women-owned small business concern* means a small business concern—

(1) That is at least 51 percent owned by one or more women; or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

*Women-owned small business (WOSB) concern eligible under the WOSB Program* (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.
