B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes VAAR 852.219-10 VA Notice of Total Service- Disabled Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. A minimum of a one (1) year warranty after acceptance will include all parts, labor, preventative maintenance and adjustments necessary for operation of the equipment at a level meeting all requirements of the salient characteristics/specifications of this equipment. Services performed under the warranty time frame, shall be provided within the standard commercial service time frames, Monday through Friday, 8:00 a.m. to 5:00 p.m. Any "emergency" work required by the VA outside the standard commercial service time frames shall be purchased as a separate purchase order from VA North Texas Health Care System.

5. PRODUCT MODIFICATION, REMOVAL OR RECALL:

- a. 6. SECURITY CLAUSE
