1. This solicitation is issued as a Request for Proposal (RFP) from the Department of Veterans Affairs, Commodities & Services Acquisition Service (CSAS). It is numbered **36C79118R0014**.

## SECTION B - CONTINUATION OF SF 1449 BLOCKS

1. This Request for Proposal (RFP) is a Department of Veterans Affairs (VA) action intending to contract with qualified automobile insurance carriers to administer and provide insurance coverage to eligible Veterans with disabilities and certain military personnel that are relearning to drive.
2. Public Law 93-538, dated December 22, 1974 mandates that the VA contract to provide a special driver training courses at every hospital and, where appropriate, at regional offices and other medical facilities, of the Veterans' Administrations to instruct such eligible person to operate the type of automobile or other conveyance such person wishes to obtain with assistance under this chapter, and may make such courses available to any veteran or member of the Armed Forces, eligible for care under the chapter 17 of this title. Title 38 United States Code (U.S.C.) Section 3903(e) authorizes the Secretary of the VA to obtain insurance on automobiles and other conveyances used in conducting the special driver training courses and to obtain, at the Government expense, personal liability and property damage insurance for all persons taking such courses.
3. This solicitation will result in one firm fixed price contract. Contract will be for a base year with four – one (1) year option periods to be exercised by the Contracting Officer. One award will be made to the responsible offeror whose offer conforms to the solicitation and is determined to be the lowest price and technically acceptable.
4. This is considered a commercial service in accordance with the definition for Commercial item at FAR 2.101.
5. This is a Full and Open, Competitive RFP. The applicable NAICS code is 524210, Insurance Agencies and Brokerages; with a U.S. Small Business Administration size standard of \$7.5 Million.
6. The solicited base will be awarded as a firm fixed price contract with four option periods.
7. All proposals submitted in response to this RFP shall be valid for a minimum of 90 calendar days from the date the RFP closes. A statement regarding the validity period must be included in the proposal.
8. Offerors should take special notice of FAR 52.212-1 Instructions to Offerors-Commercial Items. Initial proposals should contain the Offeror's best terms. The Government reserves the right to conduct exchanges if determined necessary by the Contracting Officer.
9. The Government anticipates contracts will be awarded to no more than one offerors; however, the Government reserves the right to award to more if it is in the best interests of the Government. These awards will be based on a best value evaluation in accordance with (IAW) FAR 15.101-1, in conjunction with FAR Part 12 Acquisition of Commercial Items. The Offeror's Technical Approach, Past Performance, Price, and Service-Disabled Veteran-Owned and Veteran-Owned Small Business Participation will be evaluated under this RFP.
10. FAR Clause 52.204-7 System for Award Management is included in this solicitation. Embedded in paragraph (f) of this clause is a web address that takes the user to the ACQUISITION.GOV website. 11. Offerors are responsible for including sufficient details to permit a complete and accurate evaluation of the proposal. The Government will not make assumptions concerning an Offeror’s intent, capabilities, facilities or experience. Offerors are cautioned to ensure that their proposals are complete, including all fill-ins and blanks in the solicitation.

## **B.1 PERFORMANCE WORK STATEMENT**

### **PERFORMANCE WORK STATEMENT**

#### **Driver Rehabilitation Program Insurance**

**BACKGROUND:** Public Law 93-538, dated December 22, 1974 mandates that the VA contract to provide a special driver training courses at every hospital and, where appropriate, at regional offices and other medical facilities, of the Veterans’ Administrations to instruct such eligible person to operate the type of automobile or other conveyance such person wishes to obtain with assistance under this chapter, and may make such courses available to any veteran or member of the Armed Forces, eligible for care under the chapter 17 of this title. Depending upon the severity of the disability and the available adaptive equipment designed for utilization in today’s motor vehicles, the disabled individual should enjoy the independence and freedom of mobility offered all citizens. Title 38 United States Code (U.S.C.) Section 3903(e) authorizes the Secretary of the VA to obtain insurance on automobiles and other conveyances used in conducting the special driver training courses and to obtain, at the Government expense, personal liability and

property damage insurance for all persons taking such courses, hereafter such persons shall be referred to as clients.

***Period of Performance:*** A one year contract, with four (4) one year option periods with initial period of performance from June 1, 2018 to May 31, 2019.

1. ***SCOPE OF WORK:*** Services under this contract consist of third party liability insurance coverage for approximately 100 government-owned vehicles (GOV) up to 130 GOV in the VA Driver Rehabilitation Programs at all participating Department of Veterans Affairs (VA) medical facilities in the United States, Washington D.C., and Puerto Rico. The vehicles covered under this contract are used by clients referred to the Driver Rehabilitation Programs. Government employees are excluded from this contract and are covered under provision of the Federal Tort Claims Act. Insurance coverage shall be automatic during the time clients are involved in the program.

1.1. All the vehicles used in the VA Driver Rehabilitation Program are equipped with specially adapted equipment for use by the disabled driver trainee. At a minimum, all vehicles have been adapted to include an instructor brake on the front passenger side. Vehicles are owned or leased by VA, and are insured (“primary insurance”) by VA.

1.2. Transfer of vehicles: Transfers of driver rehabilitation vehicles from one driver rehabilitation center to another is authorized. Therefore prices for this contract will be based on a nationwide rate rather than a zip code/state basis. The Contractor will be notified within 5 business days by the Contracting Officer Technical Representative and the vehicle location listing will be updated.

1.3. Vehicle Security: When not in use, the Driver Training Vehicle will be kept in a secure location and adequate precautionary measures will be in place; such as, security checks provided by Medical Facility Police.

1.4. On rare occasions, it is necessary to evaluate and train selected driver rehabilitation clients in a non- government owned vehicle, because of the following conditions: lack of availability of special equipment in the government owned vehicles, or to meet the specific individual needs of the patient. In such cases, the contractor will be notified within 24 hours by the Contracting Officer Technical Representative and a task order will be issued as applicable for the privately owned vehicle (POV). Total price of the task order will be prorated based on the time used and contract pricing per vehicle.



2. **GOV COVERAGE:** Coverage for the government-owned vehicles under this contract will be for third party bodily injury (BI) and property damage (PD). Limits of \$1,000,000 each accident – single limit – BI and PD combined. Coverage is for the Driver Rehabilitation Program vehicles at all participating VA medical facilities. This policy will cover any new or replacement driver training vehicles purchased by any existing or new VA facility added to the program during the policy period. The liability coverage shall cover bodily injury and property damage to the third party caused by the driver trainee (client) while operating a specially adapted vehicle in the program.

3. **POV Coverage:** Coverage for the government-owned vehicles under this contract will be for third party bodily injury (BI) and property damage (PD). Limits of \$1,000,000 each accident – single limit – BI and PD combined.

4. **STATIONS:** Please see the attached list of participating VA Driver Rehabilitation Centers and the vehicles, which are to be covered during the policy term Section D. In the event a VA Rehabilitation Center is opened in a state or U.S. Territory not already included in the policy, an amendment to the policy will be incorporated through a bilateral contract modification.

5. **Claims Service:** The Contractor shall operate a customer service claims service program to provide customer support through telephone, facsimile, mail and electronic media 24 hours a day seven days a week.

6. **TRAINING:** Training will occur on a daily basis at each of the driver rehabilitation centers. A VA employee, who is a trained drive rehabilitation specialist, accompanies program participants (clients) during each training session. The only incidence in which the drive rehabilitation specialist is not in the vehicle with the client is during a time when a driving test is being administered by the local (state) Motor Vehicle Department. The state examiner is the only person allowed in the vehicle with the client during the test, and coverage will extend to the client and vehicle during those times.

6.1. **NUMBER OF VEHICLES:** The total number of vehicles used during each policy year is estimated to be 100, but could increase to approximately 130. The Government anticipates that this will be a gradual increase over the term of the contract.

6.2 **NUMBER OF CLIENTS IN PROGRAM:** The Government estimates the total number of clients referred during each policy year is to be **10,000**, but this could increase to approximately **15,000 over the term of the contract**, and includes both veteran and non-veteran clients.

A post-award conference will be held at a time and place or means to be determined after award, unless waived by the Contracting Officer. The conference will take place prior to the period of performance beginning date;

therefore the contractor shall not commence performance under this contract until notified to do so by the Contracting Officer.

### **B. 3 MINIMUM TECHNICAL REQUIREMENTS**

1. This solicitation will result in one firm fixed price contract. Contract will be for a base year with four – one (1) year option periods to be exercised by the Contracting Officer. One award will be made to the

responsible offeror whose offer conforms to the solicitation and is determined to be the lowest price and technically acceptable.

2. The offeror is required to offer prices for a base year and four option year periods identified in the Schedule for each line item. Prices awarded for the base and option year periods will remain in effect for the respective contract base year or option periods, if exercised, without an increase. Evaluation of options and award of option year pricing shall not obligate the Government to exercise any option periods.

3. Estimated Quantities: The estimated quantities listed in the Schedule of Items are estimates of the total annual requirement for a CLIN and are NOT commitments by the Government. The actual quantity will be determined at time of award of the base and each option. The actual quantities awarded will also be subject to the requirements in Section B.1 Performance Work Statement., paragraph 5.

**The minimum technical requirements for each CLIN are listed below and must be met with the submission of any offer.** Offerors shall submit documentation listing how the minimum technical requirements will be met. If the descriptive literature does not contain sufficient detail please submit a technical proposal documenting your compliance with the minimum technical requirements.

Award will be made on a lowest price, technically acceptable (LPTA) basis.

The Government will evaluate on a pass/fail basis and the offeror will be considered technically acceptable if it meets all of the criteria listed below:

1. Carrier must be licensed in all 50 United States, Washington D.C. and Puerto Rico.
2. Carrier must have a Claims Service Center that can be reached 24 hours a day seven days a week through telephone, facsimile, mail and electronic media.
3. A.M. Best Rating of B or higher.

## SECTION C - CONTRACT CLAUSES

### C.1 Contract Terms and Conditions—Commercial Items (Jan 2017)

(a) Inspection/Acceptance. The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

(1) Within a reasonable time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) Assignment. The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act (31 U.S.C. 3727). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) Changes. Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) Disputes. This contract is subject to 41 U.S.C. chapter 71, Contract Disputes. Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR 52.233-1, Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) Definitions. The clause at FAR 52.202-1, Definitions, is incorporated herein by reference.

(f) Excusable delays. The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.



(g) Invoice.

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

- (i) Name and address of the Contractor;
  - (ii) Invoice date and number;
  - (iii) Contract number, line item number and, if applicable, the order number;
  - (iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;
  - (v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;
  - (vi) Terms of any discount for prompt payment offered;
  - (vii) Name and address of official to whom payment is to be sent;
  - (viii) Name, title, and phone number of person to notify in event of defective invoice; and
  - (ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.
- (x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., 52.232-33, Payment by Electronic Funds Transfer—System for Award Management, or 52.232-34, Payment by Electronic Funds Transfer—Other Than System for Award Management), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act (31 U.S.C. 3903) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR Part 1315.

(h) Patent indemnity. The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) Payment.—

(1) Items accepted. Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) Prompt payment. The Government will make payment in accordance with the Prompt Payment Act (31 U.S.C. 3903) and prompt payment regulations at 5 CFR Part 1315.

(3) Electronic Funds Transfer (EFT). If the Government makes payment by EFT, see 52.212-5(b) for the appropriate EFT clause.

(4) Discount. In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) Overpayments. If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

(C) Affected line item or subline item, if applicable; and

(D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) Interest.

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in 41 U.S.C. 7109, which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) Final decisions. The Contracting Officer will issue a final decision as required by 33.211 if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see 32.607-2).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in 32.608-2 of the Federal Acquisition Regulation in effect on the date of this contract.

(j) Risk of loss. Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) Taxes. The contract price includes all applicable Federal, State, and local taxes and duties.

(l) Termination for the Government's convenience. The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) Termination for cause. The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) Warranty. The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) Limitation of liability. Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) Other compliances. The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) Compliance with laws unique to Government contracts. The Contractor agrees to comply with 31 U.S.C. 1352 relating to limitations on the use of appropriated funds to influence certain Federal contracts; 18 U.S.C. 431 relating to officials not to benefit; 40 U.S.C. chapter 37, Contract Work Hours and Safety Standards; 41 U.S.C. chapter 87, Kickbacks; 41 U.S.C. 4712 and 10 U.S.C. 2409 relating to whistleblower protections; 49 U.S.C. 40118, Fly American; and 41 U.S.C. chapter 21 relating to procurement integrity.

(s) Order of precedence. Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

(1) The schedule of supplies/services.

(2) The Assignments, Disputes, Payments, Invoice, Other Compliances, Compliance with Laws Unique to Government Contracts, and Unauthorized Obligations paragraphs of this clause;

(3) The clause at 52.212-5.

(4) Addenda to this solicitation or contract, including any license agreements for computer software.

(5) Solicitation provisions if this is a solicitation.

(6) Other paragraphs of this clause.

(7) The Standard Form 1449.

(8) Other documents, exhibits, and attachments.

(9) The specification.

(t) System for Award Management (SAM).

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data within the SAM database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the SAM database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent

updates its information in the SAM database to ensure it is current, accurate and complete. Updating information in the SAM does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, “doing business as” name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR subpart 42.12, the Contractor shall provide the responsible Contracting Officer a minimum of one business day’s written notification of its intention to (A) change the name in the SAM database; (B) comply with the requirements of subpart 42.12; and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the SAM information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the “Suspension of Payment” paragraph of the electronic funds transfer (EFT) clause of this contract.

(3) The Contractor shall not change the name or address for EFT payments or manual payments, as appropriate, in the SAM record to reflect an assignee for the purpose of assignment of claims (see subpart 32.8, Assignment of Claims). Assignees shall be separately registered in the SAM database. Information provided to the Contractor’s SAM record that indicates payments, including those made by EFT, to an ultimate recipient other than that Contractor will be considered to be incorrect information within the meaning of the “Suspension of payment” paragraph of the EFT clause of this contract.

(4) Offerors and Contractors may obtain information on registration and annual confirmation requirements via SAM accessed through <https://www.acquisition.gov>.

#### (u) Unauthorized Obligations

(1) Except as stated in paragraph (u)(2) of this clause, when any supply or service acquired under this contract is subject to any End User License Agreement (EULA), Terms of Service (TOS), or similar legal instrument or agreement, that includes any clause requiring the Government to indemnify the Contractor or any person or entity for damages, costs, fees, or any other loss or liability that would create an Anti-Deficiency Act violation (31 U.S.C. 1341), the following shall govern:

(i) Any such clause is unenforceable against the Government.

(ii) Neither the Government nor any Government authorized end user shall be deemed to have agreed to such clause by virtue of it appearing in the EULA, TOS, or similar legal instrument or agreement. If the EULA, TOS, or similar legal instrument or agreement is invoked through an “I agree” click box or other comparable mechanism (e.g., “click-wrap” or “browse-wrap” agreements), execution does not bind the Government or any Government authorized end user to such clause.

(iii) Any such clause is deemed to be stricken from the EULA, TOS, or similar legal instrument or agreement.

(2) Paragraph (u)(1) of this clause does not apply to indemnification by the Government that is expressly authorized by statute and specifically authorized under applicable agency regulations and procedures.

(v) Incorporation by reference. The Contractor's representations and certifications, including those completed electronically via the System for Award Management (SAM), are incorporated by reference into the contract.

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

Award will be made to the lowest priced, technically acceptable, responsible offeror whose proposal conforms to the solicitation requirements, and whose proposal adequately demonstrates that they are able to meet, on a pass/fail basis, all of the Minimum Technical Requirement for each line item as listed in Section B.3 above. If an offeror does not meet all of the minimum technical requirements as stated in Section B.3 above, they will be determined technically unacceptable and their proposal will not receive further consideration.

Award will be made on a lowest price, technically acceptable (LPTA) basis.

The Government will evaluate on a pass/fail basis and the offeror will be considered technically acceptable if it meets all of the criteria listed below for each proposed CLIN.

1. Carrier must be licensed in all 50 United States, Washington D.C., and Puerto Rico.

2. Carrier shall operate a customer service claims service program to provide customer support through telephone, facsimile, mail and electronic media 24 hours a day seven days a week.
3. Carrier must carry an A.M. Best Rating of B or higher.
4. Coverage for the government-owned vehicles under this contract will be for third party bodily injury (BI) and property damage (PD). Limits of \$1,000,000 each accident – single limit – BI and PD combined. Coverage is for the Driver Rehabilitation Program vehicles at all participating VA medical facilities. This policy will cover any new or replacement driver training vehicles purchased by any existing or new VA facility added to the program during the policy period. The liability coverage shall cover bodily injury and property damage to the third party caused by the driver trainee (client) while operating a specially adapted vehicle in the program.

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. Before the offer's specified expiration time, the Government may accept an offer (or part of an offer), whether or not there are negotiations after its receipt, unless a written notice of withdrawal is received before award.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as



those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). (B) The IRS has filed a notice of Federal tax lien with respect to an assessed tax liability, and the taxpayer has been issued a notice under I.R.C. Sec. 6320 entitling the taxpayer to request a hearing with the IRS Office of Appeals contesting the lien filing, and to further appeal to the Tax Court if the IRS determines to sustain the lien filing.
