

B.4 SCHEDULE OF SERVICES AND PRICING (revised 04/05/2018)

All prices and rates shall be for loaded (patient onboard) services and mileage only. But for exceptions (dry-runs or cancellations) indicated in Section B.5, PWS Paragraph 9.F., the Government shall not pay for unloaded (no patient) services or mileage.

Orders shall be placed in accordance with Section B.5, PWS Paragraph 4. The default method of payment shall be electronic funds transfer submitted into Tungsten, unless the Contracting Officer specifies otherwise. The Contractor is required to maintain an awareness of available order quantities as they are depleted during performance. Services rendered which exceed order quantities issued by the Contracting Officer shall be the risk of the Contractor and any cost thereof may be borne by the Contractor.

The quantities are estimated quantities only and shall be considered nonbinding.

The guaranteed minimum for the fiscal year in which the contract was awarded shall be \$2,000.00.

The total maximum amount of services acquired under this contract shall not exceed \$15,000,000.00.
