#### **Specifications/Characteristics:**

**Each item must be compatible with the equipment, infrastructure, and supplies already in use in VHSO Eye Clinics. VHSO has equipped each of our exam rooms at Fayetteville, Mount Vernon, Branson with identical equipment to help ensure continuity of care, maximize efficiency, and allow our providers and residents to move seamlessly from room to room and from clinic to clinic.**

**Binocular Indirect Ophthalmoscope, Heine Omega 500 with accessories: Heine extension cord.** (Binocular indirect ophthalmoscopy is used to diagnose and monitor a number of retinal diseases including retinal detachment, diabetic retinopathy, and retinal holes.

- Indirect Ophthalmoscope must have four adjustable light size settings and at least three-color settings.
- Unit must have a halogen bulb and be corded for attachment to the equipment stand.

**Reichert minus cylinder phoropter, Topcon KM-4 Manual Keratometer, Project-O-Chart with accessories: wall mount, deluxe slides, child's slides, 13x13 screen, front surface mirror set.** (The phoropter and keratometer are used in the determination of a patient's glasses or contact lens prescriptions. The projector system is used in conjunction with the phoropter to perform a refraction. This measurement provides optimum visual correction as well as manage many disease states and their effect on vision.)

- Phoropter must have minus cylinder.

- Cylinder dials must be located in the inner-lower portion of the instrument.
- Keratometer must have manually adjustable dials for measurement of the corneal surface.
- Projector chart must mount to the wall with tilt adjustments.
- Projector System must consist of two mirrors and a third projection surface.

**Topcon CL-300 Lensmeter** (used to determine and/or verify the proper glasses prescription).

- Lensmeter must have auto-measuring functions for glasses measurement.
- Lensmeter must have multiple programmable settings for measurement of single vision, bifocal, and progressive glasses.

**Topcon trial lens set with accessories: Lombart lens cabinet, Lombart metal trial frame.** (Used in the final determination of an eyeglasses prescription.)

- Custom cabinet on rollers.
- Trial frame must have fully adjustable features for pupillary distance, height, and temple length.

**Kowa HA02 handheld tonometer and Tono-Pen XL tonometer.** Tonometry is part of a comprehensive exam and crucial as part of glaucoma management. Both the Kowa tonometer and Tono-Pen XL are reliable hand-held instruments in measuring intraocular pressure when a mounted Goldmann device cannot be utilized (i.e., wheel chair patient, inpatient, obese patient, etc.). The Tono-Pen is particularly useful when intraocular pressure cannot be measured with standard devices due to media opacity, compromised cornea, apprehension, etc. Tono-Pen technology is also easier and more efficient for eye technicians to use.

- Tonometer must employ the Goldmann style prism.
- Tono-Pen must have a single-button measurement feature.

This includes termination of the contract or, solely at the VA's election, allowing the Vendor to replace, at no cost to the Government, any remanufactured or gray market item(s) delivered to a VA medical facility upon discovery of such items.

(iii) The Government will evaluate offers in accordance with the policies and procedures of FAR Part 25. For line items covered by the WTO GPA, the Government will evaluate offers of U.S.-made or designated country end products without regard to the restrictions of the Buy American statute. The Government will consider for award only offers of U.S.-made or designated country end products unless the Contracting Officer determines that there are no offers for such products or that the offers for such products are insufficient to fulfill the requirements of the solicitation.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. Sec. 6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. 362 (the Bankruptcy Code).
