**SOURCES SOUGHT DESCRIPTION**

This is NOT a solicitation announcement. This is a sources sought/RFI only. The purpose of this RFI is to gain knowledge of potential qualified sources and their size classification relative to NAICS 334515 (size standard of 750 Employees). Responses to this sources sought will be used by the Government to make appropriate acquisition decisions. After review of the responses to this sources sought, a solicitation announcement may be published. Responses to this sources sought synopsis are not considered adequate responses for a solicitation announcement.

The Department of Veterans Affairs (VA), VISN 22 Network Contracting Office, is seeking sources that can at a minimum meet the following salient characteristics with a brand name or equal to a *Pacer Analyzer /Defibrillator* for the VA Long Beach Healthcare System:

**SALIENT CHARACTERISTICS:**

**1. Fluke Biomedical SigmaPace 1000 External Pacemaker Analyzer:**

- a) Must have capabilities of:
  - i) Tests for both transcutaneous and trans-venous external pacemakers
  - ii) Full range selectable measurement algorithms and test loads for external pacemakers
  - iii) Dual-channel signal acquisition for capturing synchronous AV-sequential pulse data
  - iv) Interactive pacemaker and ECG simulation with 5-lead output
- b) Must have test features: DC static/dynamic leakage, and current drain
- c) Must have rechargeable battery
- d) Unit must come with a carrying case.

- b) Must have One-tap testing for most performance tests and checks
- c) Must have patient monitor testing in one minute or less
- d) Must have rechargeable battery
- e) Must have connected ECG posts for secure lead connections
- f) Unit must come with a carrying case
- g) Must meet safety standards IEC 61010-1:2001
