5. **Rational/explanation to support cited authority:** The Metacross RX is a Percutaneous Transluminal Angioplasty Balloon Dilatation Catheter for peripheral indications has the smallest balloon profile. Enables faster, more convenient exchange of devices, supports the use of shorter guidewires, encourages procedural efficiency, reducing fluoroscopy time and radiation dose, optimizes control, allowing a single operator to mitigate lost wire position.

The Crossperio RX is a Percutaneous Transluminal Angioplasty Balloon Dilatation Catheter for peripheral indications to dilate stenosis in the iliac, femoral, ilio-femoral, infra-popliteal and renal arteries and for the treatment of obstructive lesions of native or synthetic arteriovenous dialysis fistulae. Also indicated for stent post-dilatation in the peripheral vasculature.

6. **BRAND NAME ONLY:** This buy is not estimated to exceed \$25,000 and this documentation will be posted along with the RFQ on e-Buy, as required by [FAR 8.405-1\(e\)](#).
