## **STATEMENT OF WORK**

Repair Part and Service; Contractor shall provide a brand-new PC workstation, P1 to I5 upgrade kit, Part# 710327, to the Biomedical Engineering department at JACC Pensacola. The Contractor will also provide installation services for the PC workstation.

### **1. CONTRACTOR PERFORMANCE REQUIREMENTS**

#### **a. Initial Startup:**

- 1) Contractor must deliver the PC upgrade kit to the Biomedical Engineering Department of the VA Gulf Coast Health Care System, Joint Ambulatory Care Center, 790 Veterans Way, Pensacola, FL 32507, in accordance with the shipping options chosen at the time of purchase.

#### **b. In-field Supervision**

- 1) Contractor will remove the old PC workstation and will install the new PC upgrade kit on-site.

Contractor agrees, in accordance with the terms and conditions stated herein, to furnish to the Department of Veterans Affairs facilities, hereinafter referred to as the VA, the material and services specified and at the prices specified herein.

### **2. CONTRACTOR PERFORMANCE REQUIREMENT - TRAINING**

#### **Training**

- 1) Contractor performing repair services must be factory-trained.

### **3. FUNCTIONS AND RESPONSIBILITIES:**

- a. Service engineer from the manufacturer will install the PC upgrade kit and verify function in accordance with manufacturer's guidelines.

### **4. SERVICE:**

- a. The services specified herein may be changed by written modification to this contract.
- b. Any disagreements concerning services to be provided or other questions and concerns will be forwarded to the Contracting Officer for resolution.

**5. PERSONNEL :**

Biomedical Engineering Staff (“Biomed”) : Upon receipt of the PC Upgrade kit, will coordinate with the manufacturer and schedule for the service engineer to come on site and install the PC upgrade kit.

**6. MONITORING :**

Biomed personnel at the JACC will escort and monitor the service engineer during the installation process..

**7. RECORDKEEPING SYSTEM :**

Biomed staff will report hours worked on this request through the Maximo work order system, entered under the EE number of the device receiving the assembly.

**8. WORK HOURS :**

Work hours will be within normal duty hours of Biomed staff.

**9. PERSONNEL POLICY:**

The contractor shall provide necessary parts to fix the Liebel-Flarsheim Cysto X-ray unit.

In the performance of this repair, Biomed staff will take all necessary precautions in regards to electrical safety, infection control, and equipment storage.

The Contracting Officer is not responsible for locating or obtaining any information not identified in the offer.

(d) Unless the offeror clearly indicates in its offer that the product being offered is an "equal" product, the offeror shall provide the brand name product referenced in the solicitation.

(c) A written notice of award or acceptance of an offer, mailed or otherwise furnished to the successful offeror within the time for acceptance specified in the offer, shall result in a binding contract without further action by either party. - (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

*Small business concern* means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

*Small disadvantaged business concern*, consistent with 13 CFR 124.1002, means a small business concern under the size standard applicable to the acquisition, that—

*Subsidiary* means an entity in which more than 50 percent of the entity is owned—

(1) Directly by a parent corporation; or

(2) Through another subsidiary of a parent corporation.

*Successor* means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

*Veteran-owned small business concern* means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(u)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Appropriations Act, 2015 (Pub. L. 113-235) and its successor provisions in subsequent appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).
