STATEMENT OF WORK (SOW)

I. GENERAL DESCRIPTION

a. Veterans Affairs Ann Arbor Healthcare System (VAAHS) main campus is located at Ann Arbor, Michigan. The VAAHS network infrastructure equipment and their rooms require a yearly environmental cleaning to reduce the risk of dust and particulate from hampering or reducing service life of network equipment.

II. DEFINITIONS

Commonly used terms and acronyms and their equivalent appear throughout this contract and shall have the following meanings:

- a. CONTRACTING OFFICER (CO):** The person executing this contract on behalf of the Government (Only the Contracting Officer is authorized to make commitments to issue changes that shall affect the price, quantity, and quality or delivery terms of this contract).
- b. CONTRACTING OFFICER'S REPRESENTATIVE (COR):** The COR is an employee of the VA designated to perform specified contract administration activities, but is not given authority to enter into contractual agreements or modifications.
- c. HEPA:** High-Efficiency Particulate Air
- d. IT:** Information Technology
- e. VA:** Veteran's Administration
- f. VAAHS:** Veterans Affairs, Ann Arbor Healthcare System to include the Main Medical Center, its clinics and CBOCs.
- g. NOTE:** All times reflect Eastern Standard Time (EST).

III. PLACE OF PERFORMANCE

- a.** Ann Arbor VA Medical Center (AAVAMC), 2215 Fuller Rd, Ann Arbor, MI 48105

IV. PERIOD OF PERFORMANCE

- a.** Estimated Period of Performance
 - i.** Base Year: May 1, 2018 – April 30, 2019
 - ii.** Option Year 1: May 1, 2019 – April 30, 2020
 - iii.** Option Year 2: May 1, 2020 – April 30, 2021
 - iv.** Option Year 3: May 1, 2021 – April 30, 2022
 - v.** Option Year 4: May 1, 2022 – April 30, 2023
- b.** The Period of Performance may be adjusted on a sliding scale based on time of award. Timeframes above reflect the earliest possible effective date.

V. SCOPE OF WORK

a. Contractor shall provide cleaning services one-time annual cleaning services for the following IT areas. Services shall include:

i. DATA CENTER – Approximately 1,728 square feet

1. Under-Floor Plenum Cleaning

- a. HEPA vacuum the raised floor surface to remove loose particulate prior to removing floor tiles,
- b. Lift a limited number of floor tiles to provide underfloor plenum access,
- c. Manually remove large debris and contaminants,
- d. HEPA vacuum the subfloor slab to remove dust and debris,
- e. HEPA vacuum floor stringers, pedestal heads,
- f. Clean perforated tiles and replace to their original locations,
- g. Provide a comprehensive report highlighting conditions of the underfloor plenum, AND
- h. Any damaged equipment cabling or flooring shall be documented and brought to the attention of the COR to ensure that the contractor is not held liable for any preexisting conditions that cannot be resolved through standard cleaning services required under this contract.

2. Floor Surfaces (Raised and Non-Raised Access Flooring)

- a. HEPA vacuum all floor surfaces, including accessible areas beneath hardware devices, to remove loose particulates
- b. Safely damp mop floor surfaces using Data Center approved cleaners and low lint mops
- c. As needed and based on maintenance frequency, scrub clean all accessible floor surfaces using low speed scrubbing machines to remove imbedded contaminants and scuff marks
- d. Safely damp mop floor surfaces as many times as needed to remove residual contaminants and cleaning solution

3. Equipment and Environment Cleaning

- a. HEPA Vacuum, Damp Wipe and Spot Scrub:
 - i. Exterior and interior surfaces of equipment cabinets, racks and stand-alone equipment, e.g. mainframes and tape libraries.
 - ii. Exterior surfaces of support equipment, power distribution units and any Uninterrupted Power Source.
 - iii. Exterior surfaces of furniture, chairs and desktop equipment, e.g. tables, storage cabinets, monitors
 - iv. Major infrastructure components, e.g. interior windows, window sills, wall mounted hardware (Not to include window covering when present)

ii. Telecommunications Room – Approximately 1,376 square feet**1. Floor Surfaces**

- a.** HEPA vacuum all floor surfaces, including accessible areas beneath hardware devices, to remove loose particulates
- b.** Safely damp mop floor surfaces using Data Center approved cleaners and low lint mops
- c.** As needed and based on maintenance frequency, scrub clean all accessible floor surfaces using low speed scrubbing machines to remove imbedded contaminants and scuff marks
- d.** Safely damp mop floor surfaces as many times as needed to remove residual contaminants and cleaning solution
- e.** Apply Anti-static floor sealer

2. Equipment and Environment Cleaning

- a.** HEPA Vacuum, Damp Wipe and Spot Scrub:
 - i.** Exterior and interior surfaces of equipment cabinets, racks and stand-alone equipment, e.g. mainframes and tape libraries
 - ii.** Exterior surfaces of support equipment, power distribution units and any Uninterrupted Power Source.
 - iii.** Exterior surfaces of furniture, chairs and desktop equipment, e.g. tables, storage cabinets, monitors
 - iv.** Major infrastructure components, e.g. wall mounted hardware

iii. IT Closets – (see Section VII. IT Closets)**1. Floor Surfaces**

- a.** HEPA vacuum all floor surfaces, including accessible areas beneath hardware devices, to remove loose particulates
- b.** Safely damp mop floor surfaces using Data Center approved cleaners and low lint mops
- c.** Safely damp mop floor surfaces as many times as needed to remove residual contaminants and cleaning solution

2. Equipment and Environment Cleaning

- a.** HEPA Vacuum, Damp Wipe and Spot Scrub:
 - i.** Exterior surfaces of equipment cabinets, racks and stand-alone equipment, e.g. switches, routers
 - ii.** Exterior surfaces of support equipment, power distribution units, NetBotz, Uninterrupted Power Source, and overhead piping.

3. Chemical Controls

- a.** All chemicals will need to be contained in appropriately marked and sealed containers
- b.** Material Safety Data Sheet (MSDS) must be maintained for all materials utilized by the contractor. (Must be in an easily accessed location.)
- c.** Cleaners shall not contain ammonia or dangerous chemical solvents that are potentially hazardous to the data processing equipment.

VI. CONTRCTOR RESPONSIBILITY

a. Cleaning Requirements:

- i. The contractor shall furnish labor, equipment and supplies for datacenter under plenum, floor surface, equipment, environment and air quality cleaning services resulting in the prevention of downtime and increasing the reliability of our data center while adhering to the sensitivity and safety of our mission critical operations.
- ii. Cleaning services in a data center, telecommunications rooms and IT closets have to be carried out by controlled environment specialists that understand the data center dynamics and how to decontaminate these areas without causing downtime or microscopic long-term damage.
- iii. Data Center Cleaners decontaminate (clean) equipment and supplies and their effects on different surfaces, energies and microscopic air particulate using testing instruments and specialized cleaning equipment and chemicals. Since there are static, particulate, network signals and heat sources in the Data Center that can cause disastrous catastrophic loss of uptime to the Library of Congress, cause fires and Indoor Air Pollution –there are several standards that help keep these environments safe including:
 1. American Society of Heating, Refrigerating, and Air-Conditioning Engineers (ASHRAE) and International Organization for Standardization (ISO) Standards.
 2. All areas are to be cleaned to minimum levels outlined in the ASHRAE 2009a white paper report and ISO Standard 14644-1.
- b. Hours of approved work are during normal work hours determined by the VAAAHCS defined as 8:00 AM through 4:30 PM EST, excluding Federal Holidays. Work outside of these hours shall NOT be approved.
- c. **NOTE:** The Federal Government observes the following Federal Holidays plus any other day designated a Federal Holiday by the President of the United States:

The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 30 days.
