1. Draeger Infinity Acute Care System (IACS) monitors are needed by the Post Anesthesia Care Unit (PACU) to replace their end of life GE Monitoring system. Anesthesia Department utilizes the Infinity Delta XL monitoring system and Apollo Draeger Anesthesia machines. Anesthesia and PACU utilize Draeger Innovian Automated Record System (ARK). Recently, the Anesthesia Department and PACU each purchased and utilize Draeger IACS monitors placed on portable Kiosk when performing out of Operating Room and out of PACU cases. The Post Anesthesia Care Unit needs a system that can be used on its own or as a transport monitor, with cable ports keyed, color-coded and labeled for fast setup.
2. Requirements: Seamless integration between the Draeger PACU patient monitoring and Draeger Anesthesia Monitoring optimizes patient care and safety that once docked, stored events and patient demographics are automatically backfilled, supporting a complete patient record and reducing the risk of missed events. Meets monitoring needs: of ECG, basic arrhythmia, respiration, pulse rate, temperature, invasive and non-invasive blood pressure, Nellcor OxiMax SpO2, integrated cable hookups for compatibility, and portability.
3. Define requirements: The Draeger Infinity Acute Care System (IACS) Monitors must be compatibility with Draeger ARK System and Draeger maintenance.

This includes termination of the contract or, solely at the VA's election, allowing the Vendor to replace, at no cost to the Government, any remanufactured or gray market item(s) delivered to a VA medical facility upon discovery of such items.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). “Sensitive technology”—

  - (i) To restrict the free flow of unbiased information in Iran; or
  - (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern—*
