Background/ Scope

The Alexandria VA Health Care System, Pineville, LA requires office furniture and industrial furniture for the Biomedical Department, located in Building 7, at the Veterans Health Care System in Pineville, LA.

Objectives

To ensure all office furniture and industrial furniture is capable of operating in a correct and safe manner as intended and designed by the Original Equipment Manufacturer (OEM).

Tasks

- The contractor will supply, deliver, assemble, and install office furniture and industrial furniture at the U.S. Department of Veterans Affairs located at 2495 Shreveport Hwy in Pineville, Louisiana 71360 during normal business hours.
- The contractor will deliver and install of the office furniture and industrial furniture within 12 weeks after contract award.
- The location for the office furniture and industrial furniture installation is in building 7, rooms 46, 54, 56, and 57. Furniture layout will be provided by the VA within 5 business days of contract award. Warranty Information

The industrial furniture must have a minimum of a 55-year 100% Satisfaction Warranty, limited only to abuse.

Delivery

- Contractor will bring items to the VA for installation. Delivery and installation shall take place at the same time. Project COR will coordinate with contractor and designate the installation location for each piece of supplied equipment and provide means for both loading and unloading of materials on VA property. The VA will not provide storage for any items that are not installed.
- Installed items shall be tested to verify the items perform as required by the VA.
- The COR will be informed in the following situations:
 - Before the start of any contract work.
 - After arriving on site but before any work is started.
 - To complete all contract work in the time specified.

- As soon as it is known that the work will take longer than expected.
- At completion of work prior to leaving the facility.
- To report any incomplete aspects of the work or issues that could not be corrected during the visit.
- To provide a written plan for corrective action for any work that cannot be completely within contract specified time. Plan must be provided to and approved by COR.
- All required contract repairs and work completed will be approved and accepted by COR prior to accepting and approving contractor application for payment.
- All required testing procedures and results will be approved and accepted by COR prior to accepting and approving contractor application for payment.

Security and General Requirements

- All on-site work should be completed between the hours of 8am and 4:30pm CST, Monday through Friday excluding holidays unless otherwise listed in the tasks section.
- Contractor shall obtain an access badge from the VA Police Department or from Facility Engineering Department while performing work on-site.
- Contractor shall contact COR whenever work is being performed in any VA facility to determine if an escort is needed. COR will arrange for an escort if needed.
- Security and privacy requirements vary depending on the service being performed. Contractor personnel may be required to complete any or all of the following but not limited to:
 - Online training.
 - Read, sign, and comply with 'Contractor Rules of Behavior'.
 - Submit to finger printing and background investigation.
 - Provide network security information as requested for any equipment used in the VA facilities.
 - The extend of these requirements will be determined by COR using current facility Information Technology and Privacy rules in cooperation with experts in those departments.

- Parking will be limited to established parking lots. Contractors and personnel are not allowed on the grass area unless specifically authorized by the COR. U.S. District Court Violation Notices will be issued for parking violations.
- The contractor and all employees will comply with all applicable VA Medical Center fire, safety, and traffic regulations.
- The contractor is to field verify existing conditions.
- All work is to be performed within all OSHA, EPA, VA, and Federal, State and local codes and regulations.
- No roadway, drainage ditch, pedestrian walkway, or any other service, utility, or access to any of the above is to be blocked or rendered unusable for any length of time during this project unless previously approved by the COR.
- All work, materials, storage of materials and equipment, repair procedures and unforeseen problems or circumstances are to be coordinated with the COR.
- Work on this project will not begin until authorized by the Contracting Officer.
- The title COR shall refer to the Contracting Officer's Representative.

Contractor Responsibility

The contractor is responsible to repair or replace any item damaged during installation. This includes existing facility walls, floors, ceiling, doors and doorframes as well as all equipment in the facility. Damage to existing items will be repaired to the condition they were in at the start of this project.

Place of Performance

- Installation work will be performed at the Alexandria VA Health Care System, Pineville, LA, Bldg 7 or in the immediate vicinity of Bldg 7 as required by this Statement of Work.
- Equipment or materials may be removed from the facilities for service with prior permission from COR and the Department Director.

Period of Performance

All contractually required work and tests must be successfully completed within 12 weeks after contract award.

ISO Requirements

The C&A requirements do not apply, therefore a Security Accreditation Package is not required.

All software licensing, warranty and service associated with the medical supplies, medical equipment and/or services contracts for maintenance of medical equipment shall be in accordance with the OEM terms and conditions.

(c) The delivery of gray market items to the VA in the fulfillment of an order/award constitutes a breach of contract. Accordingly, the VA reserves the right enforce any of its contractual remedies. This includes termination of the contract or, solely at the VA's election, allowing the Vendor to replace, at no cost to the Government, any remanufactured or gray market item(s) delivered to a VA medical facility upon discovery of such items.

(a) The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation will be most advantageous to the Government, price and other factors considered. The following factors shall be used to evaluate offers:

(b) *Options.* The Government will evaluate offers for award purposes by adding the total price for all options to the total price for the basic requirement. Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—
