SOURCES SOUGHT DESCRIPTION

This is NOT a solicitation announcement. This is a sources sought/RFI only. The purpose of this sources sought/RFI is to gain knowledge of potential qualified sources and their size classification relative to NAICS 333415 (size standard of 1,250 Employees). Responses to this sources sought will be used by the Government to make appropriate acquisition decisions. After review of the responses to this sources sought, a solicitation announcement may be published. Responses to this sources sought synopsis are not considered adequate responses for a solicitation announcement.

The Department of Veterans Affairs (VA), VISN 22 Network Contracting Office, is seeking a brand name or equal product for the VA San Diego Healthcare System. We are seeking sources that at a minimum can meet the following salient characteristics of an *Ice Machine, Refrigerator and Freezer*:

ICE MACHINE & DISPENSER, NUGGET STYLE (50FB425A-S) & (50FB425A-L)

- Must automatically produce compressed nugget ice for patient safety, No cubed ice.
- Must have automatic bin level control with a storage capacity of 50Lbs.
- Must have silver-base antimicrobial built in protection for key ice and water contact components for continuous protection against microbes growth.
- Must have activated sleep-mode that turns off ice machine when idle.

REACH-IN UNDERCOUNTER REFRIGERATOR, 1 SECTION (REF5P)

- Operating temperatures must be maintained within +/- 1°C (1.8°F) of settings.
- Must have an electronic keypad pad.
- Refrigerator capacity: minimum of 4.5 cu ft. internal storage
- The refrigerator must have dimension of H 34" X 23.75" W X 25.62" D.

REACH-IN UNDERCOUNTER FREEZER, 1 SECTION (FZR5P)

- Interior must have epoxy- covered wire shelves with customizable internal drawers & shelves.
- Alarm must have an audible and visual alarm display for temperatures out of range and power failure.
- Front ventilation, with a minimum of 4.5 cu ft. freezer internal storage.
- The freezer must have dimension of H 34” X 23.75” W X 25.62” D.
