The Superintendent is required to have SDS's of all hazardous materials on site. The Superintendent is required to maintain a Safety and Security plan. Plans need to be unique to the current project – No Generic Plans!

Throughout the specifications it talks about Quality Assurance – provide a QA plan! Quality Assurance also includes coordinating the site with your subs and scheduling them to do work. i.e. If your sprinkler sub puts his pipe where the VAV is supposed to go and makes it inaccessible for maintenance. To the VA, this is a coordination and quality assurance issue on the prime. Also, provide coordination drawings, to include elevations, sizes of duct work, pipes, conduits, VAV's, FCU's etc. Don't do the work then come back and tell us it doesn't work! Lack of Coordination and Quality Assurance only creates delays and needless change orders.

Neg Air Hepa Filters need to be cleaned once a week, if not more. Paths of egress need to be clear at all times. Sweep inside your construction site daily with sweeping compound. Insure sticky matts are available and changed regularly throughout the day. Contain construction waste before transport in a tightly covered container. Draping a cloth over the container is not acceptable - it must be secured to the cart. Insure that the outside of your construction site is free of dust and debris. This includes, to and from your construction site; i.e. the Freight Elevator, Corridors, Loading Dock and Dumpsters.

Need to know the Name of the Sub, Name of the Employee, Where and What they are Working on and the Duration of the Work. The daily log will include your full-time superintendent's time as well. Note: Daily logs are daily, not weekly! Payrolls must reflect what your daily logs say. You must provide payrolls and daily logs for everyday of the work week, even if there is no work.
