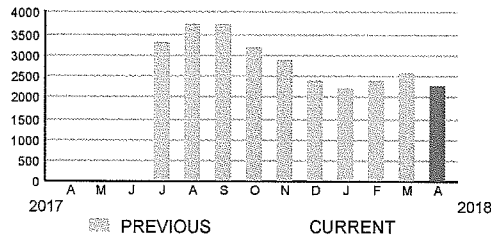

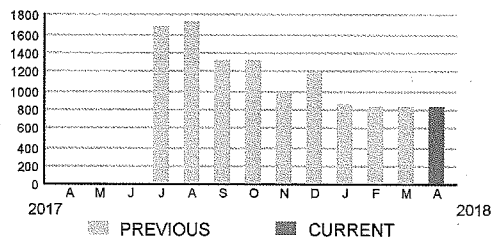
7 Electric Demand in kW

7 Electric Usage per 1000 kWh

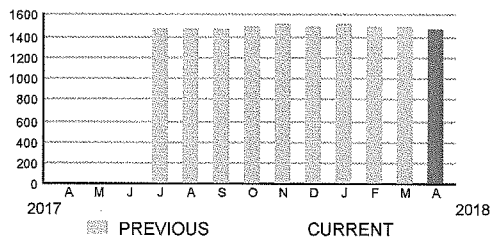

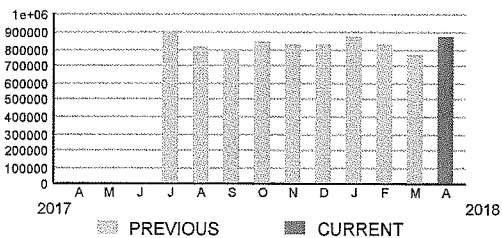
7 Electric Demand in kW

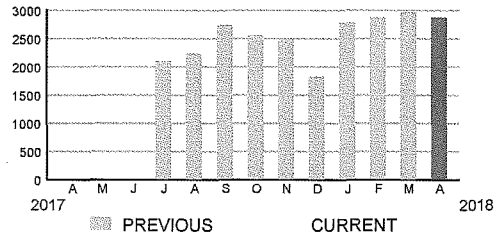

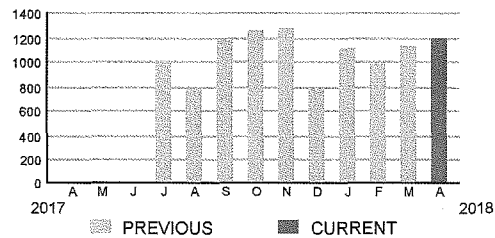
Electric Demand in kW

Electric Usage per 1000 kWh

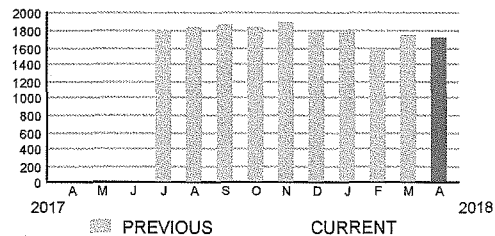

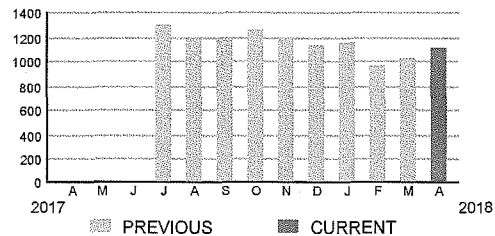
Electric Demand in kW

Electric Usage per 1000 kWh



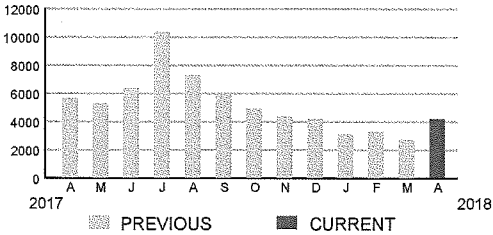

Water Usage in KGAL

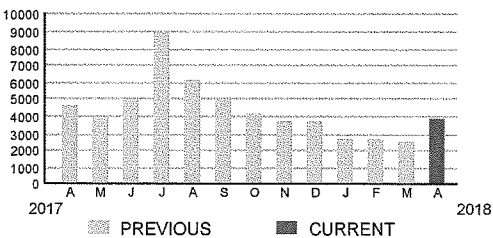

Water Usage in KGAL

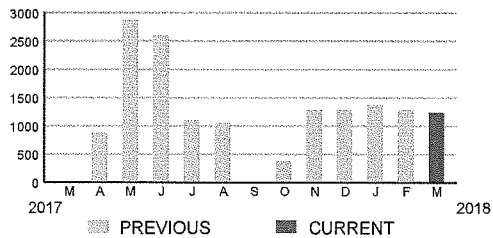

Reclaimed Water Usage in KGAL

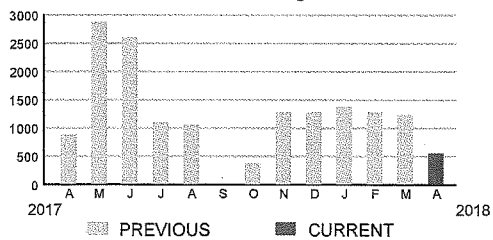

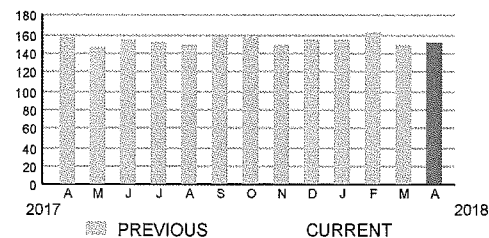

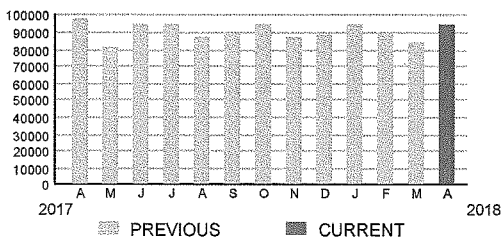
Electric Demand in kW
