(2). Contracting Officer Representatives (COR) and Alternate Contracting Officer's Representatives (Alt-COR) may be assigned to this contract. The COR and Alt-COR shall be provided specific written delegated authority by the CO, a copy of which will be provided to the Contractor.

(3). Ordering Officers may be authorized to place orders against this contract. The Contracting Officer will furnish the Contractor with the names of individuals authorized as ordering officers, by separate memorandum upon issuance of the contract. When ordering officers are added after award, the Contracting Officer will furnish the Contractor with the names of individuals authorized as ordering officers, by memorandum upon ordering officer appointment. Ordering officers are responsible for issuing and administering orders placed under this contract. Ordering officers have no authority to modify any term of this basic contract. Any deviation from the terms of the basic contract must be approved in writing by the Contracting Officer responsible for this

contract. The Contractor shall accept orders against this contract only from the Contracting Officer and/or authorized ordering officers. Fulfilling orders from persons other than the Contracting Officer or ordering officer may result in loss or delay in payment for supplies/services provided under such orders.

(g). **CHANGES TO THE CONTRACT:** No individual or activity has authority to ADD, DELETE, CHANGE, OR MODIFY this order except by the CO or by written authority specifically delegated by the CO.

(h). **CONTRACT TIME PERIOD:**

(1). The base contract period shall commence approximately **August 1, 2018** and expire **July 31, 2019**.

(2). At the discretion of the government, and in accordance with FAR Clause 52.217-9, Option to Extend the Term of the Contract, the contract may be extended four (4) one (1) year periods. Notice of an extension must be served in writing by the VA at least 10 days prior to the scheduled expiration date. An extension may be exercised subject to the continued acceptable performance and responsibility of the Contractor, the continued requirement for services, and the availability of funds.

(3). At the discretion of the government, and in accordance with 52.217-8, Option to Extend Services, the contract may be extended for up to six (6) months. Notice of an extension must be served in writing by the VA prior to the scheduled expiration date. The Contracting Officer may exercise the option by written notice to the Contractor within 10 days. The Government may choose to exercise the Extension of Services at the end of any performance period (base or option periods), utilizing the rates of that exercised performance period.

B.3 STATEMENT OF WORK (SOW)

(a) GENERAL INFORMATION:

(1) Title of Project: Sharps Medical Waste Disposal Services for the St. Louis MO VA Medical Center.

(2) Location: Services will be provided to both the Jefferson Barracks and John J. Cochran Divisions of the VA St. Louis Health Care System located at:

(3) Scope of Work: The Contractor shall provide all labor, materials and transportation necessary to provide Sharps Medical Waste Disposal Services for the St. Louis MO VA Medical Center in accordance with the following specifications, terms and conditions.

(4) Background: There are presently approximately 342 containers at John Cochran and 142 containers at Jefferson Barracks. The following table identifies historical data of the average number of container exchanges per month and the average container weight for each location.

| Division | Containers Exchanges/Month | Avg. Weight per Container |
|--------------------|----------------------------|---------------------------|
| John Cochran | 300 | 5.67 pounds |
| Jefferson Barracks | 75 | 4.38 pounds |

(5) Performance Period: The Contractor shall begin the work required under this SOW commencing with the effective date of award, unless otherwise directed by the CO, and shall provide continuous service until the date of contract expiration. Work at the VA Medical Center shall not take place on Federal holidays or weekends unless directed by the COR, AltCOR or the CO.

(6) Type of Contract: Firm-Fixed-Price.

(7) Extension of Contract: This contract may be extended for up to four (4) one (1) year option periods in accordance with FAR 52.217 9, Option to Extend the Term of the Contract, plus an additional six (6) months in accordance with FAR 52.217-8 – Option to Extend Services, at the discretion of the government. Notice of an extension must be served in writing by the VA prior to the scheduled expiration date. An extension may be exercised subject to the continued acceptable performance and responsibility of the Contractor, the continued requirement for services, and the availability of funds.

(b) SERVICES TO BE PROVIDED:

- (1) The contractor shall provide all sharps containers, mounting brackets, storage rack or containers and carts for interim storage and transport sufficient to meet VA St. Louis' current and future requirements. The brackets and carts furnished will be capable of holding any of the different size containers for use in all areas of the facility including Wards, clinics, Operating Room, Hemodialysis, etc. The products must meet all federal, state, OSHA and DOT standards for collection, storage and transport of medical waste/sharps. All mobile carts and bulk transport carts must have wheels and be in clean and good repair at all times. Minimum requirements for the reusable sharps containers are as follows:
 - (A) Reusable.
 - (B) Puncture proof.
 - (C) Pre-assembled.
 - (D) Leak proof.
 - (E) Overfill protection – swing tray tops for most units.
 - (F) Lockable.
 - (G) Sight/view port.
 - (H) Large access opening but with restricted hand access that will prohibit a child to adult from accessing the contents for most containers with an open top container for OR and other similar area uses.
 - (I) Multiple sizes, 2-gal, 4-gal, and 8-gal. as appropriate, based upon each collection locations projected volume.
 - (J) Able to be sanitized or sterilized
- (2) The contractor shall conform to all federal, state, and local regulations governing the providing of, transporting and disposal of sharps/medical waste.
- (3) The contractor is responsible for training medical center staff on the use, handling and care of the reusable sharps containers. Training will be documented and provided 24-7 during installation to ensure that training is available to all employees.
- (4) At the expiration of the contract, the contractor is responsible for the removal of their existing sharps containers and container brackets. The new contractor shall furnish sharps containers, container brackets, and shall install their wall brackets at no cost to the government. Wherever feasible the contractor will mount their wall brackets in the same location as the existing brackets being removed. All brackets must be securely mounted. Placement should be in accordance with industry standard ergonomic practices when possible.
- (5) The contractor is responsible for providing a manifest of all items picked up (number of containers and sizes) at the time of pick up to the Contracting Officer's Representative (COR) or his/her designee. A detailed destruction manifest of all medical sharps containers transported from the VA Medical Center to include the date of pick up, location and the weight of the content of the containers as well as the date and place of destruction is to be provided to the COR within thirty (30) calendar days of destruction.

- (6) The VA will be responsible for collecting all full containers and bringing them to the designated medical waste storage area. Waste pick up will be weekly at the John Cochran Division from the back-loading dock of Building 1, and monthly at the Jefferson Barracks Division from the loading dock of Building 93. The specific pick up day for JB is to be determined. A VA representative will need to verify the number and sizes of containers picked up at each collection. The full containers will be stored on shelving units or disposal containers that shall be provided by the contractor.
- (7) The Contractor will furnish on-site one-for-one replacement of full sharps containers with new sharps containers that are the same quantity, quality, and size as the collected full sharps containers, and are certified to have been cleaned/sterilized and are in proper working condition prior to delivery to the medical center (no signs of blood or body fluids or any other type of dirt). The Contractor will be responsible for unpacking the replacement sharps containers, removing all packing material from the premises, and placing the replacement sharps containers onto shelving units that shall be provided by the contractor.
- (8) The Contractor will provide a backup plan in the event circumstances disrupt their ability to provide pick up services. Remedial service will be provided within 24 hours of a failure to meet scheduled pick-up or delivery times.
- (9) Enough replacement sharps containers will be provided by the Contractor to maintain an on-site inventory sufficient to last until the next collection/replenishment period. The number of sharps containers supplied for inventory will meet the projected as well as the current needs of the VA. When additional mounting brackets are required or a certain size container's inventory is low or out, the Contractor will correct the deficiency within 24 hours of notification at no additional charge to the VA.
- (10) Pricing will be a firm-fixed-price per any size sharps container collected and disposed of. The manifest will show the type of shelving units (ex. 2 shelf, 3 shelf) or disposal containers picked up and the itemized list of the size and number of sharps containers on the shelving units or contained in the disposal container. A single invoice will be provided itemizing the collections for both divisions.

(c) GENERAL REQUIREMENTS.

(1) Hours of Coverage:

(A) The contractor will provide all required services within the normal business hours (7:00 AM to 4:30 PM (CST) M-F).

(B) All services shall be performed during these normal hours of coverage unless one of the following conditions exists:

- (i) The contractor wishes to furnish services at a time that is outside of the normal hours of coverage, at no additional cost to the Government, the contractor submits a request to the COR prior to the proposed start of the work, and the request is approved in writing by the COR before work is begun.
- (ii) The COR directs that the services be furnished at a time that is outside the normal hours of coverage and the additional cost is recommended by the COR and authorized by the CO.

(2) Federal holidays observed by the VA Medical Center:

New Year's Day

Labor Day

Martin Luther King Day Columbus Day
 President's Day Veteran's Day

(3) Point of Contact: The contractor shall appoint a point of contact that will have the responsibility to respond to customer needs in the performance of this contract. He/she will ensure emergent needs are appropriately addressed within 24 hours and non-emergent needs addressed within the normal delivery period specified by the contract.

(4) Quality Assurance/Assurance Control:

(A) The contractor shall have a quality control program in place to ensure the requirements of this contract are provided as specified. The program will include, but will not be limited to the following:

- (i) An inspection system covering the services listed in the Scope of Work. It must specify areas or work to be inspected on a scheduled basis.
- (ii) A method of identifying deficiencies in the quality of services performed before the level of performance becomes unacceptable which would include ensuring products delivered are clean.
- (iii) A record of all inspections conducted by the contractor and corrective action taken. These documents shall be made available to the Government during the contract.

(6) Required Contractor Reporting:

(A) The contractor is responsible for supplying, completing and submitting all reports required or requested by Federal, State or local ordinances, which pertain to any duties contained in the contract.

(B) All tasks accomplished by contractor personnel will be performed to preclude damage or disfigurement of govern-owned furnishings, fixtures, equipment and structures. The

contractor will report any damages caused by his/her agent and will be responsible for repairing or replacing to the VA's satisfaction. The government will not be held responsible for loss or damage to the contractor's equipment or belongings.

(7) Identification, parking, smoking and VA regulations:

- (A) Contractor's personnel shall wear visible identification at all times while on the premises of the VA. Identification shall include, as a minimum, the employee's name, position, and the contractor's trade name.
- (B) It is the responsibility of the contractor to park in the appropriate designated parking areas. Information on parking is available from VA Police Service. VA will not invalidate or make reimbursement for parking violations of the contractor under any conditions.

- (F) If warranted, an access badge will be given to the contractor's employee upon entrance into VA buildings. The contractor employee must safeguard the access badge and immediately report any lost, stolen, or destroyed badges to the COR. All contract personnel must properly display their access badges. Access badges must be worn at or above the waist (facing forward.). The contractor's employees must return the access badge(s) to the COR or designee at the end of each pick up process.
- (G) The contractor shall be required to comply with all security policies/requirements of the VA St. Louis. All security policies/requirements must be met and employees cleared prior to the contractor performing work under this contract. Employees that cannot meet the security and clearance requirements shall not be allowed to perform work under this contract. Employees may be required to attend or complete privacy training.

(8) English Language: The contractor will ensure that employees assigned to this contract possess basic proficiency in spoken and written English.

(9) Interference to Normal Function:

- (A) Contractor may be required to interrupt their work at any time so as not to interfere with the normal functioning of the facility, including utility services, fire protection systems, and passage of facility patients, personnel, equipment and carts.
- (B) In the event of an emergency, contractor services may be stopped and rescheduled at no additional cost to the government.
- (C) Contractor personnel shall inform the COR or the designee of the need to gain access to secured areas. If access is required to secure areas, prearranged scheduling will be made with COR or designee.

(10) CPARS. Required registration with Contractor Performance Assessment Reporting System (CPARS).

(A) As prescribed in Federal Acquisition Regulation (FAR) Part 42.15, the Department of Veterans Affairs (VA) evaluates Contractor past performance on all contracts that exceed the Simplified Acquisition Threshold (SAT) (presently \$150,000), and shares those evaluations with other Federal Government contract specialists and procurement officials. The FAR requires that the Contractor be provided an opportunity to comment on past performance evaluations prior to each report closing. To fulfill this requirement VA uses an online database, CPARS, which is maintained by the Naval Seal Logistics Center in Portsmouth, New Hampshire. CPARS has connectivity with the Past Performance Information Retrieval System (PPIRS) database, which is available to all Federal agencies. PPIRS is the system used to collect and retrieve performance assessment reports used in source selection determinations and completed CPARS report cards transferred to PPIRS. CPARS also includes access to the federal awardee performance and integrity information system (FAPIIS). FAPIIS is a web-enabled application accessed via CPARS for Contractor responsibility determination information.

(B) Each Contractor whose contract award is estimated to exceed the SAT will be provided CPARS access to review their report and for submitting comments, rebutting statements, or additional information. Access will be assigned to the email address of the person identified as the Contractor contact person in the Administration Section of the contract. It is the contractor's responsibility to update both the contact person's name and email address with the Contracting Officer if either change.

(C) For contracts with a period of one year or less, the contracting officer will perform a single evaluation when the contract is complete. For contracts exceeding one year, the contracting officer will evaluate the Contractor's performance annually. Interim reports will be filed each year until the last year of the contract, when the final report will be completed. The report shall be assigned in CPARS to the Contractor's designated representative for comment. The contractor will receive a CPARS-system generated notification when an evaluation is ready for comment. Contractors shall be afforded up to 14 calendar days from the date of notification of availability of the past performance evaluation to submit comments, rebutting statements, or additional information.

(D) The evaluations, including any contractor-submitted information (with indication whether agency review is pending), are automatically transmitted to PPIRS at <http://www.ppirs.gov>. not later than 14 days after the date on which the contractor is notified of the evaluation's availability for comment. Failure to provide a response will result in the Government's evaluation being placed on file in the database with a statement that the Contractor failed to respond.

(11) IT Security Requirements: IT Security requirement will not apply to this contract.

(12) Contract Attachments. The following attachment has been provided and is applicable to this contract:

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

- (6) State the form of relief requested; and
- (7) Provide all information establishing the timeliness of the protest.

(b) Failure to comply with the above may result in dismissal of the protest without further consideration.

(c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174).
