1. **Contracting Activity:** Department of Veterans Affairs, Network Contracting Office 16, VISN 16, Gulf Coast Veterans Health Care System.

2. **Nature and/or Description of the Action Being Processed:** This action is for justification for other than full and open competition for the procurement of brand name only, A-Dec dental examination chairs and related equipment. This action will be awarded as one (1) new, firm-fixed price purchase order.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** The Gulf Coast Veterans Health Care System's Joint Ambulatory Care Center in Pensacola, FL has a requirement to purchase A-Dec brand dental examination chairs and related equipment. The following equipment is to be procured:

5. Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):

The Gulf Coast Veterans Health Care System requires the purchase of A-dec brand dental examination chairs and related equipment, to replace existing chairs that have aged beyond their service life for the Joint Ambulatory Care Center facility in Pensacola, FL. The facility has existing A-dec dental chairs currently in use, parts and hand-pieces for specific use with the A-dec brand dental chairs, and VA personnel trained on the repair of these units. Therefore, the Gulf Coast Veterans Health Care System is requesting the procurement of brand name only equipment manufactured by A-dec Inc, for compatibility with existing equipment. The procurement of A-dec brand equipment allows for functional standardization throughout both facilities, the continued use of the spare parts and equipment inventory without the need to procure additional equipment, and the continued in-house maintenance of the dental chairs without having personnel retrained on repairing different brands. In the interest of standardization, new purchases of this equipment to be supported by the Gulf Coast Veterans Health Care System should be the same brand. Accordingly, A-dec brand equipment identified in Section 3 above, is the only equipment that can meet the Government's need without the Veteran's Health Administration experiencing substantial duplication of cost that could not be expected to be recovered through unrestricted competition and unacceptable delays in fulfilling its requirements.

The required Brand Named equipment is required to replace previously procured A-Dec Dental Equipment in use at the Gulf Coast Veterans Health Care System and its community base outpatient clinics.

The A-dec Units delivery systems units are used throughout VISN 16 for direct patient care and are compatible with the hand-pieces currently in use.

- 6. Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** To ensure that offers are solicited from as many potential sources as practicable, the Contracting Officer published Source Sought 36C25618Q9353 on FBO on March 26, 2018 for nine (9) days for the delivery and installation of Dental Equipment – chairs. Eight (8) responses were received. Responses were reviewed for the vendor's capability to provide the A-dec Brand name chairs and equipment, their socioeconomic status, and the vendors capability to meet the requires of the installation requirements of this procurement.

7. **Determination by the CO that the Anticipated Cost to the Government will be Fair and Reasonable:** The Contracting Officer has determined that the anticipated cost to the government will be considered fair and reasonable based on the competition resulting from the Brand Name Only SDVOSB Set-Aside solicitation that will be posted on FBO.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** As described in Section 6 above, market research, in accordance with FAR Part 10, was conducted by synopsis of the proposed acquisition, advising industry of the pending acquisition and soliciting inquiries from interested parties. The market research, which included a search on VIP, FBO, and FPDS. Sources Sought 36C25618Q9353 published to FBO resulted in two (2) Service Disabled Veteran Owned Small Business (SDVOSB), two (2) Veteran Owned Small Business, and one (1) large business concerns expressing interest in the acquisition and are capable of providing the requested items via the Open Market. A search on the VIP returned 80 SDVOSB/ and 11 VOSB entities matches using NAICS 339114 and key words, A-dec Dental Equipment. A search using key words, A-dec Dental Chair returned, 37 SDVOSB matches and seven (7) VOSB matches. A search on FPDS returned four (4) matches for the procurement of A-Dec chairs by the VA in FY18. The Contracting Officer contacted A-Dec, Inc., the manufacturer of the required equipment to determine authorized dealers or resellers of their products.
- Based on the above market research results, the VA Rule of Two in accordance with (IAW) 38 U.S.C. 8127 would be met by soliciting SDVOSBs as the Contracting Officer has a reasonable expectation that two or more small business concerns owned and controlled by veterans will submit offers and that the award can be made at a fair and reasonable price that offers best value to the Government.
9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** The Adec delivery systems units are currently used throughout VISN 16 for direct patient care and are compatible with the hand-pieces currently in use. The existing A-Dec equipment and accessories will be upgraded to meet the changing needs of the Veteran population Dental providers serve. The new equipment will support the continuity of care for providers as well as this will be a technology upgrade from prior vendor.
