**Q:** How much advanced notice of trips is usually provided? Section X states that trips will be communicated by 4:30pm on the day before pickup. Would it be possible to receive any early morning trips earlier than that for proper driver scheduling?

**A:** No, we don't know what the schedule is until that time ourselves. Attempting to send an earlier schedule would just result in changes being made later.

**Q:** Provide breakdown of trips performed by location for the most recent 12-month period for which information is available.

**A:** Trips are approximate:

- 240 trips in Jackson
- 240 trips in Flint
- 900 trips in Toledo
- 3000 trips in and around Ann Arbor.

**Q:** Indicate if any significant change is anticipated in the future.

**A:** The estimated units per year is the anticipated use per year. Currently, no significant change is expected.

**Q:** How many stretcher chair trips were performed by location for the most recent 12-month period for which information is available?

**A:** We have very limited stretcher chair use.

**Q:** Re IV, would it be possible to have a notice of contract award 30 days in advance of commencement of service?

**A:** Yes, this was addressed in Amendment 00002 to the solicitation under Changes to the Statement of Work, Statement of Work, Section IX.a. shall be amended to read: "The contractor shall be ready to perform in full compliance with all contract requirements within 30 business days of contract start date. The contractor shall submit specific

information on vehicles and drivers required for full performance at the time of offer submission.

**Q:** If we offer a prompt payment discount, would the value of the discount be considered in evaluating our pricing?

**A:** We cannot include prompt payment discounts in the evaluation of pricing.

**Q:** If volume discount(s) are offered, would the value of the discount be considered in evaluating pricing?

**A:** If a volume discount is offered, we will evaluate based on our estimated usage as advertised in the solicitation price schedule.

**Q:** Is it permissible to furnish different pricing for trips originating in cities other than Ann Arbor? Is it permissible to furnish different pricing for trips scheduled “off-tour”? Is it permissible to furnish different pricing for stretcher chair runs?

**A:** The pricing schedule provided is a template that is required for use. Deviation from the pricing schedule will skew government estimates of usage and may result in the inability to fairly evaluate your offer and possible rejection of the offer.
