1. **Contracting Activity:** Department of Veterans Affairs, Network Contract Office 12, Great Lakes Acquisition Center, 115 South 84<sup>th</sup> Street, Suite 101, Milwaukee, WI 53214.
2. **Nature and/or Description of the Action Being Processed:** Justification and approval for Other Than Full and Open Competition for the procurement for an Environmental Consulting Services, Indefinite Delivery, Indefinite Quantity contract at the Edward Hines Jr. VA Hospital (Hines), Hines, Illinois. Award of a new firm-fixed price contract is anticipated. This procurement will proceed on a sole source basis with Tropical Environmental, Inc. (Tropical). Estimated value of IDIQ is \$200,000.00. The intent of this procurement is to provide an Environmental Consulting Service for task orders that encompass asbestos abatement and miscellaneous hazardous material removal at the facility.
3. **Description of Supplies/Services Required to Meet the Agency's Needs:** Hines has a need for a licensed Environmental Consulting Service to provide sampling and Professional Industrial Hygienist services for monitoring, sampling, and noise monitoring, of asbestos abatement, lead abatement, mold remediation projects.

5. **Demonstration that the Contractor's Unique Qualifications or Nature of the Acquisition Requires the Use of the Authority Cited Above (applicability of authority):** Tropical Environmental, Inc is a CVE verified SDVOSB that is registered under the NAICS code 541620 – Environmental Consulting Services. They are one of only two companies located in the state of Illinois, licensed, ready to mobilize without prior notification, and able to meet the immediate needs of the Hines VAH. The other licensed company will be receiving an ACM abatement contract, thus making them ineligible.

6. **Description of Efforts Made to ensure that offers are solicited from as many potential sources as deemed practicable:** A search for Veteran-Owned Small-Businesses in Illinois, Indiana, and Wisconsin that are capable of providing these services was completed in VetBiz and SAM under NAICS code 541620 – Environmental Consulting. Seventeen (17) SDVOSB firms were identified in VIP, and forty (40) were identified in SAM. A further review of firms listed in Illinois revealed nine (9) in VIP and nineteen (19) in SAM. It was further discovered that there only two companies located in the state of Illinois that are capable of providing ACM abatement and/or monitoring services.
7. **Determination by the Contracting Officer that the Anticipated Cost to the Government will be Fair and Reasonable:** Rates will be established for various monitoring and sampling work elements. VISN 12 has utilized this type of contract and has historical cost information that will be utilized for cost comparisons. Additionally, cost proposals for individual task orders will be evaluated and negotiated to assure the cost will be fair and reasonable to the Government.
8. **Description of the Market Research Conducted and the Results, or a Statement of the Reasons Market Research Was Not Conducted:** Market Research was conducted for this requirement. A search for Veteran-Owned Small-Businesses under the NAICS code 541620 – Environmental Consulting, identified nine SDVOSB in Illinois. Further research revealed that of those nine companies, only two can or have performed the required abatement and/or monitoring services (Celtic Environmental and Tropical Environmental). While Celtic is a CVE verified Service-Disabled Veteran-Owned Small-Business (SDVOSB) as registered in VetBiz. It is the intent of the GLAC to award Celtic Environmental with a Sole-Source ACM Abatement Contract, thus creating a conflict of interest. It is this conflict that makes Tropical the only responsible source that can satisfactorily perform under the requirements of this contract. Tropical is determined to be a responsible source when background checks in SAM were performed as well as the capability to perform and obtain the necessary bonding and necessary Insurance Certification. Tropical meets the requirements under PL 109-461, which gives the contracting officer the authority for sole-source procurements to SDVOSB contractors.
9. **Any Other Facts Supporting the Use of Other than Full and Open Competition:** Satisfactory prior experience with VA utilizing Tropical will assist and contribute to the overall VISN goals for SDVOSB utilization. Tropical has performed successfully on several similar type ACM Abatement and Monitoring contracts in the past at the Hines VAJ.
