Description

This is a combined synopsis/solicitation for commercial items prepared in accordance with the format in Federal Acquisition Regulation (FAR) subpart 12.6, "Streamlined Procedures for Evaluation and Solicitation for Commercial Items," as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested, and a written solicitation document will not be issued.

This solicitation is a *request for quotations (RFQ)*. The solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition (FAC) FAC 2005-97 is effective January 24, 2018.

This procurement is a 100% SDVOSB set-aside and all eligible offerors are encouraged to submit quotes. Statement of Work

A. General

The Department of Veteran Affairs is seeking contractors to install one, Laars Magnatherm Gas Fired boiler as identified in this Statement of Work (SOW). The location is Lee County VA Healthcare Center, 2489 Diplomat Parkway East, Cape Coral, Florida 33909.

B. Scope of Work

1. Boiler will be provided by the VA and is currently located adjacent the intended installation site.
2. Contractor shall provide all demolition required for the removal of the existing boiler from the building. The Contractor shall drain, palletize, and secure the boiler for shipping by the customer.
3. The Contractor shall provide all labor, equipment, tools and supplies required to bring new boiler into the building and install it in place of original boiler.
4. Contractor will make all the necessary connections from the buildings systems to the boiler. These systems include hot water supply and return, all piping, insulation, natural gas connections, electrical, and Building Automation System (BAS) connections. All work shall be performed by Journeyman trade specific installers and or in the case of the BAS, manufacturer approved installers.
5. The boiler must also be connected to and programmed to function with the existing Johnson Controls Inc., Metasys building automation system.
6. Contractor will supply all labor, piping, valves, wires, circuits, fasteners and associated hardware and software necessary to connect to existing building systems. All work shall be inspected and must be accepted by the COR prior to submitting final payment. Functionality of all systems including BAS controls must be demonstrated.
7. Contractor shall provide start up, proper operation, water flow balancing, complete boiler testing and certification and on-site staff training prior to acceptance of work.
8. Debris Removal: Contractor shall clean up and dispose of all debris caused by installation, i.e. small screws, any glues, sealant, hazardous materials and related waste. Contractor shall perform a general sweep of the work area and ensure that no damage was done to any walls, frames, platforms and associated areas due to work performed.
9. Contractor shall provide a minimum of one-year warrantee on all work associated with this contract.

The Contracting Officer is the only person authorized to approve changes or modify any of the requirements under this contract. The Contractor shall communicate with the Contracting Officer on all matters pertaining to contract administration. Only the Contracting Officer is authorized to make commitment or issue changes that will affect price, quantity or quality of performance of this contract. In the event the Contractor effects any such change at the direction of any person other than the Contracting Officer, the change shall be considered to have been made without authority and no adjustment will be made in the contract price to cover any increase in cost incurred thereof.

52.237-2 - Protection of Government Buildings, Equipment, and Vegetation (Apr. 1984)

The Contractor shall use reasonable care to avoid damaging existing buildings, equipment, and vegetation on the Government installation. If the Contractor's failure to use reasonable care causes damage to any of this property, the Contractor shall replace or repair the damage at no expense to the Government as the Contracting Officer directs. If the Contractor fails or refuses to make such repair or replacement, the Contractor shall be liable for the cost, which may be deducted from the contract price.

52.246-4 - Inspection of Services -- Fixed-Price (Aug. 1996)

(a) *Definition:* "Services," as used in this clause, includes services performed, workmanship, and material furnished or utilized in the performance of services.

(b) The Contractor shall provide and maintain an inspection system acceptable to the Government covering the services under this contract. Complete records of all inspection work performed by the Contractor shall be maintained and made available to the Government during contract performance and for as long afterwards as the contract requires.

(2) Reduce the contract price to reflect the reduced value of the services performed.

(f) If the Contractor fails to promptly perform the services again or to take the necessary action to ensure future performance in conformity with contract requirements, the Government may --

(1) By contract or otherwise, perform the services and charge to the Contractor any cost incurred by the Government that is directly related to the performance of such service; or

(2) Terminate the contract for default.

(i) Not less than 51 percent of which is owned by one or more service-disabled Veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled Veterans or eligible surviving spouses (see VAAR 802.201 Surviving Spouse definition);

(b) General.

(1) Offers are solicited only from verified service-disabled Veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled Veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled Veteran-owned small business concern.
