B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes VAAR Clause 852.219-10, VA Total VA Notice of Total Service-Disabled Veteran-Owned Small Business Set- Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). The contractor is required to cooperate fully and make available any records as may be required to enable the CO to assess the contractor's compliance with the limitations on subcontracting or percentage of work performance requirement.

- SCHEDULING ARRANGEMENTS:** Except by special alternative arrangement, scheduled delivery will be provided only during Contractor's normal working hour's local site time. Upon acceptance of this contract, the Contractor shall immediately contact the Dental Service at 214-857-1086 or EXT 71086, to schedule mutually agreeable delivery times.

3. **SCOPE OF WORK:** Providing and installation of dental equipment/chairs in treatment room for the Bonham Dental Clinic (Sam Rayburn Memorial Veterans Center), 1201 E.9th St., Bonham, Texas 75418. Delivery activities shall consist of the following:

A. Delivery:

Client is responsible for receiving boxed equipment deliveries, inclusive of offloading, handling, and storage requirements and movement of goods to site if installation is provided. Undeliverable freight shipments may result in additional storage and handling costs at the client's expense. Client is responsible for disposal of all crating or packing materials with boxed deliveries unless specified in quote.

B. Installation.

All preparation necessarily required to ready the Dental Equipment/chairs for operation (installation and training) including:

- Placement of all items into specified location
- Assembly of all items per factory specifications and agency requirements.
- Anchoring of all items per factory specifications and agency requirements.
- Final air and vacuum connections.
- Calibration and function testing of equipment.
- Remove trash and packaging to a dumpster provided by owner unless otherwise specified in the purchase order.
- A walk-through with the owner and/or contractor will be completed noting any punch-list items.
- A "Customer Acceptance" sign-off letter will be requested upon completion.

The installation does not include:

- Final plumbing connection
- Final electrical connection
- Removing old equipment unless specified in the P.O.
- Transporting stored equipment to the clinic unless specified in the P.O.

C. Post installation inspection.

Dental service will verify required specifications, and testing will be performed as necessary to meet VA and vendor requirements.

The service team will provide all resources required to ensure a smooth transition, in accordance with the contract requirements.

4. DESCRIPTION OF EQUIPMENT:

- Multi-Position Armrests designed to allow easy access the dentist and the patient
- Chair Capacity Patient Load: 400lb (181 kg) maximum

5. DELIVERY DATES/PRODUCT LEAD TIMES:

- Equipment: 6-8 weeks

6. PROJECT DELAYS:

In the event that project delays beyond A-Dec's control impact the agreed upon delivery or installation date, the client must notify A-Dec prior to 21 days of the scheduled delivery date to modify logistics and scheduling. In an effort to meet customer needs, A-Dec will collaborate with the client to identify alternate delivery arrangements or offsite storage at client's expense. Deliveries and installations cancelled in less than 21 days are subject to additional charges associated with temporary storage/handling and mobilization expenses for the installation team. Site conditions that impede the scheduled installation (i.e., unfinished construction, incomplete utilities or safety issues) may necessitate installation delays or cancellation, resulting in additional charges to compensate for mobilization expenses.

7. WARRANTY:

A-Dec warrants all products against defects in material or workmanship for one year from time of delivery. A-Dec's sole obligation under the warranty is to provide parts for repair, or at its option, to provide the replacement product (excluding labor). The buyer shall have no other remedy in the breach of warranty action. In a breach of warranty action all special, incidental, and coincidental damages are excluded.

Written notice of breach of warranty must be given to A-Dec within the warranty period. The warranty does not cover damage resulting from improper installation or maintenance, accident, or misuse. The warranty does not cover damages resulting from use of cleaning, disinfecting, or sterilization chemicals and processes. The warranty also does not cover light bulbs. Failure to follow instructions provided in the A-Dec's owner's guide may void the warranty.

A-Dec warrants A-Dec dental chair cylinders; both lift and tilt, for ten years from the date of delivery of the chair or the cylinder. This warranty is retroactive to A-Dec chair cylinders already in that field. The warranty cover chair cylinders A-Dec finds to have manufacturing related irregularities. Stool cylinders are covered until A-Dec's one-year warranty.

8. **PERSONNEL CLEARANCES AND PRIVACY CONSIDERATIONS:** The Contractor will ensure that their personnel and subcontractor personnel meet the privacy standards as set forth by HIPPA (Health Insurance Portability and Accountability Act of 1996) with respect personal and confidential information that they may come upon, while servicing medical equipment.

9. **SECURITY REQUIREMENTS:**

The COTR and the Contractor will assure that-

1. No other information except what is in this contract will be shared with the contractor in any follow up communication.
2. None of the information in this contract includes Protected Health Information.
3. No memory device will be removed from the VA Facility without the approval of the Facility Information Security Officer (ISO).

Bio-Medical devices and other equipment or systems (workstations, copies, FAX, prints) containing media (hard drives, optical disks, etc.) with VA sensitive information must not be returned to the vendor during off site repairs, warranty period, at the end of lease, for trade-in, or other purposes. Vendor must accept the system without the drive;

4. Information made available to the contractor or subcontractor by VA for the performance or administration of this contract or information developed by the contractor/subcontractor in performance or administration of the contract shall be used only for those purposes and shall not be used in any other way without the prior written agreement of the VA. This clause expressly limits the contractor/subcontractor's rights to use data as described in Rights in Data General, FAR 52.227-14(d) (1).

No VA information shall be transferred outside of the VA.

5. The term "security incident" means an event that has, or could have, resulted in unauthorized access to, loss or damage to VA assets, or sensitive information, or an action that breaches VA security procedures. In such an event, the contractor/subcontractor shall immediately notify the COR and simultaneously, the designated ISO and Privacy Officer for the contract of any known or suspected security/privacy incidents, or any unauthorized disclosure of sensitive information, including that contained in system(s) to which the contractor/subcontractor has access.
6. Consistent with the requirements of 38 U.S.C. §5725, a contract may require access to sensitive personal information. If so, the contractor is liable to VA for liquidated damages in the event of a data breach or privacy incident involving any SPI the contractor/subcontractor processes or maintains under this contract.

10. INFORMATION SYSTEMS/MEDICAL DEVICE ACCESS:

The Contractor shall only have supervised access when necessary to VA systems/medical devices. The VA system administrator will monitor the activities of the Contractor and will be accountable for all of the actions taken by the Contractor. The COR is responsible for maintaining the security under the terms of this contract and shall immediately report security & privacy violations to Information Security Officer and Privacy Officer.

11. **DOCUMENTATION:** Contractor will provide the COR with individual written reports which describe the maintenance and repair service performed on the equipment in sufficient detail so as to be acceptable by field inspectors of the Joint Commission and other inspecting bodies. This shall include a list of all parts replaced, all service performed as well as a statement that the equipment is operating per manufacturer's specifications after repair. The service report will be signed by the contractor's service technician, and by designated VANTHCS personnel.

- a. Prior to award, bidder must have a facility to include personnel, test equipment, parts inventory, training certificates, licenses and technical documentation available for inspection by VA Medical Center personnel and be able to show written evidence to technical qualifications of personnel, test equipment (and

calibration documentation) licenses and availability of parts. Parts availability must be written documentation from either the equipment manufacturer or authorized parts supplier. In either case, bidder must be able to show the availability of parts to him/her within 24 hours after initial call. For contracts for maintenance and repair services from other than the original manufacturer or a designated representative, the Contractor will be fully responsible for obtaining all technical documentation necessary to fulfill contractual obligations.

b. The Contractor warrants that the services to be performed under this contract will be performed in a good workmanship manner and shall conform to the standards of the industry. This warranty is given expressly and in place of all other warranties, expressed or implied, statutory or otherwise, and is the only warranty given by the Contractor.

c. Warranty items that expire during the contract period will be added to the contract as appropriate.

12. NEGLIGENCE CLAUSE: When services and parts are required as a result of accident, abuse, misuse or negligence by other than the Contractor or his representative, and are not included as a part of PM inspection or service calls, such needs will be reported to the Contracting Officer's representative along with estimates of charges. The Contracting Officer and Representative will evaluate these needs and authorize appropriate action. The parts will be installed under the terms of the contract and each invoice is to include a legible itemized list of labor charges and parts costs. The government will incur no charges for service and parts including glassware due to accident, abuse, misuse or negligence by the contractor or his representative.

13. RECORDS MANAGEMENT STATEMENT:

All records (administrative and program specific) created during the period of the contract belong to VA North Texas Health Care System (VANTHCS) and must be returned to VANTHCS at the end of the contract or destroyed in accordance to the VHA Record Control Schedule (RCS)10-1.

1. Citations to pertinent laws, codes and regulations such as 44 U.S.C Chapter 21, 29, 31 and 33; Freedom of Information Act (5 U.S.C. 552); Privacy Act (5 U.S.C. 552a); 36 CFR Part 1222 and Part 1228.
2. Contractor shall treat all deliverables under the contract as the property of the U.S. Government for which the Government Agency shall have unlimited rights to use,

dispose of, or disclose such data contained therein as it determines to be in the public interest.

3. Contractor shall not create or maintain any records that are not specifically tied to or authorized by the contract using Government 'IT' equipment and/or Government records.
 4. Contractor shall not retain, use, sell, or disseminate copies of any deliverable that contains information covered by the Privacy Act of 1974 or that which is generally protected by the Freedom of Information Act.
 5. Contractor shall not create or maintain any records containing any Government Agency records that are not specifically tied to or authorized by the contract or identified in the RCS 10-1.
 6. The Government Agency owns the rights to all data/records produced as part of this contract.
 7. The Government Agency owns the rights to all electronic information (electronic data, electronic information systems, electronic databases, etc.) and all supporting documentation created as part of this contract. Contractor must deliver sufficient technical documentation with all data deliverables to permit the agency to use the data.
 8. Contractor agrees to comply with Federal and Agency records management policies, including those policies associated with the safeguarding of records covered by the Privacy Act of 1974. These policies include the preservation of all records created or received regardless of format [paper, electronic, etc.] or mode of transmission [e-mail, fax, etc.] or state of completion [draft, final, etc.].
 9. No disposition of documents will be allowed without the prior written consent of the Contracting Officer. The Agency and its contractors are responsible for preventing the alienation or unauthorized destruction of records, including all forms of mutilation. Willful and unlawful destruction, damage or alienation of Federal records is subject to the fines and penalties imposed by 18 U.S.C. 2701. Records may not be removed from the legal custody of the Agency or destroyed without regard to the provisions of the agency records schedules.
 10. Contractor is required to obtain the Contracting Officer's approval prior to engaging in any contractual relationship (sub-contractor) in support of this contract requiring the disclosure of information, documentary material and/or records generated under or relating to this contract. The Contractor (and any sub-contractor) is required to abide by Government and Agency guidance for protecting sensitive and proprietary information.
14. **END OF CONTRACT:** Contractor guarantees that all equipment covered in this contract shall meet or exceed manufacturer's performance specifications at the contract expiration date.

(2) "Service-disabled veteran" means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(i) Taxes are considered delinquent if both of the following criteria apply:

(A) *The tax liability is finally determined.* The liability is finally determined if it has been assessed. A liability is not finally determined if there is a pending administrative or judicial challenge. In the case of a judicial challenge to the liability, the liability is not finally determined until all judicial appeal rights have been exhausted.

(B) *The taxpayer is delinquent in making payment.* A taxpayer is delinquent if the taxpayer has failed to pay the tax liability when full payment was due and required. A taxpayer is not delinquent in cases where enforced collection action is precluded.

Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. Sec. 6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. 362 (the Bankruptcy Code).
