


- CONSTRUCTION GENERAL NOTES**
1. CONSTRUCTION WORK SHALL BE IN ACCORDANCE WITH CONSTRUCTION SEQUENCING NOTES, SHEET X-101.
 2. THE CONTRACTOR SHALL TAKE ALL NECESSARY PRECAUTIONS TO ASSURE NO DAMAGE OCCURS TO EXISTING STRUCTURES, TREES, AND UTILITIES THAT ARE TO REMAIN. THE CONTRACTOR SHALL BE RESPONSIBLE TO SECURE ALL ABOVEGROUND AND UNDERGROUND UTILITIES, INSTALL AND MAINTAIN ALL NECESSARY PROTECTION STRUCTURES, TREES, AND UTILITIES EVEN THOSE NOT INDICATED ON THE CONTRACT DRAWINGS RESULTING FROM CONSTRUCTION OPERATIONS SHALL BE REPAIRED AND/OR REPLACED AT NO ADDITIONAL COST TO THE OWNER.
 3. THE CONTRACTOR SHALL BE RESPONSIBLE FOR OBTAINING NECESSARY UTILITIES TO REMAIN IN PLACE, INCLUDING ANY UTILITIES NOT INDICATED ON CONTRACT DRAWINGS.
 4. ALL AREAS ADJACENT TO THE SITE SHALL BE MAINTAINED IN A CLEAN CONDITION, MUD AND DIRT FREE AT ALL TIMES.
 5. THE CONTRACTOR SHALL ENSURE THAT WORK PERFORMED UNDER THIS CONTRACT SHALL NOT INTERFERE WITH THE OPERATION OF ANY EXISTING PUBLIC OR PRIVATE UTILITIES OR SERVICES. THE CONTRACTOR SHALL BE RESPONSIBLE TO SECURE ALL ABOVEGROUND AND UNDERGROUND UTILITIES, INSTALL AND MAINTAIN ALL NECESSARY PROTECTION STRUCTURES, TREES, AND UTILITIES EVEN THOSE NOT INDICATED ON THE CONTRACT DRAWINGS RESULTING FROM CONSTRUCTION OPERATIONS SHALL BE REPAIRED AND/OR REPLACED AT NO ADDITIONAL COST TO THE OWNER.
 6. CONTRACTORS SHALL SEQUENCE WORK AS NECESSARY TO ENSURE THAT ALL UTILITIES SERVICES, INCLUDING FIRE HYDRANTS, REMAIN OPERATIONAL DURING CONSTRUCTION.
 7. CONTRACTOR SHALL PRESERVE AND PROTECT EXISTING TREES AND SHRUBS. TREES DAMAGED BY CONSTRUCTION OPERATIONS SHALL BE REPLACED WITH A TREE OF THE SAME SPECIES AND SIZE. IF SIZE OF EXISTING TREE IS NOT AVAILABLE CONTRACTOR SHALL REPLACE WITH A 2" CAL. TREE (OCCURDUS) FOR THE MONETARY DIFFERENCE IN VALUE. ANY SHRUBS DAMAGED BY CONSTRUCTION OPERATIONS SHALL BE REPLACED BY A SHRUB OF THE SAME OR SIMILAR SPECIES AND SIZE. ANY SHRUBS DAMAGED BY CONSTRUCTION OPERATIONS SHALL BE REPLACED WITH A 1 1/2" CAL. SHRUB AND SHALL PROVIDE A CREDIT TO THE OWNER FOR THE MONETARY DIFFERENCE IN VALUE.
 8. CONTRACTOR SHALL PRESERVE AND PROTECT EXISTING TURF DESIGNATED TO REMAIN. EXISTING TURF SHALL BE REPLACED WITH 500 TO MATCH EXISTING SPECIFICATIONS SECTION 32 92 00.
 9. IF ADDITIVE ALTERNATE #1 IS NOT ACCEPTED, CONTRACTOR SHALL INSTALL 1" BELOW TOP OF ADJACENT CONCRETE, CONTRACTOR SHALL EXTEND 8" HI. SPHEREN WALL TO EDGE OF EXISTING BUILDING WALL AS SHOWN.
 10. IN THE EVENT THAT BONES OR HISTORIC ARCHAEOLOGICAL REMAINS ARE UNCOVERED DURING CONSTRUCTION OR EARTH-DISTURBING ACTIVITIES, CEASE WORK IMMEDIATELY AND NOTIFY THE DIRECTOR AT SANTA FE NATIONAL CEMETERY. THE OWNER WILL CONTACT THE NEW MEXICO HISTORIC PRESERVATION DIVISION (SNHP) TO DETERMINE THE APPROPRIATE ACTION TO BE TAKEN BY THE OWNER.


