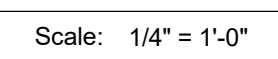
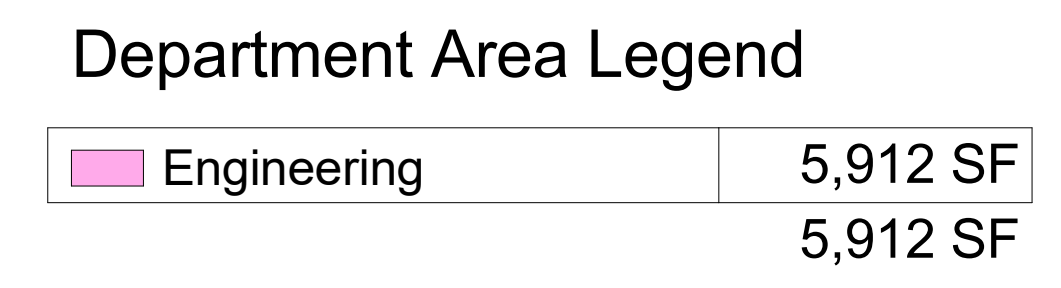
THIRD FLOOR PLAN
