B.3 STATEMENT OF WORK

Background:

The Sterile Processing Service is responsible for reprocessing and sterilizing reusable medical equipment (RME), medical scopes, and medical instruments at Tibor Rubin VA Medical Center in Long Beach, CA. Presently, there are many surgical/clinical instrument trays that have many instruments that don't always get used. This current practice contributes to wasted resources/cost to the government to reprocess unused instrumentation.

Objectives:

To provide quality service in downsizing instrumentation in surgical/clinic instrument trays, and fostering a learning environment in tackling new tray assembly processes.

Scope:

The vendor provides:

- Experience with working alongside medical facilities.
- Shall be able to wear personal protective equipment as needed to include: gowns, booties, gloves, hair/beard covers, face shields, etc.
- Shall offer an invoice of services to appropriate contracting channels/personnel.
- Shall always ensure expensive RME, medical scopes, and instruments are handled professionally.
- Shall work with sterile processing service (SPS) Chief, other SPS employees and operating room employees to determine best Surgical Asset Management (SAM) set optimization strategies.
- Shall foster a learning environment by providing surgical/clinical tray management processes. Management processes include: downsizing instrumentation from overcrowded trays, providing guidance on assembling functional surgical/clinic trays and assisting in reducing wasted resources by eliminating unused instrumentation from surgical/clinical trays.
- Shall provide updated count sheets, listing all instrumentation per tray, for each modified surgical/clinical instrument tray.
- Shall provide a finalized report on all changes made to each surgical/clinical instrumentation tray to the Sterile Processing Service.
- Shall provide their own asset management software and technology to accomplish the Surgical Asset Management optimization of instrument trays.

Normal Working Hours:

Contractor personnel shall be available to perform services during regular work hours.

Regular Work Hours:

6:30am – 12:00am

SECTION C - CONTRACT CLAUSES

C.1 VAAR 852.203-70 COMMERCIAL ADVERTISING (JAN 2008)
