This solicitation includes VAAR 852.219-10, VA Notice of Total Service-Disabled Veteran-Owned Small Business Set-Aside. STATEMENT OF WORK (SOW)

**Chemical Hazardous, Universal Waste and Recyclables Disposal Services
For**

**Central Texas Veterans Health Care System (CTVHCS)
Temple and Waco, TX**

I. GENERAL INFORMATION

A. Background:

1. Contractor shall provide RCRA hazardous and universal waste, and recyclables disposal to include manifesting, packing, removal, transportation, disposal, and/or treatment to the Central Texas Veterans Health Care System (CTVHCS).
2. This contract is for services located at the following facilities:

1901 Veterans Memorial Drive
Temple, TX 76504

Doris Miller VAMC
4800 Memorial Drive
Waco, TX 76711

B. Scope of Work:

1. The contractor shall provide the following services on a **quarterly** basis
 - 1.1. Contractor shall furnish all necessary transportation, labor, supervision, supplies, and equipment to pick-up and dispose of all RCRA hazardous waste, universal waste and recyclables that accumulates over a previous three-month period.
 - 1.2. Contractor shall furnish all packing and shipping containers and maintain an adequate number of packing and shipping containers to include proper fitting lids for use. These packing and shipping containers are used for transporting the hazardous and universal waste to an Environmental Protection Agency (EPA), or Texas Commission on Environmental Quality (TCEQ) approved treatment, disposal or recycling facility. All packing and shipping containers provided shall meet or exceed current Department of Transportation (DOT) regulations and standards.
 - 1.2.1. Contractor shall provide supplies and equipment necessary to prevent and clean up accidental spills during the collection, packaging and transfer of hazardous and universal waste.
 - 1.2.2. Contractor shall clean up any spilled material during collection, packaging and transfer of hazardous and universal waste back to background levels prior to the spill or to the satisfaction of the CTVHCS.

- 1.3. An EPA and/or TCEQ approved hazardous waste manifest and/or bill-of-lading shall be completed prior to departure when hazardous and universal wastes are picked up.
- 1.4. Should the Contractor ever detect unknown hazardous chemicals, they shall immediately report the finding to the Contracting Officer Representative (COR) and work with the facility regarding security, holding or return of any packing and shipping container found to contain an unknown hazardous chemical waste.

2. REGULATORY COMPLIANCE:

- 2.1. The Contractor shall coordinate marking, packaging, and provide proof of destruction and/or recycling to the CTVHCS for hazardous and universal wastes in strict accordance with all local, state, and federal laws within 45 days of initial shipment of waste. The Contractor shall provide documentation as requested by the CTVHCS to ensure regulatory compliance with EPA, TCEQ, DOT, and OSHA, etc. related to this contract.
- 2.2. The Contractor's services, as required by this contract, shall be in accordance with all Department of Transportation (DOT), (EPA), (TCEQ) and applicable Federal, State and Municipal governmental regulations and codes that are applicable, but different in scope, are to be all complied with and shall be strictly adhered to, shall include:
 - 2.2.1. Contractor shall sign, date, and furnish a copy of the hazardous waste manifest and/or bill-of-lading prior to any hazardous and universal waste leaving the pickup site. Contractor shall deliver the hazardous and universal wastes to an authorized treatment, disposal and/or recycling facility.

3. PERMITS/LICENSURE:

- 3.1. The Contractor shall be registered with the Texas Commission on Environmental Quality (TCEQ) and possess the necessary registrations, licenses and or permits necessary to perform the services.
- 3.2. The Contractor shall notify the COR of any change or alteration to their permits and licenses for facilities, (including but not limited to waste treatment, storage, disposal or recycling sites), or for any change in status which may affect performance.

C. **Performance Period:** 6 -month Base Year and (4) 1-year Option Periods.

D. Types and Quantities of Material:

1. **NOTE:** The Temple and Waco VA locations are classified as Large Quantity Generators, based on the monthly amounts of Pharmaceutical P-waste accumulation (primarily nicotine).

2. This pickup may contain the following waste streams:
- Various RCRA hazardous waste originating from research chemicals in small quantities.
 - Universal Waste (lamps, bulbs, paint)
 - Toxic (Mitomycin, Phenol, Cyclophosphamide)
 - Ignitable (Ethanol, Methanol, Xylenes, aliphatic hydrocarbons)
 - Corrosives (acids, bases)
 - Acutely Hazardous (warfarin, epinephrine, nicotine).
 - Compressed gas cylinders (propane, Nitrous oxide)
 - Non-regulated Material (excess cleaners, detergents, etc.)
3. **ESTIMATED MAXIMUM QUANTITY** of Waste per pick up (**Quarterly**):
- **Chemical Hazardous Waste:** 2,300 pounds - Temple
300 pounds - Waco
Total Chemical Hazardous Waste Estimate: **2,600 Pounds (10,400 lbs per year – 4 pickups)**
 - **P-Listed Hazardous Waste** (Temple & Waco combined): **500 pounds (2,000 lbs per year – 4 pickups)**
 - **Universal Hazardous Waste:** (fluorescent light bulbs, Paint and Paint related products)

Temple: 2000 Pounds
Waco: 1000 Pounds

Total: **3,000 Pounds (12,000 lbs per year – 4 pickups)**
 - **Non-Regulated Waste (oil-in-water, oil sorbent, etc.):** **800 Pounds (3200 lbs per year – 4 pickups)**
 - **Recyclables** (Temple and Waco Combined) – Batteries (lead, nicad, nickel halide, lithium): **1400 Pounds (5600 lbs per year – 4 pickups)**

II. GOVERNMENT HOLIDAYS:

- A. Contractor shall schedule pickup based on mutually agreeable time between the federal government and the contractor; within normal business hours, and not on weekends or holidays.

- C. When a holiday falls on a Sunday, the following Monday shall be observed as a legal holiday by U.S. Government agencies. When a holiday falls on a Saturday, the preceding Friday shall be observed as a legal holiday.
- D. It is understood and agreed between the Government and the Contractor that observance of such days by Government personnel shall not otherwise be a reason for an additional period of performance, or entitlement of compensation. In the event the Contractor's personnel work during the holiday, they may be reimbursed by the Contractor, however, no form of holiday or other premium compensation will be reimbursed either as a direct or indirect cost, other than their normal compensation for the time worked.

(d) The successful bidder must present to the Contracting Officer, prior to award, evidence of general liability insurance without any exclusionary clauses for asbestos that would void the general liability coverage.

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans or eligible surviving spouses (see VAAR 802.201 Surviving Spouse definition);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document;

(iv) The business has been verified for ownership and control pursuant to 38 CFR 74 and is so listed in the Vendor Information Pages database, (<https://www.vip.vetbiz.gov>); and

(v) The business will comply with subcontracting limitations in 13 CFR 125.6, as applicable

(2) “Service-disabled veteran” means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB as appropriate.

- (9) Acknowledgment of Solicitation Amendments;
- (10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and
- (11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.
