5. Rational/explanation to support cited authority:

The unique situation with regards to the volume of records and the time and resources required to move the records justify maintaining services with Sourcecorp is the most reasonable determination based on: 1) the legal requirements aforementioned within 36 CFR 1220 and 36 CFR 1234 for National Archives and Records Administration (NARA) approval of Commercial Records Storage Facilities for storage of Federal Agency Records, 2) the time required to search out, certify and submit vendors for NARA approval is not feasible to realistically procure the required services in a timely and efficient manner, 3) Sourcecorp currently stores approximately 6,000 sqft. of documents with the VA under the previous contract moving the records from the Sourcecorp facility to another NARA approved facility would cost an estimated \$12,000.00 excluding any shipping costs. 4) the Sourcecorp CRSF location is less than 100 miles from the Records Pick-up points for the Northern California Veteran Affairs Healthcare System with the only in state other option for NARA approved storage is over 450 miles away (Iron Mountain, Redlands CA) which would require excessive travel costs for minor records.

6. Note that this determination satisfies the requirements of [FAR 8.405-6](#). The requirement to prepare a written justification [IAW FAR 6.303](#) does not apply to Federal Supply Schedules.
