B.2 STATEMENT OF WORK (SOW)

Landscape Beds – Ann Arbor VA Medical Center

1. Work to be performed:
 - a. The contractor shall remove existing and install new landscape beds at the following locations:
 - i. Main Entrance Sign on Fuller Road.
 - ii. Sign at the Corner of Fuller Road and Fuller Street.
 - b. Landscapes shall be based on the designs provided by the government in this solicitation (see attached). Designs portray the “Rosetta Outcropping Collection” with shrubs and perennials. Similar collections are acceptable (provide details). Minimum requirements are:
 - i. Maximum wall heights of 18” exposed above ground level. Wall heights may vary.
 - ii. All stones forming walls shall be a minimum thickness of 6”.
 - iii. Joints shall be staggered.
 - c. New poly edged perimeters shall be installed around the renovated area.
 - d. All bed areas shall be dressed with a minimum of 3” of landscape stone (e.g. river rock, egg stone).
 - e. All landscape beds shall have soil returned to its’ original condition or better.
 - f. Adjacent areas to landscape bed shall be returned to original condition or better (i.e. topsoil, fertilizer, seed, etc.)
2. All services provided shall comply with all local, federal, and Ann Arbor VA laws, policies and laws.
3. The contractor shall report to the Grounds and Transportation Office located at the Ann Arbor Veterans Affairs Medical Center to log in during normal working hours (0600-1700). This check in is mandatory. The contractor shall document services rendered on a legible field service report that is to be provided to and signed by the Grounds and Transportation Supervisor.

appropriations acts (and as extended in continuing resolutions), Government agencies are not permitted to use appropriated (or otherwise made available) funds for contracts with an entity that requires employees or subcontractors of such entity seeking to report waste, fraud, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

(2) The prohibition in paragraph (u)(1) of this provision does not contravene requirements applicable to Standard Form 312 (Classified Information Nondisclosure Agreement), Form 4414 (Sensitive Compartmented Information Nondisclosure Agreement), or any other form issued by a Federal department or agency governing the nondisclosure of classified information.

(3) Representation. By submission of its offer, the Offeror represents that it will not require its employees or subcontractors to sign or comply with internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting waste, fraud, or abuse related to the performance of a Government contract to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information (e.g., agency Office of the Inspector General).
