This solicitation includes VAAR 852.219-11 VA Notice of Total Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. B.4 STATEMENT OF WORK

Objective:

The objective of this proposal is to coach (advisory and assistance) facility senior leaders in the implementation of a comprehensive lean management program with these specific aims:

- To assist leaders in driving lean strategy deployment throughout the organization.
- To assist leaders in developing well-coordinated improvements in every administrative and clinical process in the organization with measurable improvements in quality, safety, cost, access and satisfaction, coaching leaders in implementation of value stream mapping, improvement workshops, leader standard work and daily accountability meetings
- To assist leaders in developing standardization of processes specifically related to SAIL (Strategic Analytics for Improving and Learning) clinical initiatives resulting in improved benchmarked quality.
- To assist leaders in developing a service culture through process improvement that supports achievement of Veteran Centered Care principles.

Tasks (required to achieve the above objectives):

The Contractor shall provide all labor, transportation and materials to implement a comprehensive executive coaching model for lean healthcare transformation. The implementation of the coaching model will encompass quad members and other senior leaders, in all patient care delivery and support departments of the Detroit VA Medical Center. Total business days per year is approximately 28-32 depending on the structure of the training developed for the quarterly oversight sessions. This requirement is for coaching sessions for VA personnel only; training certification (certificate of completion) is not required for VA employees. This is an advisory and assistance contract. No Government furnished equipment will be provided.

1. The Contractor shall work with facility leaders to create a strategy deployment plan that specifically develops lean literacy among all leaders and facilitates the engagement of all facility staff in daily process improvement that supports strategic goals. Deployment plan must outline the following:
 - a. Where to start and end the Lean Deployment
 - b. How to track progress of Lean program.
 - c. How to track financial benefits of Lean program
 - d. How to achieve customer centricity in key process through Lean deployment.
 - e. How to achieve results and continuously improve them.
2. The Contractor shall conduct once every quarter, facilitation and oversight sessions lasting 1-2 business days (8-16 hours) designed to teach the lean deployment focused on the development of the executive's skills in meaningful strategic deployment using available management tools as well as those specific to lean. Sessions must be limited to 10 participants.
3. The Contractor shall guide the pre-work and facilitate a structured process to utilize key facility performance metrics in order to identify and sequence the transformative improvement of clinical and administrative value streams combined with the development of all leaders towards continuous daily improvement and leader standard work. Current performance metrics will be made available after award to assist in development of the training.
4. The Contractor shall provide, twice a month, coaching and facilitation services to executive sponsors, process owners, and systems redesign staff to prepare them to effectively prepare for and execute RPIW (Rapid Process Improvement Workshop) events and subsequently drive sustainment of the improved results. The coaching sessions are for approximately ninety (90) key leadership personnel and shall be conducted as 8-hour sessions twice a month. This training may vary depending on the project if the 90 personnel will be met as one group or in small groups (shadowing in departments) throughout 8 hour day. Note: Detroit VAMC has previously identified and internally developed project objectives. This information will be shared upon award.

5. Coach leaders in methods and content to allow leaders to coach supervisors and staff in sustaining improved results through development of standard work, daily accountability meetings related to the specific improvement, other tiered accountability meetings with higher levels of leadership

Hours of Performance and Response Time: The Contractor shall be on station for the requested timeframes each month (based on scheduling with the teams that they are assigned to work with, per the Chief Quality and Performance, and the facility director) and shall be available during normal working hours M-F 8-4:30 (est.) for assistance. The Contractor shall respond to all calls from Detroit VA Medical Center personnel within 2 hours, and if requested, shall present themselves on site at the Detroit VA Medical Center within 3 days. Email responses must be completed within 2 business days of email submission.

Required Reports & Documents: The Contractor shall submit a detailed monthly report as to what item(s) and tasks were completed which shall be submitted within five (5) business days after the beginning of each month (or the 5th day of the month)

Contractor Conduct, Identification and Customer Service: The Contractor and their employees shall at all times conduct themselves in a professional manner, maintain personal hygiene, and wear clean, neat uniforms with Employee IDs in clear view above the waist.

C.1 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 15 days of contract expiration.

(End of Clause)

C.2 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 2000)

(a) The Government may extend the term of this contract by written notice to the Contractor within 15 days of contract expiration; provided that the Government gives the Contractor a preliminary written notice of its intent to extend at least 60 days before the contract expires. The preliminary notice does not commit the Government to an extension.

(b) If the Government exercises this option, the extended contract shall be considered to include this option clause.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed five (5) years.

C.3 VAAR 852.203-70 COMMERCIAL ADVERTISING (MAY 2018)

The Contractor shall not make reference in its commercial advertising to Department of Veterans Affairs contracts in a manner that states or implies the Department of Veterans Affairs approves or endorses the

Contractor's products or services or considers the Contractor's products or services superior to other products or services.

C.4 VAAR 852.219-11 VA NOTICE OF TOTAL VETERAN-OWNED SMALL BUSINESS SET-ASIDE (JUL 2016)(DEVIATION)

(a) *Definition.* For the Department of Veterans Affairs, "Veteran-owned small business or VOSB."—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans;

(ii) The management and daily business operations of which are controlled by one or more veterans;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document;

(v) The business will comply with subcontracting limitations in 13 CFR 125.6, as applicable

(2) "Veteran" is defined in 38 U.S.C. 101(2).

(b) *General.*

(1) Offers are solicited only from verified veteran-owned small business concerns. All service-disabled veteran-owned small businesses are also determined to be veteran-owned small businesses if they meet the criteria identified in paragraph (a)(1) of this section. Offers received from concerns that are not veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified veteran-owned small business concern.

(c) *Agreement.* A veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a veteran-owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB and/or VOSB as appropriate.

(b) *Electronic payment requests.* Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

He/she shall be responsible for any injury to himself/herself, his/her employees, as well as for any damage to personal or public property that occurs during the performance of this contract that is caused by his/her employees fault or negligence, and shall maintain personal liability and property damage insurance having coverage for a limit as required by the laws of the State of Michigan. - (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
- (2) Are conducted pursuant to specific authorization from the Office of Foreign Assets Control in the Department of the Treasury, or are expressly exempted under Federal law from the requirement to be conducted under such authorization;
- (3) Consist of providing goods or services to marginalized populations of Sudan;
- (4) Consist of providing goods or services to an internationally recognized peacekeeping force or humanitarian organization;
- (5) Consist of providing goods or services that are used only to promote health or education; or
- (6) Have been voluntarily suspended.

“Sensitive technology”—

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

Service-disabled veteran-owned small business concern—

(1) Means a small business concern—

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans; and

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran.

(2) Service-disabled veteran means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

Small business concern means a concern, including its affiliates, that is independently owned and operated, not dominant in the field of operation in which it is bidding on Government contracts, and qualified as a small business under the criteria in 13 CFR Part 121 and size standards in this solicitation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

Women-owned small business (WOSB) concern eligible under the WOSB Program (in accordance with 13 CFR part 127), means a small business concern that is at least 51 percent directly and unconditionally

owned by, and the management and daily business operations of which are controlled by, one or more women who are citizens of the United States.
