### **STATEMENT OF WORK**

#### **FOR**

#### **Tester Hearing Aid – GSI CORTI Otoacoustic Emissions**

**General:** This GSI CORTI Otoacoustic Emission Hearing Aid Testing system is a combination Distortion Product Otoacoustic Emissions, (DPOAE) and a TEOAE system. This equipment is a standard and critical tool in examination protocols for the Audiologist. It is a portable and screening unit and needs no patient response for evaluation. Used in differential diagnosis of auditory pathology this system is employed to measure with great accuracy the hearing acuity or condition of the Cochlear (Inner Ear).

In cases of Non-Organic hearing loss or a malingerer, this system can accurately measure the condition of the Cochlea without behavioral responses from the patient. In cases such as dementia and an unconscious patient this device can create an examination environment promoting the ability of the Audiologist to determine management of these cases.

In the case of a nonorganic hearing loss, or a malingerer, the GSI CORTI can quickly assess the condition of the Cochlea providing accurate data. This empowers the Audiologist with objective data to manage the difficult patient. Thus, it saves vast amount of provider time during an examination.

**Description of work:**

Item will be delivered to the warehouse Audie L. Murphy (ALM) Veterans Affairs Hospital, 7410 Merton Minter Road, San Antonio Texas 78229 for inspection by Biomedical Engineering. The item will then be delivered to Data Point Outpatient clinic for use in the Audiology Clinic.

**Hours of Performance:** Delivery to occur between 8:00 am and 4:00 pm during non-Federal Holidays.

**Check in Requirements:** N/A

**Period of Performance:** N/A

**Place of Performance:** Item will be used at the Data Point Audiology Clinic and at the Frank Tejada Audiology Compensation and Pension section.

**Contracting Officer Technical Representatives:** Prior to contract award, the Contracting Officer shall coordinate with the COR the acceptability of the items to ensure that they meet agency requirements. Once a selection has been made, the COR will ensure acceptable delivery and receipt of the item.

**Information Technology Security Requirements:** The item will only be delivered to ALM Hospital by the representatives of the Vendor. No use of VA information systems will take place.

**Information Systems Officer, Information Protection:** The contractor will not have access to VA Desktop computers nor will they have access to online resources belonging to the government while conducting services.

**Privacy Officer:** The contractor will not have access to Patient Health Information (PHI) nor will they have the capability of accessing patient information during the services provided to the VA.

**Safety Requirements:** In the performance of this contract, the Contractor shall take such safety precautions as the Contracting Officer may determine to be reasonably necessary to protect the lives and health of occupants of the building. The Contracting Officer shall notify the Contractor of any safety issues and the action necessary to correct these issues. Such notice, when served to the Contractor or his representative at the work site shall be deemed sufficient for the corrective actions to be taken. If the Contractor fails or refuses to comply promptly, the Contracting Officer may issue an order stopping all or part of the work, and hold the Contractor in default.

(ii) Establish exactly what the bidder proposes to furnish and what the Government would be binding itself to purchase by making an award. The information furnished may include specific references to information previously furnished or to information otherwise available to the purchasing activity.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.
