Debakey Medical Center located at 2002 Holcombe Blvd, Houston, TX 77030. The container will be used to store pest control sprays. The Contractor shall furnish all materials, parts, equipment, tools that completes the installation of the storage container. Contractor shall certify that the container is installed properly and safely and ready for use. Contractor must provide documentation that their company has worked on the equipment specified at the beginning of this document. Following the service and part(s) replacement, contractor must demonstrate to the Contracting Officer Representative (COR) or designee that the container is installed and functioning properly and to standard properly according to manufacturer specifications. The contract price shall be firm-fixed, all-inclusive, and not limited to specified products/equipment, installation, and setup/configuration.

 - b. **Please note that VA is particularly interested in determining the availability of Small Business Manufacturers.** If your company is a small business manufacturer of similar items, please respond to this RFI.
