STATEMENT OF WORK

DaVinci Xi Surgical System (Surgical Service)

PURPOSE:

To purchase HT/HC equipment via VISN17 Approval and funding, specifically DaVinci Xi Surgical System.

SCOPE OF WORK:

Delivery of the DaVinci Xi Surgical System to Logistics Service at S.T.V.H.C.S. 7400

Merton Minter Blvd, San Antonio, Texas, 78229. Delivery shall be scheduled through Logistics Service at S.T.V.H.C.S. prior to shipment. Vendor shall provide all preparation necessarily required to ready implementation of the DaVinci Xi HD Surgical System for surgical operations. Preparations shall include Set up of equipment and training for Surgeons, Nurses, and Biomedical staff.

Post installation inspections will be required to be verified by surgical service prior to vendor departure. Should maintenance or repair be required and called to vendor, expectation is that vendor will make return call within 2 hours.

Vendor is expected to restore full performance of surgical unit within 48 hours of the original call. Should the surgical unit be deemed to take longer than 48 hours for full restoration, it is expected that the portion causing the unit to be un-usable will be replaced within 5 working days. Should the surgical unit need repair which the contractor considers not responsible for under the terms of contract (such as Operator misuse), prior to such repair, vendor will immediately communicate the situation to COTR, Administrative Officer of Surgical Service at S.T.V.H.C.S. and Contracting Officer. Training, support, preventative maintenance, educational courses shall be provided on-site – per contract or vendor courtesy agreement. Vendor shall provide detailed report for any maintenance, calibration or repair for biomedical service record entry. No repairs due to negligence, misuse or vendor/contractor services will be performed without a written estimate to provide the Biomedical Service for verification and determination of cause or authenticity of repair. Contracting officer must be informed prior to repair and written approval attained by Biomedical for authorization of repair. All repairs must be supervised by Biomedical personnel.

Personnel clearances and privacy:

The vendor will ensure that their personnel and subcontractors (if applicable) meet and attain all S.T.V.H.C.S. sponsorship and appropriate identification to conduct extended lengths of stay to conduct complete install, setup and training.

End of Contract:

Contractor shall guarantee all equipment meets or exceeds manufacturer's performance standards and specifications at the end of contractual agreement.

Information Systems Officer, Information Protection:

The contractor *will not* have access to VA Desktop computers nor will they have access to online resources belonging to the government while conducting services. Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the

Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

(i) The Offeror (itself or through its immediate owner or highest-level owner) does, does not publicly disclose greenhouse gas emissions, i.e., makes available on a publicly accessible Web site the results of a greenhouse gas inventory, performed in accordance with an accounting standard with publicly available and consistently applied criteria, such as the Greenhouse Gas Protocol Corporate Standard.

E.5 VAAR 852.233-70 PROTEST CONTENT/ALTERNATIVE DISPUTE RESOLUTION (JAN 2008)

(a) Any protest filed by an interested party shall:

- (1) Include the name, address, fax number, and telephone number of the protester;
- (2) Identify the solicitation and/or contract number;
- (3) Include an original signed by the protester or the protester's representative and at least one copy;
- (4) Set forth a detailed statement of the legal and factual grounds of the protest, including a description of resulting prejudice to the protester, and provide copies of relevant documents;
- (5) Specifically request a ruling of the individual upon whom the protest is served;
- (6) State the form of relief requested; and
- (7) Provide all information establishing the timeliness of the protest.

(b) Failure to comply with the above may result in dismissal of the protest without further consideration.

(c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.
