B.2 LIMITATIONS ON SUBCONTRACTING-- MONITORING AND COMPLIANCE (JUN 2011)

This solicitation includes VAAR 852.219-10 VA Notice of Total Service- Disabled Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's

business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. All support contractors conducting this review on behalf of VA will be required to sign an "Information Protection and Non-Disclosure and Disclosure of Conflicts of Interest Agreement" to ensure the contractor's business records or other proprietary data reviewed or obtained in the course of assisting the CO in assessing the contractor for compliance are protected to ensure information or data is not improperly disclosed or other impropriety occurs. Furthermore, if VA determines any services the support contractor(s) will perform in assessing compliance are advisory and assistance services as defined in FAR 2.101, Definitions, the support contractor(s) must also enter into an agreement with the contractor to protect proprietary information as required by FAR 9.505-4, obtaining access to proprietary information, paragraph (b). B.3 PERFORMANCE WORK STATEMENT

Performance Work Statement Southeast Louisiana Veterans Healthcare System (SLVHCS) Engineering Joint Commission Preparation Consulting Services

1.0 INTRODUCTION

1.1 Scope

Facilities Management Service at Southeast Louisiana Veterans Healthcare System (SLVHCS) needs consulting services in preparation of upcoming Joint Commission surveys. Services to be performed include, but are not limited to assisting with service specific policy development, filling and binder presentation; Joint Commission and VA directive relative documentation development, organization and filing; specialized training, and mock survey reviews.

2.0 REQUIREMENTS

2.1 Consultative Support Services

The Contractor shall provide consultative support services including all aspects of Joint Commission preparation, including but not limited to: documentation review and preparation, onsite training, reference library set up (electronic and physical), review of existing work order protocols and work recording processes.

The following is a general description of the support services that the Contractor will be required to provide.

2.1.1 Consulting Services:

- 2.1.1.1. The contractor shall provide fully qualified staff experience with Joint Commission survey and shall demonstrate experience pertaining to the Environment of Care Chapter and Life Safety Chapter of the Joint Commission elements of performance. Experience shall include knowledge of standards as it pertains to the following accreditations: Ambulatory, Hospital, Home Care, Behavioral Health Care, and Laboratory Services.

- 2.1.1.2. Consultative services may be conducted via email, teleconference and by site visits. The contractor shall provide no fewer than two (2) site visits no fewer than two days each during this period performance. The contractor shall provide at least three personnel to rotate through the different sections within the service during all site visits.

2.1.2. Deliverable Requirements

2.1.2.1. Policy Binders

- 2.1.2.1.1. The Contractor shall assist with the development, assembly and creation of physical spreadsheets. The documents developed shall be hyperlinked to the facility's online policy repository.
- 2.1.2.1.2. The Contractor shall assist the facility in building references for all applicable policies. These included but are not limited to:
- 2.1.2.1.2.1. Fire Safety and Systems
- 2.1.2.1.2.1.1. Medical Gas (medical air, oxygen, nitrogen, carbon dioxide, vacuum)
- 2.1.2.1.2.1.2. Temperature, relative humidity (RH), air pressures and air exchanges for critical areas: Operating Rooms (ORs), Sterile Processing Services (SPS), Isolation Rooms
- 2.1.2.1.2.2. Electrical System Maintenance
- 2.1.2.1.2.3. Emergency Operations Plans, etc.

2.1.3. Documentation

- 2.1.3.1.1. The Contractor, in coordination with VA staff, shall establish document formatting concerning internal standard operating procedures (SOPs), service line policies, and maintenance and emergency operation procedure and train personnel on said formatting.
- 2.1.3.1.2. The Contractor shall review existing and develop new inspection, testing, maintenance documents (including but not limited to: inventory, testing periods, testing procedures, and results properly documented), fire alarm and suppression systems, medical gas, emergency power supply system, generators, automatic transfer switch (ATS), egress lighting/exit signs, and LIM Panels. All documents to be review and developed shall be all necessary documents needed by the site in order address Joint Commission Accreditation requirements and Elements of Performance.
- 2.1.3.1.3. The contracting shall provide an organizational assessment of the service to evaluate current compliance with specific Joint Commission standards.
- 2.1.3.1.4. Final documentation shall be completed at the conclusion of this contract.

2.1.4. Specialized Training

- 2.1.4.1.1. Teach or co-teach with safety, train operations staff from 1 to 8 hours on the following unless stated elsewhere:
- 2.1.4.1.2. Fire stop installation and inspection
- 2.1.4.1.3. Fire stop 3rd party fire stop inspector recurring proficiency training,
- 2.1.4.1.4. Fire stop installer remedial training,
- 2.1.4.1.5. Fire and smoke barrier door inspection and testing training,

- 2.1.4.1.6. Fire and smoke damper inspection and testing training,
- 2.1.4.1.7. Fire proofing introduction to installation, inspection, and training.
- 2.1.4.2. The number of staff to be trained shall not exceed 30 at any given time.
 - 2.1.4.2.1. Standards, performance, and report format for inspection, testing, and repair of fire and life safety systems and equipment shall be developed and reviewed during training sessions.
 - 2.1.4.2.2. Clinical staff training, basic course explaining Life Safety Code Surveyors role and the key items that they are responsible for in the environment of care.
 - 2.1.4.2.3. Contractor shall provide a training syllabus for approval prior to training commencement.
- 2.1.4.3. Training shall take place no later than six (6) weeks after contract award.

2.1.5. Work Order System

- 2.1.5.1. Assist in developing a priority list for standing up work order systems.
 - 2.1.5.1.1. Priority listing shall be developed no later than six (6) weeks after contract award.
 - 2.1.5.1.2. Discuss how to develop and input inventories and managing data. To include standard naming conventions, risk ranking for equipment, and standard reports.
- 2.1.5.2. The current system used by the VA is IBM's MAXIMO©

2.1.6. Internal Mock Surveys

- 2.1.6.1.1. The contractor shall conduct internal mock surveys that shall include exercises with a focus on escorting, the scribe, and ladder crew
- 2.1.6.1.2. The contractor shall also emphasis familiarity with facility and life safety drawings as well as understanding the key terms and focuses during a survey. The contractor shall provide at least one (1) mock survey no fewer than four weeks, no more than eight (8) weeks after initiation of the contract.

2.1.2 The working environment is indoors in a government office with a minimum standard of "business casual" dress. Picture identification card will be issued at the start of contract services for security access to Government facility and shall be returned immediately upon expiration or termination of requested services.

2.1.3 Physical requirements are primarily sedentary, working while seated, however, individual(s) may periodically be required to bend, lift and deposit documents, files and small quantities of office supplies (paper, etc.) in the routine course of daily duties, overhead reaching, extensive walking.

2.2 Minimum Requirements

- 2.2.1 Consultant Specialists shall possess all the demonstrated experience and knowledge requirements as delineated below, as verified by a signed and dated resume by the individual and a corporate executive. Experience shall demonstrate abilities to support services requested as per this scope of work.

- 2.2.2 Experience Requirements: The Consultant Specialist shall have a minimum of five (5) years of experience in conducting comprehensive Life safety reviews, The Joint Commission's Environment of Care with respect to healthcare facilities, Joint Commission survey preparation with a working knowledge of the task as described in this SOW.
- 2.2.3 Consultants must demonstrate specialization in specifically the Healthcare Environment of Care and Life Safety. At least one specialist shall carry a certification of Life Safety Specialist or shall demonstrate equivalency through the provision of staff resumes.
- 2.2.4 Additional Required Knowledge and Skills: In addition to the experience and educational requirements described, the Consultant Specialist shall clearly possess the following knowledge and skills:
 - 2.2.4.1. Ability to communicate effectively, both orally and in writing.
 - 2.2.4.2. Ability to conduct comprehensive research and analysis
 - 2.2.4.3. Ability to read and interpret policy, regulations, and directives.
 - 2.2.4.4. Ability to provide clear leadership, technical direction, and guidance

3.0 GOVERNMENT FURNISHED PROPERTY AND OTHER RESOURCES

3.1 The Government will provide only the property which is required to configure a suitable workstation and office environment for assigned personnel to include but not limited to office furniture, telephone, computer, and communications/dispatch devices as applicable.

3.2 Supervisory Controls: Work will be reviewed for compliance with policy, overall objectives and effectiveness in achieving results by the COR, their designee or as identified in this PWS.

4.0 OTHER DIRECT COSTS

The contractor shall include in the contract all costs associated with travel, postage, mileage, tolls, etc.

6.0 PERIOD OF PERFORMANCE

The period of performance for work subject to the resulting task order will begin August 30, 2018- December 30, 2018.

If needed, the government intends to exercise the option under FAR 52-217-8 without further competition or need for justification for other than full or open competition (or limited source justification or sole source justification).

Place of Performance and Work Hours

The period of performance for work subject to the resulting task order will begin August 30, 2018- November 20, 2018. Normal working hours are 7:30 am to 4:00 pm Monday through Friday, excluding Federal Holidays. The contractor will be expected to periodically work outside of normal working hours if the activities to take place negatively impact hospital operations (impact to patient area, result in halting in of critical care services, etc).

9.0 SECURITY ISSUES AND ACCESS

General: Department of Veterans Affairs Medical Center is a Federal Government Installation. A personnel background check may need to be processed, sent to the Contracting Officer, prior to the Contractor reporting for work. An identification card (Personal Identification Verification) and vehicle registration will not be issued until the background checks are completed and approved by the Security Investigation Center (SIC). The PIV card is required for access to the Government computer databases.

Security Identification Badges. Contract employee shall comply with the local NCO identification and access requirements. The Contractor is responsible for absences of contract employees due to expired or lost identification and access documents. Each contract employee shall wear and display assigned Security Badge ID, provided by the Human Resources Security Office (HRSO) so that it is visible at all times, and in accordance with their guidance. The badge must display the full name, title and if required by the (HRSO) the words "Contractor" in front. Contractor/Contract employees shall turn in all identification badges to the Contracting Officer, or designated representative upon termination of their services under the contract. The Contractor shall be responsible for the replacement cost of lost or non-returned Identification cards.

Vehicles. All contract employees must register their vehicles with the Police Office to gain access onto the VA Campus. A valid driver's license, Government-furnished civilian ID, proof of insurance and current registration must be presented to the Police Office, at which time a VA decal will be issued. The decal shall be placed on the vehicle's front windshield in accordance with instructions. Contract employees shall follow installation procedures for removal and turn-in of the vehicle decal upon termination of services under this contract. Vehicles, with or without a VA decal, are subject to search.

Security: All contractors and contractor personnel shall be subject to the same Federal security and privacy laws, regulations, standards and VA policies, including the Privacy Act, 5 U.S.C. 552a, and VA personnel, regarding information and information system security. Contractors shall follow policies and procedures outlined in VA Directive 6500, Information Security Program which is available at: <http://www1.va.gov/vapubs> and its handbooks to ensure appropriate security controls are in place.

Confidentiality. Contractor personnel who obtain access to hardware, software or media, which may manipulate or store any sensitive information, that is protected under 38 USC 4132 or 3305, as defined by the Department of Veterans Affairs, must not access information unless absolutely necessary to perform their contractual duties. Disclosure of any sensitive data obtained during performance of assigned duties under this contract is prohibited. Violation of these statutory provisions may involve imposition of criminal penalties. Contractor is considered to be a VA contractor for purposes of Privacy Act, Title 5 U.S.C. 552a.

HIPAA. The Contractor shall abide by the Standards for Privacy of Individually Identifiable Health Information of the Health Insurance Portability and Accountability Act (HIPAA), Public Law 104-01. The Contractor shall not use or further disclose Protected Health Information other than as permitted or required by the contract or as required by Law. The Contractor shall use appropriate safeguards to prevent use or disclosure of the Protected Health Information. The Contractor shall mitigate, to the extent practicable, any harmful effect that is known to the Contractor of a use or disclosure of Protected Health Information by the Contractor in violation of the requirements of this contract. The Contractor shall report to the Government any use or disclosure of the Protected Health Information not provided for by this Contract. The Contractor shall document, in a time and manner designated by the Government, any disclosure of Protected Health Information as would be required for the Government to respond to a request by an individual for an accounting of disclosure of Protected Health Information.

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB as appropriate.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Sec. 6320 entitling the taxpayer to request a hearing with the IRS Office of Appeals contesting the lien filing, and to further appeal to the Tax Court if the IRS determines to sustain the lien filing. In the course of the hearing, the taxpayer is entitled to contest the underlying tax liability because the taxpayer has had no prior opportunity to contest the liability. This is not a delinquent tax because it is not a final tax liability. Should the taxpayer seek tax court review, this will not be a final tax liability until the taxpayer has exercised all judicial appeal rights.

(C) The taxpayer has entered into an installment agreement pursuant to I.R.C. Sec. 6159. The taxpayer is making timely payments and is in full compliance with the agreement terms. The taxpayer is not delinquent because the taxpayer is not currently required to make full payment.

(D) The taxpayer has filed for bankruptcy protection. The taxpayer is not delinquent because enforced collection action is stayed under 11 U.S.C. 362 (the Bankruptcy Code).
