1. Background

GCVHCS requires new medical equipment in support of the activation of a new Major Lease construction project for our Mobile CBOC. The project is expanding multiple clinical services' capability in this 63,000 square foot building. The Mobile Audiology and Speech Clinic will require a Madsen Zodiac Immittance System or equal to accommodate growth in additional treatment space and increased access. 3. Specifications

Audiology staff members often move between the three Gulf Coast Audiology Clinics and are required to utilize equipment quickly. Therefore, standardization of equipment is essential. The Madsen Zodiac workflow is based on Otosuite software – which is the shared interface with other Otometric systems used at our other facilities, as well as what has been requested for our new Mobile Clinic (Astera, Capella, Otocam). The use of Otosuite makes testing and data management more efficient, accurate, and convenient.

Because of these requirements, this equipment must meet the following specifications:

Additionally, Contractor shall provide the standard OEM (Original Equipment Manufacturer) warranty period for all equipment provided starting upon receipt of delivery to VA.

6. **Delivery Coordination**

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.
