This solicitation includes VAAR 852.219-10 VA NOTICE OF TOTAL SERVICE-DISABLED VETERAN-OWNED SMALL BUSINESS SET-ASIDE (JUL 2016). Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. ## B.4 STATEMENT OF WORK

**Statement of Work  
Hazardous and Non-Hazardous Medical Waste  
Disposal Pick-up Services  
VA San Diego Health Care System (VASDHCS)**

### 1. GENERAL REQUIREMENTS.

a. The Contractor shall provide hazardous and non-hazardous medical waste disposal pick-up services. The Contractor shall provide all management, labor, supplies/liners, equipment, supervision, transportation, packaging, pick-up, and disposal of Regulated Medical Waste (RMW). RMW includes bio-hazardous waste (red bags) (autoclaved), sharps (autoclaved), comingled waste (sharps mixed with California only pharmacy waste (incinerate), lab waste (incinerate), and pathology waste (incinerate), Cactus and Pharma lock controlled substances (incinerate) in accordance with all applicable Local, State and Federal Regulations and Joint Commission Standards (JCS) listed below. The Contractor shall supply enough containers to hold 72 hours of waste; estimating 200 containers daily. The containers shall have a unique color container for each waste stream to segregate the different regulated medical waste streams. The Contractor shall uniquely label each container for each waste stream (except as specified as government furnished equipment). The Contractor shall submit a medical waste manifest/tracking document and a monthly report. The monthly report shall be for all waste stream collected, transported and treated. The monthly report shall mirror the invoice(s), tracking documentation and certificate of destruction (COD); pounds, number of containers, size, cost per pound, location of the collection, and type of treatment. The certificate of destruction (COD) shall be emailed to the Contracting Officer Representative (COR) monthly.

b. RMW containers shall be collected by the Veterans Affairs San Diego Health Care System (VASDHCS) and taken to a central collection point at each facility and/or clinic for pick-up by the Contractor.

c. Reports on poundage pick-up RMW waste containers shall be bar coded in such a way as to allow for tracking of containers including but not limited to a history of the net weight of material collected, the time a container stayed at point of accumulation, the date the full waste container was replaced and the number of times the reusable container has been reused. The history of these reports shall be maintained in a software database available for review and compilation of statistics.

d. The consolidated weight of RMW waste collected from waste accumulation points will include the date of removal from the medical center. The weight will be recorded on the waste invoice and tracking documentation, as well in a separate electronic database. All waste streams will be listed separately on the invoice, especially regarding weight.

VASDHS clinics associated with, but not located on main campus of the facilities identified in the table above also require regulated medical waste pick-up and disposal. Clinic locations and estimated quantities are subject to change due to patient demand. The Contractor shall ensure it maintains the resources necessary to respond to these changes. Notwithstanding any other provisions in this contract to the contrary, the Contractor shall provide medical waste pick-up and disposal to those facilities under the same terms and conditions as specified in this contract.

#### **4. Regulated Medical Wastes:**

##### **a. Medical Waste Segregation and Storage**

Trace chemotherapy waste, as defined in paragraph (5) of subdivision (b) of Section 117690 (California Medical Waste Management Act), shall be segregated for storage, and, when placed in a secondary container, that container shall be labeled with the words "Chemotherapy Waste", "CHEMO", other label approved by the department on the lid and sides, so as to be visible from any lateral direction, to ensure treatment of the biohazardous waste pursuant to Section 118222.

##### **b. Waste Requiring Specified Methods**

(1) Pathology waste that meets the conditions of paragraph (2) of subdivision (b) of Section 117690 and trace chemotherapy waste that meets the conditions of paragraph (5) of subdivision (b) of Section 117690 shall be treated by incineration or alternative treatment technologies approved to treat that waste pursuant to paragraph (1) or paragraph (3) of subdivision (a) of Section 118215 prior to disposal. Pharmaceutical waste from health care settings that meets the condition specified in paragraph (3) of subdivision (b) of Section 117690 shall be treated by incineration or alternative treatment technologies approved to treat that waste pursuant to paragraph (1) or paragraph (3) of subdivision (a) of Section 118215 prior to disposal the contact with, or having previously contained, chemotherapeutic agents, shall be placed in sharps containers labeled in accordance with the industry standard with the words "Chemotherapy Waste," "Chemo," or other label approved by the department, and shall be segregated to ensure treatment of the sharps waste pursuant to Section 118222.

(2) The Contractor agrees to abide by the following references: NIST (National Institute of Standards and Technology) 800-88 (EPL) 1x5 mm cross cut (as stated in Para. A below), 41 CFR Part 101-45 and 44 U.S.C. 3302 1228-58.

(3) Incinerator Specifications: The Contractor shall provide off-site pharmaceutical, sharps commingle with CA- Only pharmacy waste, pathology waste, laboratory waste destruction; these waste shall be destroyed by incineration. Protected information contained on any waste material must be destroyed in such a manner that is compliant with the NIST Special Publication 800-88; incineration, pulping, m, or shredding to National Security Agency (NSA) EPL 1x5mm.

(4) RMW waste that contains Personal Identifiable Information (PII) or Protected Health Information (PHI) must be destroyed by burning in the medical waste incinerator at a minimum of 1500F as a final destruction method. RMW waste which contains PII or PHI shall not be abandoned, sold or resold. Note: If the Contractor has to move the RMW waste containing PII data to the disposal site away for the VASDHS, this is authorized. The Contractor accepts liability for all data and the ramifications should a loss of data occur; the VASDHS is harmless should an incident occur after the Contractor takes possession of the data attached to the non-hazardous pharmaceutical waste.

(5) No Personal Identifiable Information or Sensitive information will ever be place in an unauthorized dumpster or similar device, until it has been compliant burned.

(6) The Contractor agrees to destroy all VASDHS RMW waste and shall ensure that PII and

other sensitive temporary records (in the RMW waste containers provided by the Contractor) are protected until their contents of the waste is actually destroyed by burning in a medical waste incinerator at minimum of 1500F.

**c. Intermittent/Emergency Orders:** In the event that additional waste pickups are needed, the Contractor shall be available within 24 hours' notice to respond for unscheduled service and prices shall be in accordance with the fee that is listed in the contract schedule.

**d. Control of Security Waste:** The Contractor shall be responsible for the management, oversight, security, and control of all classified, sensitive, confidential documents and documents containing

medical records stored in the pharmacy waste containers, prior to and until completion of destruction by burning in a medical waste incinerator at a minimum of 1500F.

5. The Contractor is culpable under the law should an employee view, take or release sensitive information unlawfully.

6. Regulated Medical Waste Containers: shall be stored in the locked temporary storage facility.

**7. CERTIFICATION OF DESTRUCTION:**

The Contractor shall prepare and submit to the medical facility's COR an original signed Certificate of Destruction (witnessed by a VASDHS employee or a designated representative assigned in writing by the COR) for each pick up for each site within (30 days of collection). The Contractor shall maintain proper records concerning each Certificate of Destruction issued. The Certificate of Destruction shall as a minimum contain the following:

- Pick-up/Delivery Location
- Pick-up/Delivery Date
- Name of Government COR at Pick-up Location
- Amount of RMW waste (# of containers picked up and pounds)
- Destruction Certification Document Number
- Destruction Certification Date
- Location of the treatment facility or incinerator
- Any other information as determined necessary by the Contracting Officer

**8. HOURS OF OPERATION:**

**Normal Work Hours:** This contract is a full service contract to include all necessary service calls, five (5) days per week, eight (8) hours per day. Collection shall take place between the hours of 5:00 AM and 3:30 PM (except for emergency spill response) – Monday - Friday; all National Holidays are excluded.

Any service performed during other than normal work hours shall be approved in advance by the COR.

**9. NATIONAL HOLIDAYS:**

The Contractor is not required to provide services on the following National Holidays nor shall the Contractor be paid for these National Holidays.

Also included would be any other day specifically declared by the President of the United States to be a National Holiday. When a holiday falls on a Sunday, the following Monday shall be observed as a legal holiday by U.S. Government agencies. When a holiday falls on a Saturday, the preceding Friday shall be observed as a legal holiday.

#### **10. PICK-UP SCHEDULE:**

a. VASDHS, upon contract award and in conjunction with the Contractor, shall determine pick-up requirement and schedule. The schedule is based on the amount of regulated medical waste generated and any storage restrictions specified in the referenced State and Federal regulations. Currently VASDHS Medical Center has daily pick-up.

b. VASDHS office shall be the only location with three (3) central collection points, depending on the waste stream. Building 18 shall require daily collection, Monday through Friday of (RMW), except pathological waste. Building 194 shall require pathological waste collection on an as needed basis; Monday through Friday.

#### **11. CONTRACTOR PERSONNEL:**

The Contractor shall be required to comply with all Veteran Health Administration (VHA) security requirements. All security requirements must be met and employees cleared prior to the Contractor performing work under the contract. Employees that cannot meet the security and clearance requirements shall not be allowed to perform work under this contract.

#### **12. IDENTIFICATION BADGE CHECK-IN WITH VA SECURITY:**

The Contractor personnel working on VA property must comply with the VA security management program. Contractor personnel shall wear a company I.D. badge at all times while on VA property and shall check in with the VA-Police upon arrival to pick-up a VA I.D. badge, that will be worn while on VA property.

#### **13. PARKING:**

The Contractor shall park only in areas designated by the COR or otherwise directed by VA Police and Security Service personnel. The Contractor shall display on its vehicles the company name in a manner and size that is clearly visible. The Contractor shall conform to the posted speed limits and parking restrictions set at each VA facility. Should Contractor personnel receive a citation for parking, speeding or other infractions, the offenses shall be resolved in accordance with all applicable laws and regulations. VA will not validate or make reimbursement for parking violations of the contractor's personnel under any circumstance.

#### **14. AUTHORIZED SERVICES:**

Only those services specified herein are authorized under this contract. Prior to performing any service of a non-contract nature, the COR must be advised of the reasons for this additional work. Only the CO may authorize additional services prior to commencement of work.

#### **15. SMOKING POLICY:**

Smoking is permitted only in designated areas.

## **16. SAFETY DATA SHEETS (SDS):**

- a. The Contractor shall provide their employees with immediate access to SDS for all hazardous substances.
- b. The Contractor is responsible for the proper protection of their employee. Attire and Personal Protective Equipment (PPE), including respirators, must be appropriate for the hazardous condition of lab-packing, lifting, carrying, pouring, blending, moving, and/or loading hazardous and toxic substances in limited space. The Contractor shall furnish Contractor employees all necessary PPE and ensure the proper working condition of said equipment. Contractor employees shall be enrolled, as appropriate and at Contractor expense, in a medical surveillance program as prescribed by 29 Code of Federal Regulations (CFR) 1910.

## **17. PENALTIES AND FINES:**

- a. The Contractor shall satisfy all applicable regulatory agency requirements. In the event a regulatory agency assesses a monetary fine against the VA for violations caused by the Contractor, the Contractor shall promptly reimburse the VA for the amount of the fine.
- b. The Government reserves the right to accept or reject Contractor personnel for the rendering of services. Complaints concerning Contractor personnel performance or conduct shall be dealt with by the Contractor. In addition, the parties agree that the contractor's personnel working as a result of this contract shall not be considered VA employees for any purpose and shall be considered employees of the contractor. The contractor shall be responsible for providing:
  - Workers Compensation.
  - Professional liability insurance.
  - Health examinations.
  - Income tax withholding, and,
  - Social Security payments.

## **18. GOVERNMENT FURNISHED PROPERTY AND/OR SERVICES:**

The Government will provide the following property and services in connection with the Contractor performance.

**a. Storage Areas:** The VASDHS shall provide designated areas for placement of disposable sharps and medical waste containers. The Contractor shall not restrict any VASDHS facility from performing packaging or consolidation of any facility's own waste stream, nor restrict any VASDHS facility to the Contractor provided packaging as long as said packaging or consolidation complies with applicable government regulations.

**b. Waste Manifest Form:** In accordance with applicable government regulations, the designated VASDHS representative shall complete appropriate information on and/or sign required waste manifest forms/waste tracking documents.

**c. Containers/Biohazard Bags:** The VASDHS shall provide biohazard bags. Disposable sharps containers shall be provided by VASDHS.

## **19. CONTRACTOR FURNISHED PROPERTY AND SERVICES:**

- a. The Contractor will provide RMW waste collection bins which should be 44 gallon containers or larger; unique color containers for each waste stream.
- b. The Contractor will furnish DOT approved waste containers appropriate for Regulated medical waste; collection, transport & treatment of Regulated Medical Waste (RMW).



c. Regulated Medical Waste containers will be re-usable upon emptying and cleaning of containers in accordance with any applicable state and federal regulations. Containers will incorporate environmentally preferable recycled materials consistent with the Veterans Administration's Green Environmental Management System (GEMS) program. The contractor shall ensure that all recyclable waste containers are maintained in optimum condition.

d. In accordance with applicable government regulations, the Contractor will complete appropriate information on required waste manifest forms.

## **20. TRAINING:**

The Contractor shall provide on-going training on reusable pharmaceutical containers, classification, segregation of pharmaceutical waste, and packaging as part of the service. The VASDHS shall provide appropriate facilities for any training provided by the Contractor.

## **21. SPILLS:**

When waste is spilled by the Contractor at any pickup site, storage location or during transport, the Contractor shall be responsible, at no additional charge to the VASD, for clean-up in accordance with appropriate state and federal regulations. In addition, a verbal report shall be made immediately to the COR, followed by a written report within seven (7) business days. The written report shall include the following:

- Spills by type and amount of waste
- Certification spill waste was properly removed
- Identity of personnel exposed to spilled waste
- Condition of personnel exposed to spilled waste
- Description of cause
- Corrective action and/or preventive measures

## **22. WASTE STREAM SURVEY:**

The Contractor shall conduct annual Waste Stream Surveys at each facility. The first survey shall be conducted within a thirty (30) calendar day period of the initial contract award and within a thirty (30) calendar day periods of an exercise of any options. Results of the survey shall be provided in an excel spreadsheet and submitted to the COR via email within fifteen (15) calendar days of each period. The COR will monitor the receipt of the survey.

## **23. CHARGES:**

The Contractor shall charge only for the net weight of waste excluding the weight of the containers. The Contractor shall be responsible for weighing containers. The Contractor shall ensure only scales calibrated and inspected in accordance with applicable State and Federal regulations are used by providing the COR with an annual certification from a third (3<sup>rd</sup>) party. The tracking documentation must reflect the same weight units as the monthly invoice and monthly waste report.

## **23. INVOICING:**

All invoices from the contractor shall be submitted electronically in accordance with VAAR Clause 852.232-72 Electronic Submission of Payment Requests.

(xix) 52.225-26, Contractors Performing Private Security Functions Outside the United States (OCT 2016) (Section 862, as amended, of the National Defense Authorization Act for Fiscal Year 2008; 10 U.S.C. 2302 Note).

(xx) 52.226-6, Promoting Excess Food Donation to Nonprofit Organizations (MAY 2014) (42 U.S.C. 1792). Flow down required in accordance with paragraph (e) of FAR clause 52.226-6.

(xxi) 52.247-64, Preference for Privately Owned U.S.-Flag Commercial Vessels (Feb 2006) (46 U.S.C. Appx. 1241(b) and 10 U.S.C. 2631). Flow down required in accordance with paragraph (d) of FAR clause 52.247-64.

(2) While not required, the Contractor may include in its subcontracts for commercial items a minimal number of additional clauses necessary to satisfy its contractual obligations.

### **C.3 52.216-18 ORDERING (OCT 1995)**

(a) Any supplies and services to be furnished under this contract shall be ordered by issuance of delivery orders or task orders by the individuals or activities designated in the Schedule. Such orders may be issued from the effective date of the contract through the end of the effective period.

(b) All delivery orders or task orders are subject to the terms and conditions of this contract. In the event of conflict between a delivery order or task order and this contract, the contract shall control.

(c) If mailed, a delivery order or task order is considered "issued" when the Government deposits the order in the mail. Orders may be issued orally, by facsimile, or by electronic commerce methods only if authorized in the Schedule.

### **C.4 52.216-19 ORDER LIMITATIONS (OCT 1995)**

(a) *Minimum order.* When the Government requires supplies or services covered by this contract in an amount of less than \$1,000.00, the Government is not obligated to purchase, nor is the Contractor obligated to furnish, those supplies or services under the contract.

(b) *Maximum order.* The Contractor is not obligated to honor—

(1) Any order for a single item in excess of \$1,500,000.00;

(2) Any order for a combination of items in excess of \$1,500,000.00; or

(3) A series of orders from the same ordering office within 180 days that together call for quantities exceeding the limitation in paragraph (b)(1) or (2) of this section.

(c) If this is a requirements contract (i.e., includes the Requirements clause at subsection 52.216-21 of the Federal Acquisition Regulation (FAR)), the Government is not required to order a part of any one requirement from the Contractor if that requirement exceeds the maximum-order limitations in paragraph (b) of this section.

(d) Notwithstanding paragraphs (b) and (c) of this section, the Contractor shall honor any order exceeding the maximum order limitations in paragraph (b), unless that order (or orders) is returned to the ordering office within 10 days after issuance, with written notice stating the Contractor's intent not to ship the item (or items) called for and the reasons. Upon receiving this notice, the Government may acquire the supplies or services from another source.

### **C.5 52.216-22 INDEFINITE QUANTITY (OCT 1995)**

(a) This is an indefinite-quantity contract for the supplies or services specified, and effective for the period stated, in the Schedule. The quantities of supplies and services specified in the Schedule are estimates only and are not purchased by this contract.

(b) Delivery or performance shall be made only as authorized by orders issued in accordance with the Ordering clause. The Contractor shall furnish to the Government, when and if ordered, the supplies or services specified in the Schedule up to and including the quantity designated in the Schedule as the "maximum." The Government shall order at least the quantity of supplies or services designated in the Schedule as the "minimum."

(c) Except for any limitations on quantities in the Order Limitations clause or in the Schedule, there is no limit on the number of orders that may be issued. The Government may issue orders requiring delivery to multiple destinations or performance at multiple locations.

(d) Any order issued during the effective period of this contract and not completed within that period shall be completed by the Contractor within the time specified in the order. The contract shall govern the Contractor's and Government's rights and obligations with respect to that order to the same extent as if the order were completed during the contract's effective period; *provided*, that the Contractor shall not be required to make any deliveries under this contract after August 31, 2023.

### **C.6 52.217-8 OPTION TO EXTEND SERVICES (NOV 1999)**

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The option provision may be exercised more than once, but the total extension of performance hereunder shall not exceed 6 months. The Contracting Officer may exercise the option by written notice to the Contractor within 30.

No legal liability on the part of the Government for any payment may arise for performance under this contract beyond September 30, 2018, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.

## **C.9 VAAR 852.219-10 VA NOTICE OF TOTAL SERVICE-DISABLED VETERAN-OWNED SMALL BUSINESS SET-ASIDE (JUL 2016)(DEVIATION)**

(a) *Definition.* For the Department of Veterans Affairs, "Service-disabled veteran-owned small business concern or SDVSOB":

(1) Means a small business concern:

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans or eligible surviving spouses (see VAAR 802.201 Surviving Spouse definition);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(iii) The business meets Federal small business size standards for the applicable North American Industry Classification System (NAICS) code identified in the solicitation document;

(iv) The business has been verified for ownership and control pursuant to 38 CFR 74 and is so listed in the Vendor Information Pages database, (<https://www.vip.vetbiz.gov>); and

(v) The business will comply with subcontracting limitations in 13 CFR 125.6, as applicable

(2) "Service-disabled veteran" means a veteran, as defined in 38 U.S.C. 101(2), with a disability that is service-connected, as defined in 38 U.S.C. 101(16).

(b) *General.*

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

(c) *Agreement.* A service-disabled veteran-owned small business concern agrees that in the performance of the contract, the concern will comply with the limitation on subcontracting requirements in 13 CFR §125.6.

(d) A joint venture may be considered a service-disabled veteran owned small business concern if the joint venture complies with the requirements in 13 CFR 125.15, provided that any reference therein to SDVO SBC is to be construed to apply to a VA verified SDVOSB as appropriate.

(e) Any service-disabled veteran-owned small business concern (non-manufacturer) must meet the requirements in FAR 19.102(f) of the Federal Acquisition Regulation to receive a benefit under this program.

(a) *Definitions.* As used in this clause—

(4) *Invoice payment* has the meaning given in FAR 32.001.

(5) *Payment request* means any request for contract financing payment or invoice payment submitted by the contractor under this contract.

(b) *Electronic payment requests.* Except as provided in paragraph (e) of this clause, the contractor shall submit payment requests in electronic form. Purchases paid with a Government-wide commercial purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

"Administrative proceeding" means a non-judicial process that is adjudicatory in nature in order to make a determination of fault or liability (e.g., Securities and Exchange Commission Administrative Proceedings, Civilian Board of Contract Appeals Proceedings, and Armed Services Board of Contract Appeals Proceedings). (1) Whether the offeror, and/or any of its principals, has or has not, within the last five years, in connection with the award to or performance by the offeror of a Federal contract or grant, been the subject of a proceeding, at the Federal or State level that resulted in any of the following dispositions:

(i) In a criminal proceeding, a conviction.

(ii) In a civil proceeding, a finding of fault and liability that results in the payment of a monetary fine, penalty, reimbursement, restitution, or damages of \$5,000 or more.

(iii) In an administrative proceeding, a finding of fault and liability that results in—

(A) The payment of a monetary fine or penalty of \$5,000 or more; or

(2) If the offeror has been involved in the last five years in any of the occurrences listed in (c)(1) of this provision, whether the offeror has provided the requested information with regard to each occurrence.

### **E.3 52.212-1 INSTRUCTIONS TO OFFERORS—COMMERCIAL ITEMS (JAN 2017)**

(a) *North American Industry Classification System (NAICS) code and small business size standard.* The NAICS code and small business size standard for this acquisition appear in Block 10 of the solicitation cover sheet (SF 1449). However, the small business size standard for a concern which submits an offer in its own name, but which proposes to furnish an item which it did not itself manufacture, is 500 employees.

(b) *Submission of offers.* Submit signed and dated offers to the office specified in this solicitation at or before the exact time specified in this solicitation. (9) Acknowledgment of Solicitation Amendments;

(10) Past performance information, when included as an evaluation factor, to include recent and relevant contracts for the same or similar items and other references (including contract numbers, points of contact with telephone numbers and other relevant information); and

(11) If the offer is not submitted on the SF 1449, include a statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation. Offers that fail to furnish required representations or information, or reject the terms and conditions of the solicitation may be excluded from consideration.

If no time is specified in the solicitation, the time for receipt is 4:30 p.m., local time, for the designated Government office on the date that offers or revisions are due.

(2)(i) Any offer, modification, revision, or withdrawal of an offer received at the Government office designated in the solicitation after the exact time specified for receipt of offers is "late" and will not be considered unless it is received before award is made, the Contracting Officer determines that accepting the late offer would not unduly delay the acquisition; and—

(A) If it was transmitted through an electronic commerce method authorized by the solicitation, it was received at the initial point of entry to the Government infrastructure not later than 5:00 p.m. one working day prior to the date specified for receipt of offers; or

(B) There is acceptable evidence to establish that it was received at the Government installation designated for receipt of offers and was under the Government's control prior to the time set for receipt of offers; or

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Restricted business operations* means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. For line items covered by the WTO GPA, the Government will evaluate offers of U.S.-made or designated country end products without regard to the restrictions of the Buy American statute. The Government will consider for award only offers of U.S.-made or designated country end products unless the Contracting Officer determines that there are no offers for such products or that the offers for such products are insufficient to fulfill the requirements of the solicitation.

(h) *Certification Regarding Responsibility Matters* (Executive Order 12689). (Applies only if the contract value is expected to exceed the simplified acquisition threshold.) The offeror certifies, to the best of its knowledge and belief, that the offeror and/or any of its principals—

contractor with an unfair competitive advantage. (c) Based on this information and any other information solicited or obtained by the contracting officer, the contracting officer may determine that an organizational conflict of interest exists which would warrant disqualifying the contractor for award of the contract unless the organizational conflict of interest can be mitigated to the contracting officer's satisfaction by negotiating terms and conditions of the contract to that effect. If the conflict of interest cannot be mitigated and if the contracting officer finds that it is in the best interest of the United States to award the contract, the contracting officer shall request a waiver in accordance with FAR 9.503 and 48 CFR 809.503.

(d) Nondisclosure or misrepresentation of actual or potential organizational conflicts of interest at the time of the offer, or arising as a result of a modification to the contract, may result in the termination of the contract at no expense to the Government.

If ADR is used, the Department of Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.
