- Prepared for Rixson double acting closer and floor pivot
- Top to the top of 8" mortise deadbolt is 21-3/8"
- 4X24 window will be 11" over and 17" down to visible glass
- Actual door size 43-1/2" X 83-1/4"
- Laminated safety glass to be installed
- Both cased opening and door to be prepared for roller latch
