This solicitation includes VAAR 852.219-10 VA Notice of Total Service- Disabled Veteran-Owned Small Business Set-Aside. Accordingly, any contract resulting from this solicitation will include this clause. The contractor is advised in performing contract administration functions, the CO may use the services of a support contractor(s) retained by VA to assist in assessing the contractor's compliance with the limitations on subcontracting or percentage of work performance requirements specified in the clause. To that end, the support contractor(s) may require access to contractor's offices where the contractor's business records or other proprietary data are retained and to review such business records regarding the contractor's compliance with this requirement. SCOPE OF WORK AND GENERAL SPECIFICATIONS FOR RELIANCE 7000 EYE EXAM CHAIR, 7800 OPHTHALMIC INSTRUMENT STAND, AND CHAIR ACCESSORIES OR EQUAL

1. Background

GCVHCS requires new medical equipment in support of the activation of a new Major Lease construction project for our Mobile CBOC. The project is expanding multiple clinical services' capability in this 63,000 square foot building. The Mobile Eye Clinic will require all new ophthalmologic equipment to accommodate the expanded services and increased access in space provided. Both Biomedical Engineering and Surgical-Eye Service encourage continued use and replacement of current facility wide Reliance Ophthalmic Examination equipment Or equal.

2. Project Scope

GCVHCS requires purchase of (4) Reliance 7000 Exam Chairs, (4) Reliance 7800 Instrument Stand, (1) Reliance 940 ADA Chair Glide, and (4) Reliance Exam Stools or Equal for timely activation of our Mobile CBOC Major Lease Replacement project. Product outlined in this Scope of Work shall be available for direct delivery to project site no later than December 2018 to meet current activation schedule. Delivery coordination with the COR may occur as early as two weeks following the contract award. Awarded vendor must follow delivery instructions outlined in Section 7 of this document. All requested items must meet the specifications included herein this document to meet technical acceptance by requestor. See noted specifications in Section 3.

3. Specifications for Reliance 7000 Exam Chair or Equal:

a. Ergonomic Features

1. Require Dual-side operation for chair control from both sides while maintaining patient contact.
2. Require an adjustable concave headrest to provide head and neck support.
3. Headrest must lock with a single hand.
4. Upholstered armrests must lock in place and release on both chair sides for security and comfort.
5. Require large hinged footrest to support patient's full weight and
6. Provides tilting footrest capability to save space in exam room.
7. Requires a corded footswitch for hands-free operation of chair base and top.
8. Must provide dual rotation locks to allow chair to swivel no less than 330°.
9. The 7000 chair reclines nearly flat for minor procedures. Non-articulating pillow headrest and articulating surgical headrest are optional.

b. Power Hydraulic base

1. Square pedestal base provides crucial patient stability and superior accessibility. Finger switches and a corded footswitch raise, lower or recline chair into any position without breaking patient contact. High and low base models available.

c. Ultra-Durable Membrane Switches

1. Programmable backlit membrane switches last 10-times longer than their mechanical counterparts. They're also safer because they run at low voltages.

d. Finishes and Upholstery

1. Upholstery must be hand sewn and cover high-density foam for durability.
2. Requires Removable cushions for easy cleaning or replacement.
4. Upholstery/finishes TBD by VA Interior Designer upon contract award.

e. Quality

1. Requires CSA certification to assure its safety and durability by providing a CSA, C/US certificate of compliance.

f. Dimensions and Specifications

1. Base must be equal to or less than 23" x 25" to fit eye exam rooms.
2. Overall width of entire chair must be 25" or less.
3. Overall depth (excluding headrest) must be 26" or less.
4. Table position must be 60" or less.
5. Seat must be at least 19" wide by 18" deep.
6. Armrest distance must be at least 19".
7. Must be compliant with Standard electrical: 115 volts, 60/50 Hz, 6.3 amperes total.

Specifications for Reliance 7800 Ophthalmic Instrument Stand or Equal:**h. Includes Counterbalanced Slit Lamp Arm**

1. Slit Lamp Arm must lock and adjust with a single hand. Arm travels at least 12" and includes counterbalances for instruments weighing 12-60 lbs.
2. Requires a slit lamp arm-mounted switch which raises and lowers the chair from the stand.

i. Upper Refractor Arm

1. Requires an upper refractor arm on stand that must provide at least a 10" range of movement.
2. This arm must hold and move instruments up to 20 lbs.

j. Third Instrument Arm

1. Require a third arm able to hold and move instruments from 20- 50 lb. capacity
2. Requires a third arm with a 10" range of vertical travel.
3. Compatible with 5399 Monitor Arm.

k. Instrument Wells

1. Provide a Console equipped with three rechargeable instrument wells that hold hand-held instruments.
2. Instrument wells must have capability to raise, lower and auto down exam chair from a switch.

l. Backlit Membrane Switches

1. Require Membrane switches on stand due to durability and low voltage safety over mechanical switches.
2. Switches must be capable of operating chart projector, overhead lamp and binding post for an indirect ophthalmoscope, and raise and lower the exam chair.

m. Halogen Lamp

1. Must provide a Long-lasting bulb powering bright, direct light for minor procedures.
2. Lamp Arm must adjust without tools.
3. Lamp utilizes Low voltage for safety.

n. Quality

1. Requires CSA certification to assure its safety and durability by providing a CSA, C/US

certificate of compliance.

o. Wheelchair Access

1. Provide option for a Lower slit lamp arm to facilitate exams for wheelchair bound patients (ADA Compliance).

p. Room Light Control

1. Require a feature in which all exam room lighting may be controlled from the instrument stand, or a small console. Lighting adjusts based on instrument moves or quick manual adjustments.

q. Dimensions & Specifications

1. Height to console must be 36'' or less.
2. Height to pole top must be 71'' or less.
3. Base must be no larger than 21 x 21''.
4. Stand must conform to Standard electrical: 115 volts, 60/50 Hz, 6.3 amperes total.

Specifications for Reliance 940 Chair Glide or Equal:

r. Glide System for ADA Compliance

1. Must be constructed of a heavy duty cast aluminum carriage
2. Must be compatible with specified Reliance 7000 Exam Chair as specified above
3. Track must taper into a 6'' tail to allow providers to move an exam stool closer to chair for patient accessibility. Track must be constructed of stainless steel guides to prevent lateral movement.
4. Requires a foot lever to activate and release a friction lock to secure wheel chair in position along glide path.
5. Glide base plate to be a satin finish, stainless steel construction. Base plate must include heavy-duty stops to limit distance traveled.

s. Dimensions & Specifications

1. Base plate length must be at least 52'' long.
2. Base plate width must be between 6-20''.
3. Track must be no larger than: 3/4'' wide x 3/16'' high x 52'' long.
4. Overall carriage length must be 29'' or less.
5. Overall carriage width must be 26'' or less.

Specifications for Reliance 5300 Series Stool or Equal:

t. Dimensions & Specifications

1. Seat must swivel 360 degrees independently of the base so height is not affected.
2. Provides adjustable height control via ring located under seat through a pneumatic device.
3. Requires a seat vertical travel of at least 6''. Seat height range must accommodate 18/5-25''.
4. Upholstery must be capable of matching provided specified Reliance 7000 Chair upholstery specs.
5. All exposed metal must be chrome plated steel with exception of aluminum base.

5. Warranty and Support

VA Biomedical Engineering will have full access to the hardware that constitutes this equipment. The VA Biomedical Engineering point of contact must be briefed, by the vendor, on all upgrades and changes and agrees to each prior to shipment. The vendor will provide two (2) sets of user manuals and technical manuals to VA Biomedical Engineering. Additionally, Contractor shall provide the standard OEM (Original Equipment Manufacturer) warranty period for all equipment provided starting upon receipt of delivery to VA.

6. Material Safety Data Sheet (MSDS)

Contractor shall provide three (3) copies of each Material Safety Data Sheet for every product, chemical, etc. used on this project. MSDS sheets shall be provided for any material on the same day those materials arrive on VA property. At no time shall the contractor have, or permit subcontractors to have, materials on station without MSDS sheets. All instructions for use shall be followed. Products will not be used until MSDS's are submitted to the COR.

The contractor shall maintain a current, green in color, loose-leaf notebook on the job site at all times, which is readily available for viewing by the COR or VA Safety Officer.

7. Delivery Coordination

Normal business hours for acceptance of deliveries are 8:00am-3:30pm, Monday thru Friday excluding Federal Holidays. Deliveries must be coordinated in advance with COR once a ship date is established. The COR or Biomed Representative shall be the only VA entity signing for freight received on this requirement. All items included in the requirement shall be shipped and delivered to site at same time. If deliveries must be broken into several shipments due to size, this must be coordinated in advance with the COR. Failure the coordinate shipment with COR, may result in failure to deliver on site and cause re-scheduling of delivery/freight. In event rescheduling occurs due to vendor's failure to coordinate appropriately, all additional expenses associated will be assumed by the awarded vendor.

8. Additional Charges

There will be no additional charge for time spent at the site during, or after the normal hours of coverage awaiting the arrival of additional FSE and/or delivery of parts or installation.

9. Packaging Waste management

Contractor shall remove packaging materials and all shipping debris from site and dispose of at appropriate recycling facilities. Contractor shall collect and separate for disposal all paper, plastic, polystyrene, corrugated cardboard, packaging material in appropriate bins for recycling on site if available. Contract shall fold metal and plastic banding, flatten and place in designated areas for trash as provided at CBOC.

10. Estimates

C.2 VAAR 852.219-10 VA NOTICE OF TOTAL SERVICE-DISABLED VETERAN-OWNED SMALL BUSINESS SET-ASIDE (JUL 2016)(DEVIATION)

(a) *Definition.* For the Department of Veterans Affairs, "Service-disabled veteran-owned small business concern or SDVSOB":

(1) Means a small business concern:

(i) Not less than 51 percent of which is owned by one or more service-disabled veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more service-disabled veterans or eligible surviving spouses (see VAAR 802.201 Surviving Spouse definition);

(ii) The management and daily business operations of which are controlled by one or more service-disabled veterans (or eligible surviving spouses) or, in the case of a service-disabled veteran with permanent and severe disability, the spouse or permanent caregiver of such veteran;

(1) Offers are solicited only from verified service-disabled veteran-owned small business concerns. Offers received from concerns that are not verified service-disabled veteran-owned small business concerns shall not be considered.

(2) Any award resulting from this solicitation shall be made to a verified service-disabled veteran-owned small business concern.

- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;
