The Respiratory Department at the Thomas E Creek Medical Center would like to Purchase 10 sleep study devices WATCH-PAT 200. Respiratory is required to use the ITAMAR WATCH-PAT 200 equipment due to the software system that our facility owns to read the sleep study tests. ITAMAR will provide a 1 year warranty to include in-service training on the equipment.

The equipment is needed due to the large amount of sleep studies requested from outlying areas and the time it takes for the patient to mail back the sleep study equipment (4-5 days) we can't meet the current 30 day VA guideline scheduling policy for new patients seen in the clinic.

With approximately 75% of the studies performed in the clinic being from outlying areas there is no way to currently meet the VA policy.
