Personnel using the equipment are currently familiar with the use, care, disinfecting procedures of this brand of equipment. The training and written SOPs for use, care, cleaning, are currently specific to A-DEC brand equipment. The operating inventories of consumable supplies to support A-DEC brand equipment are currently on hand to support existing A-DEC brand equipment. The training of repair personnel and available bench stock inventories of spare parts are also available to support existing ADEC brand equipment.

Purchasing another brand of equipment would require a duplicative and uneconomical investment in not only additional operating and bench stock inventories of consumables and spare parts unique to another brand, but also an investment of provider and technician time in training for use, care, cleaning, disinfecting, and repair of another brand of equipment.
