The Contractor shall provide all labor, certified technicians, travel, supervision, materials, parts, equipment, tools, control and disposal of hazardous/nonhazardous licensed material, training, proof of licensing, documentation of required services, maintenance of equipment, calibration instruments, survey instruments, methods of controlling radiation, source handling equipment, documentation of case history, remote handling tools, and permits when required to perform all services for diagnostic radiation safety survey and imaging service to maintain compliance with all state and Federal regulations. Additional testing or adjustments may be requested following repairs, to bring equipment into full compliance with the effective radiation rules and regulations. Pricing for additional testing or adjustments is established within B.2 Price/Cost Schedule.

B.4 HOURS OF SERVICE AND REQUIREMENTS

HOURS OF SERVICE

The Contractor shall perform the services as specified herein Monday through Friday, with the exception of Government Holidays (see below), between the hours of 6:00a.m. and 4:00p.m. The COR may request Supplementary Services and shall establish hours for services on these days when services required.

CONTRACTING OFFICERS REPRESENTATIVE (COR)

The Radiation Safety Officer from the VA Loma Linda Healthcare System shall be the COR for this contract. No service shall be provided or scheduled without the written approval of the COR or his/her designee for this contract.

The Contractor shall not accept any instructions issued by any other person(s) other than the Contracting Officer or his/her delegated representative(s) acting within the limits of his/her authority. The Contractor shall schedule and coordinate all services with the COR prior to providing services.

SAFETY AND FIRE PREVENTION

In the performance of this contract, the Contractor shall take such safety precautions as necessary to protect the lives and health of the occupants of the building. Fire and safety deficiencies, which exist and are part of the responsibility of the Contractor, shall be immediately corrected. If the Contractor fails or refuses to correct deficiencies promptly, the COR may issue an order stopping all, or any part, of the work.

The Contractor shall comply with applicable Federal, State, and local safety and fire regulations and codes, which are in effect during the performance period of the contract.

The Contractor personnel shall follow applicable facility policies concerning fire/disaster programs.

PERSONNEL POLICY

The parties agree that the contract personnel working under this contract **shall not** be considered VA employees for any purpose and shall be considered employees of the Contractor.

POLICY

All Contractor personnel assigned to the performance of this contract shall wear a Contractor-provided uniform that clearly identifies the individual as a Contractor. Contractor personnel shall not wear sandals, flip-flop style footwear, or open toed shoes. The Contractor shall ensure that the staff assigned will be cognizant of sexual harassment, drug-free workplace and other appropriate federal employment requirements.

CONTRACTOR SUBMITTALS /INSURANCE REQUIREMENTS

The Contractor shall procure and maintain liability insurance of at least \$100,000.00 while the contract is in effect. The Contractor is also required to comply with federal and state Workers Compensation and liability insurance.

1. Within 15 days of contract award the Contractor shall furnish to the Contracting Officer certification from the insurance company indicating that the coverage has been obtained and that it may not be changed or cancelled without guaranteed thirty (30) day notice to the Contracting Officer. New certifications shall be furnished prior to the expiration date.
2. Within 15 days of award the Contractor shall provide proof of Federal, State and or Local Licensing or Permits as required in order to perform services.

EXERCISE OF OPTION YEARS

The Government is not obligated to exercise option periods as referenced in this contract. Determination to exercise the option year shall be evaluated prior to the expiration of the period in effect. If it is determined to be in the best interest of the Government, the option period may be exercised, refer to FAR 52.217-9- "Option to Extend the Term of the Contract".

SMOKING POLICY

Smoking is not permitted within or around the VA Healthcare System facilities, except in designated areas.

PARKING POLICY

It is the responsibility of Contractor personnel to park only in designated parking areas. Parking information is available from the VA Police. The VA will not invalidate or make reimbursement for parking violations of the Contractor's personnel under any circumstances.

ADDITIONAL REQUIREMENTS

 - I. A tentative schedule and description of the Contractor's plan of providing Diagnostic Radiation Safety Survey and Imaging Service per the SOW. **The Contractors schedule for providing services shall be approved by the COR prior to initiating services.**
 - II. A description of the Contractor's plan to provide Supplementary Services within 24 hours of a written request for services for approval by the COR.
- d. The Contracting Officer reserves the right at no additional cost to the Government to schedule an on-site quarterly visit with the Contractor and the COR to discuss performance, changes and regulatory procedures. The Contractor shall have at least one person attending the meeting that can make decisions on their behalf.

3. CONTRACTOR POINT OF CONTACT:

The Contractor shall provide a contract Program Manager who shall be responsible for scheduling services and the performance of the work. The name of this person shall be designated in writing to the Contracting Officer and COR. The Contractor's Program Manager shall have full authority to act for the Contractor on all contract matters relating to daily operation of this contract.

(d)(1) In accordance with section 743 of Division E, Title VII, of the Consolidated and Further Continuing Resolution Appropriations Act, 2015 (Pub. L. 113-235), use of funds appropriated (or otherwise made available) under that or any other Act may be prohibited, if the Government determines that the Contractor is not in compliance with the provisions of this clause.

(2) The Government may seek any available remedies in the event the contractor fails to comply with the provisions of this clause.

The Government may require continued performance of any services within the limits and at the rates specified in the contract. These rates may be adjusted only as a result of revisions to prevailing labor rates provided by the Secretary of Labor. The Contracting Officer may exercise the option by written notice to the Contractor within 30 days.

(c) The total duration of this contract, including the exercise of any options under this clause, shall not exceed five (5) years.

purchase card are considered to be an electronic transaction for purposes of this rule, and therefore no additional electronic invoice submission is required.

E.2 52.212-2 EVALUATION COMMERCIAL ITEMS (OCT 2014)

The Government will award a contract resulting from this solicitation to the responsible offeror whose offer conforming to the solicitation offers the lowest price and that price is found to be reasonable. After making selection of the lowest, reasonably priced offer, the Contracting Officer will determine if the selected Offeror' is responsible. - (3) PSG 88, Live Animals;

- (4) PSG 89, Subsistence;
- (5) PSC 9410, Crude Grades of Plant Materials;
- (6) PSC 9430, Miscellaneous Crude Animal Products, Inedible;
- (7) PSC 9440, Miscellaneous Crude Agricultural and Forestry Products;
- (8) PSC 9610, Ores;
- (9) PSC 9620, Minerals, Natural and Synthetic; and
- (10) PSC 9630, Additive Metal Materials.

Place of manufacture means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

Predecessor means an entity that is replaced by a successor and includes any predecessors of the predecessor.

Restricted business operations means business operations in Sudan that include power production activities, mineral extraction activities, oil-related activities, or the production of military equipment, as those terms are defined in the Sudan Accountability and Divestment Act of 2007 (Pub. L. 110-174). Restricted business operations do not include business operations that the person (as that term is defined in Section 2 of the Sudan Accountability and Divestment Act of 2007) conducting the business can demonstrate—

- (1) Are conducted under contract directly and exclusively with the regional government of southern Sudan;

(2) Through another subsidiary of a parent corporation.

Successor means an entity that has replaced a predecessor by acquiring the assets and carrying out the affairs of the predecessor under a new name (often through acquisition or merger). The term “successor” does not include new offices/divisions of the same company or a company that only changes its name. The extent of the responsibility of the successor for the liabilities of the predecessor may vary, depending on State law and specific circumstances.

Veteran-owned small business concern means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at 38 U.S.C. 101(2)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(c) *Representation.* By submission of its offer, the Offeror represents that it does not require employees or subcontractors of such entity seeking to report fraud, waste, or abuse to sign internal confidentiality agreements or statements prohibiting or otherwise restricting such employees or subcontractors from lawfully reporting such waste, fraud, or abuse to a designated investigative or law enforcement representative of a Federal department or agency authorized to receive such information.

- (5) Specifically request a ruling of the individual upon whom the protest is served;
- (6) State the form of relief requested; and
- (7) Provide all information establishing the timeliness of the protest.

(b) Failure to comply with the above may result in dismissal of the protest without further consideration.

(c) Bidders/offerors and contracting officers are encouraged to use alternative dispute resolution (ADR) procedures to resolve protests at any stage in the protest process. If ADR is used, the Department of

Veterans Affairs will not furnish any documentation in an ADR proceeding beyond what is allowed by the Federal Acquisition Regulation.
