Questions Submitted in response to Solicitation 36C24618Q9511 and Government Responses:

Question I am hoping to find out if there is an incumbent contractor currently performing these services or if this is a new requirement. If there is an incumbent, could you please provide the contract number?

Gov't Response This is a new requirement for a Vertical Filing System with installation in which there is no incumbent. Installation of goods is the only service tethered to this project and is incidental to the Governments actual defined needs.

Question Can you tell me the dimensions of their folders, the height and length and whether there is a top tab or side tab.

Gov't Response Folder dimensions are; Front side 9 1/2" by 11 3/4", Back side 9 1/2" by 12 1/2". Pressboard with side tab.

Question Is this for the Radiation Oncology Dept?

Gov't Response Yes, this is for the Radiation Oncology department.

Question From the 129" unit width x 15 carriers = 1,935 however this is overstated and should be based on the shelf width which would be approximately 112" wide. We are thinking than that, the LFI requirement should be 1,680 LFI, not 1935.

Gov't Response The current machine that will be removed is 115 inches wide with 17 shelves. The 129 inches is the space available where the machine is at. It has to fit within the confines of the curbing available (can be less than 129). Of the 17 shelves we currently have, 2 are not in use for records.

Question In addition, what is the ceiling height in the room and is it a drop ceiling?

Gov't Response The 102 inches described in section b. of the salient characteristics is the ceiling height with consideration given to the drop ceiling in place with an additional 5 inches of available space above the drop ceiling. All dimensions provided in the salient characteristics in regards to curbing are maximum dimensions.

Gov't Response
