Equivalent products will be considered, with the following required salient features:

- Shall have a microprocessor control with Display
- Shall be ETL- Certified to UL 2208
- Shall be all metal design, no glass parts
- Shall be electrical configuration: 120V, 15 amps
- Process occurs in enclosed, sealed, stainless steel cabinet
- Shall include an automatic waste drain
- Shall have gravity fill system with auto-fill and auto-flush
- Shall have built-in spill containment
- Shall have variable volume selection
- Shall be maximum size general dimensions: 30" w x 67" h x 31" d
- Shall have alcohol cycle: 2 hrs. per gallon or less
- No special ventilation needed
- Shall have quick transitions between cycles; no cool-down between runs
